Annual Departmental Report (2017-2018)

During the 2017/18 academic year, members of the department continued to maintain an intensive commitment to lecturing and examining a wide range of compulsory and elective study units in the courses offered by the Law Faculty and by other Faculties of the University of Malta. At the same time the Department as a whole co-organised a conference on *Religious Marriages in the Mediterranean* with Prof. Susan Hirsch (George Mason University) and the Muslim Marriages Research Group of the University of Amsterdam, represented by Dr Ibtisam Sadegh. This conference was held on the 20th-21st March and hosted by the Department and the Mediterranean Institute of the University of Malta. It managed to attract around 20 mostly foreign scholars who presented a range of interesting papers and a follow-up publication of some of the papers presented is currently being finalised. Through Dr Kurt Xerri, the department also co-organised (with the University of Bremen and the University of Amsterdam) and hosted the "TENLaw Follow Up Conference 2018" focusing on tenancy law. This attracted 30 foreign scholars and was held on the Valletta Campus from the 11-12 October 2018.

The Department also organised three Public Seminars throughout 2018. On the 14th February, the Department co-organised a Public Seminar in conjunction with the Parliamentary Secretariat for Social Accommodation, held in the Phoenicia hotel, entitled "Looking Ahead: The Future of Housing", and addressed by Igor Costarelli (Universita Milano Bicocca). On the 20th March the Department organised and hosted a public lecture, opened by the President of Malta, in which Prof. Annalies Moors of the University of Amsterdam talked about: Problems with Regularising Religious Marriages. On the 2nd July the Department launched the publication: "Renting Residential Property in Twenty-First Century Malta: Does the law provide a level playing field?". This monograph was written by Dr Kurt Xerri LL.D. Ph.D. who was employed in October 2017 as full-time lecturer in the Department. It was launched during a seminar co-organised between the Department of Civil Law and the Parliamentary Secretary for Social Accommodation. During the seminar a keynote speech was delivered by Prof. Sergio Nasarre Aznar, who holds the Chair in Housing at the University of Tarragona in Spain on: "European Lessons in Tenancy Law Reform".

Throughout the 2017/18 academic year, Dr David Zammit and Dr Kurt Xerri dedicated a lot of time to the running of the Law Clinic, which had been formally launched in May 2017. Dr Mary Muscat invested substantially in the organisation of client interview role plays and moot courts for all the students following the Masters in Advocacy. The Department also benefited greatly from the support of two excellent scholars who acted as Visiting Examiners: Prof. Sergio Nasarre Aznar and Prof. Aurelia Colombi Ciacchi from the University of Groningen. Finally special thanks go to Mr Brandon-Lee Caruana who gave a solid, intensive and professional contribution as Department Secretary.

- > Regularly publishes legal works in Malta and abroad on legal research carried out.
- > Seeks internship programmes as practical legal training for students specializing in the legal fields above mentioned at both public and private entities that have an interest in the topics. A list of potential candidates is referred to below. The Department strives to academically address and in so doing promote legal research that may be commissioned by the same.

The Environment and Resources law Department was set up just before the beginning of the academic year 2010/2011. The decision to set up this new Department within the Faculty of Laws has been prompted by the vast developments on a national, European and International level in the legal framework addressing the topics mentioned above. The regulation of these sectors is horizontal in nature and impinges upon all of the major legal streams and human activities. The entire mass of norms that fall under Environment and Development Planning law has introduced specialized legal regimes that complement and at times supersede the *lex generalis* under which, they originated. This enables the Faculty of Laws to keep abreast with the demand for legal

learning and research in these legal fields, as they evolve from statutory sources as well as case law. This would consequently benefit and contribute to the development of the other existing Departments. There is a strong and steady demand for academic learning in the legal fields mentioned in 1.1.not only within the Faculty of Laws, where the subject has been offered since 1994, but also from other faculties and institutes at University as the subject is essentially horizontal. A list of the said University of Malta institutions that request such services is included below.

The proliferation of national legislation on environment and planning law reflects the changes the country is undergoing as a Member of the European Union. The environmental

acquis communautaire is the second largest chapter constituting 22% of the whole acquis not including related legal instruments addressing for example energy issues. Apart from the bulk of laws involved, most of these laws are subject to specialized legal regimes that have no link with other legal fields.

The Strategic Educational Pathway Scholarships (STEPS) Programme, has identified environmental studies as one of its priority areas. Indeed environmental studies particularly in the field of renewable energy resources, the earth sciences and planning development are on the increase in Malta as everywhere else in the world. The Department is gearing itself up to support this influx of interested applicants by offering study units that train students in understanding the legal framework that supports innovation and developments in this field of academic study.

Annual Departmental Report (2017-2018)

The Department has continued to consolidate and move forward. In 2018 it worked to consolidate the introduction of a new additional LLM programme in European Business Law, which commenced in September 2015. In October we had the reached the highest number of applicants for the LL.M stream, over 12 students. We have also launched the new MA in European Legal Studies intended for post graduate students who do not have an undergraduate degree in law. This attracted over 15 applicants. Members were active in research and participation in conferences and network meetings in Malta and abroad. The Department continues to run two LLM programmes, and a significant range of electives at LLB and LLD level in addition to the compulsory courses in European Union Law. It also services other Faculty of Laws programmes as well as other Faculties and Institutes. There were no changes in staff during the past year.

Annual Departmental Report (2017-2018)

The highlight of this year for the Public Law department was probably the first ever symposium held, for Constitutional Law students, in February 2018. Basically, all of the LLB1s were placed in one of twelve groups, and were given a topic to study. Each group consisted of around twenty students, and over the months October to February these had to research their chosen topic with a view to making a twenty minute presentation on the same, at the symposium. The symposium was held at the Assembly Hall, and as stated, twelve presentations of twenty minutes each were made. The symposium was attended not only by the LLB1s but also by their lecturers and by Dr John Stanton from London City University, who was on an Erasmus visit. The presentations were of a particularly high standard, indicating that the students truly put in the required effort and rose to the challenge. There was obviously even time for questioning and comments, and plenty of coffee breaks between the twelve presentations. The symposium was considered a success and arrangements were made for the system to be not only repeated, but extended to Administrative Law in the next academic year. The symposia in future will be held later in the year and will count for a maximum of 10% of the final exam mark.

Dr John Stanton, as part of his Erasmus visit, also delivered a lecture in which he compared the English and the Maltese constitutional law systems. We were also graced by another visitor: Prof Guillaume Tusseau from the Ecole de Droit Paris, who lectured on "The Mutations of French Constitutional Culture".

Another first, was a joined presentation by Dr Ivan Sammut and Dr Ivan Mifsud, to Pro Rectors Baldacchino and Zammit, on *Faculty of Laws Vision 2030*. This was well received and follow up discussions were, and are still being, held.

On the other hand, the low point was probably the loss of the services of Dr Roberta Avellino Pule', who wished to contribute further to the Faculty of Laws, but felt compelled to choose between her academic interests on the one hand, and her professional work. Efforts were made to find the resources to employ her, even as a research assistant, but these failed because the funds were simply not available. This led to her resining completely, from the Faculty of Laws.

The Department participated in the workings of the Human Rights Programme of the University. The Programme continued to be chaired by Dr Austin Bencini, with Dr Ivan Mifsud joining the Programme as a member. The Department of Public Law even sponsored the December 2017 conference and contributed towards the costs of a round table held in July 2018 on migration.

The Department also undertook to sponsor an GhSL publication of summaries of important judgements related to Private International Law; the very creation of this publication was a suggestion of Dr Alex Sciberras Trigona, which suggestion the GhSL accepted and organised volunteers to work on.

Members of the Public Laws Department published some articles and made other scholarly contributions:

- Dr Sylvann Aquilina Zahra contributed to the *International Comparative Legal Guide* (ICLG) Malta chapter, 2018 and 2019 editions;
- Dr Tonio Borg contributed an article on *Juridical Interest in Constitutional cases*, published in *Id-Dritt(GHSL)*
- Dr Ivan Mifsud contributed a chapter to a book to be published by the University of Nantes, "Elected Officials and Money: an Analysis of the Material Conditions of Statutory Electoral Mandates"
- Dr Jacqueline Tanti Dougall contributed "The Package Travel Insolvency Fund Regulations- The Maltese Perspective in the book entitled "The New Package Travel Directive" published by Estoril Higher Institute for Tourism and Hotel Studies (ESHTE), Portugal and the INATEL Foundation on the initiative of Prof. Carlos Torres

Annual Departmental Report (2017-2018)

Introduction

The Department of Commercial Law has faced another busy and challenging year, during which if offered lecturing programmes at both under-graduate and Masters levels and organized a number of public activities on commercial law subjects.

The Commercial Law Department seeks to preserve the good reputation built over so many by illustrious predecessors in office and to maintain high standards of teaching and academic performance. The Departmental academic staff includes the leading professionals and recognized experts in their respective fields, be it shipping, competition law or company law. Students receive the best possible academic preparation backed by practical experience at the highest level. The Department relies on the able University administrative staff led by the Faculty Office for its day to day management.

Today commercial law examines more than ever before how business activities can be carried out and by whom, and how these activities and operators are regulated. Regulation of commercial activities is expanding and is playing an ever more important role in conditioning how business is carried out and by whom and under what conditions and restrictions. Study units examines how specific business activities are carried out and regulated in Malta: from basic notions of commercial law such as traders and acts of trade, to company law, financial services, aircraft and shipping law and financing, as well as consumer protection and fair competition. Some subjects are fairly traditional and well-established while others are new and only recently introduced. Study units are periodically revised and refreshed to reflect changes in law and international developments. The Department updates its programmes as commercial law evolves and changes and as new laws are passed by Parliament.

Objectives, relevance and the future

During 2018, the Department continued to play a relevant role which tried to be relevant and useful to students, to society and to the University generally. It has collaborated as necessary with other Departments and Faculties through lecturing and participation at seminars. The Department strives to provide teaching at very high standards and to analyse and promote initiatives aimed for the country's development and to inform the general public on commercial law issues as they develop.

The Department's philosophy is that it is not sufficient for academics to support businesses and business development but it is more important to look at the broader picture of what is best for the public and the general community's well-being. With this aim in mind, all Commercial Law courses offered by the Department are open to the public. Regrettably few members of the public actually avail themselves of this massive opportunity.

Over the past few years, Department has managed to re- assert its presence and has played a relevant role both within and outside the University walls. This contrasts with past years where the Department was absent from public life and kept too low a profile. During these past years, high-level talks, seminars and conferences involving participation by Department members and other experts in the field, have regularly been organized with significant success and publicity. Members of the Department are regularly invited to address seminars and conferences organized by various professional entities and associations on various commercial law subjects and developments. Joint collaborative efforts with FEMA, the Chamber of Advocates, the Malta Institute of Accountants and the Malta Stock Exchange continue with success.

The Department's academic programmes are no longer centred on the Commercial Code as used to be the case in the past. Commercial law today is much more extensive with much more state intervention than ever before. It is much more than acts of trade, keeping of books of accounts, unfair competition and marine insurance. Today, as already remarked earlier, commercial law includes sophisticated new rules, largely derived from the European Union, on competition and consumer protection, on financial services regulation, shipping and aviation. The teaching carried out by the Department has had to adjust and evolve accordingly.

Public conferences and seminars

Various successful conferences were held during the current year in conjunction with the Chamber of Advocates.

The first conference was held on the 15th March 2018 to commemorate the Annual World Consumers Day celebrated on that very day. The attendees were happily more than in the previous year and numbered around fifty. Thanks to the European Commission representation in Malta a member of the EC Directorate participated at the seminar and made a useful and expert contribution.

The second conference was the Annual Company Law Conference held on the 2nd November 2018, which once again proved highly successful with about 160 participants and the event was reported in the press.

Another event was a successful seminar on Corporate Insolvency and EU State Aid was organized jointly with the Malta European Law Association with the presence of Prof M A Schillig from King's College in London was held at the Chamber of Advocates on the 21st February 2018.

On the 23rd May 2018, the Department joined with the Chamber in a well-attended conference on MIFID II: benefits, challenges or opportunities?

In all these events, Departmental lecturers participated fully.

During 2018, Dr. Ann Fenech spoke on shipping law at numerous international fora including the Marine Money Forum in Monaco on how Maltese law protects mortgagees, at the University of Split on the international recognition of judicial sales, as a representative of the CMI on the need for an international convention on the recognition of judicial sales before the United Nations Committee on International Trade Law in New York and on arrest of ships at the Spanish maritime law association meeting in Madrid. In November of this year, Dr Fenech was elected Vice President of the CMI by the General Assembly held at the IMO in London. This is a three year term and is the first time any Maltese person has occupied this post. The CMI is responsible for the drafting of the vast majority of international maritime conventions. She has been given the specific responsibility of coordinating all CMI efforts at UNCITRAL for a new convention on the international recognition of judicial sales

Teaching staff resources and commitments

The undersigned is a full-time member of staff for the past three years after having served on a part-time basis since 1994.

Dr Tiziana Filletti is the second full time member of staff, since October 2017.

The Department relies heavily on part-timers who are fortunately true experts and leading professionals in the subjects which they teach and we are grateful to them. Most lecturers are committed and provide an excellent service to students a d the University. However, it is to be re-stated that number of lecturers who enjoy a Council appointment should contribute more to the Department's responsibilities and amplify their presence and participation in University life and activities.

No new permanent staff was recruited under a Council appointment during this last year and none are planned for the coming year.

The Departmental secretary is Ms Claire Gouder.

The Students

The same concerns expressed in last year's report have to be re-affirmed today. The increase in the number of law has exercised a negative impact on the quality of the relationship between lecturers and students and also on student participation during lectures. Students remain largely passive and lack confidence to participate more actively in the lecture-room and few carry out independent reading or study. They seem unduly obsessed with class notes and past papers. Students generally do little independent reading or research and few show interest in analysing current legal and political issues. Student participation in the lecture-room remains generally unsatisfactory. The large number of students scares away valid lecturers seeing the obligation to correct hundreds of scripts for which payment is minimal.

Money Matters

The Department once again manages to undertake initiatives practically without being a financial burden on University finances. Nonetheless the annual budget allocated to the Department is delusory and barely covers the cost of scripts, toners, paper and sundry stationery for use by the Department.

Teaching activities

In the year under review, the Department carried out its lecturing duties which were fulfilled in line with the respective University course descriptions and study unit commitments. Very few lectures were cancelled or postponed and action was immediate action was taken to reduce any inconvenience to students. Problems are often encountered in securing examiners willing to undertake the role of examiners to correct exam scripts. This point has already been made in earlier Reports. Especially with large classes, the correction task is viewed as tedious, thankless and unrewarding.

Where appropriate, study units were updated and refreshed.

Happily the consumer protection study unit, which for two years running was not offered due to lack of appreciable applications, will this year be held as sufficient applications have been received.

The Masters Programme in Financial Services

The Department offers only one Masters programme but it is a valuable asset which deserves to be protected and promoted. For more than ten years, the undersigned has continued to coordinate the Masters programme in Financial Services. This is offered annually both on a full-time and on a part time basis. With the able assistance of fellow coordinator, Mr Peter J Baldacchino, relentless efforts are made to ensure it maintains a high standard. Mr Baldacchino heads the Department of Accountancy and continues to be a very supportive FEMA programme co-coordinator on the Board of Studies.

The evening Masters programme in financial services was originally launched in 1996 and has continued to be offered annually without fail. Last year, this report regretted recorded that the number of applications had fallen considerably. Possibly this apparent decline was due to the relatively high fees charged and to new competition by Masters programmes offered both the University itself (especially the Masters in Banking and Finance and in Accountancy) as well as by other foreign institutions for which the Maltese government grants assistance and scholarships. Fewer accountants and law students than before seem to be applying for the course. In order to meet this challenge and in pursuance of the University's stated direction that the law courses should be more internationalized, the course was opened to up to accept students from a wider range of related and relevant

disciplines like criminology, business studies and diplomatic studies. With this objective, amendments to the course bye laws were drawn and approved at Faculty Board level last year. These reforms have thankfully ensured that this Masters programme is sustainable and fresh. Lecturers were directed to follow a more comparative and internationalized approach than before in order that the course may be attractive and accessible to foreign students. This year the programme started with 22 students including five foreign students — a remarkable figure seeing that not one advert was issued for this course by University, as opposed to other highly advertised Masters programmes.

All important decisions affecting or arising out of the course are taken by the Board of Studies. This Board meets regularly and minutes are duly kept. Despite repeated reminders, students have not nominated their representatives to sit on the Board of Studies.

As from next year, study-units dealing with the three pillars of financial services, namely banking, insurance and securities, shall for the first time since the inception of the course become all non-elective units.

New non-visiting lecturers were successfully engaged during the year to manage the banking regulation unit.

Disciplinary and plagiarism cases

No big disciplinary issues or plagiarism have been identified during the year.

Commitments

Since 2004, the undersigned cease to serve on the Senate-appointed University Research Ethics Committee.

He coordinates and lecturers in the study unit on Regulatory Issues arising from the Regulation of Business offered every three years by the Faculty of Theology in its Masters in Business Ethics Programme.

He also coordinates and lectures, with other colleagues, in a study unit (ACC 5962) which provides accountancy students with an extensive introduction to financial services law and regulation and to dissolution and winding up of companies. The study unit is run by FEMA as part of its MA Accountancy programme.

During 2014, the Head of Department and Dr A Galea Salomone attended practically all meetings of the Faculty Board and served as necessary in meetings and on Faculty sub-

committees. The undersigned, also attended most Heads of Department and Dissertations Committee meetings.

In conjunction with the Faculty of Engineering, the Department delivers a study unit on Maritime Law for Engineers at MSc level. The initial work was directed by Dr Ann Fenech and Dr Clarie Demarco. The study unit (CML 5043) is offered once every two years.

A new study-unit named "Advanced Company Law" has been drawn up for undergraduate law students. This new non-elective unit restored and re-asserted the importance of company law studies after a few years where it suffered from an unfortunate reduction of the lecturing hours as a result of the restructuring of the law courses. It will be offered during the third year of legal studies staring from this academic year.

External examiners

During 2013 the External Examiners were appointed for a selection of LL.D and Masters in Financial Services theses in accordance with the relevant University rules. The external non-visiting examiners were ably assisted by Faculty staff in the examination of the theses allocated following their choice of preferred topics.

Prof Luca di Donna was appointed for the under-graduate law course while Prof Ian Fraser has accepted to serve as external examiner for the Masters course.

Judicial Studies Committee

Every year the Department organizes a full day seminar on commercial law subjects to the members of the judiciary as part of their continued professional training. In April 2017, the undersigned delivered a lecture on whistleblowing law and practice. For next year two separate sessions on consumer protection and market abuse have already been scheduled.

Some final remarks

Examiners assisting the department are a very useful indeed vital part of the
administrative machinery which enables the University to function. Examining is a
laborious and unrewarding task under any circumstances but becomes an even
greater burden when the number of students is large and the quality of the work is

low. Examiners have complained about the lack of appreciation for their efforts and

some have withdrawn indefinitely from accepting further engagements, a great loss

for the Department and our students.

• The quality level of students is not improving; most students seem not to even read

newspapers and admit it freely. The general ignorance of history, even recent

history, is deeply disturbing. With a few exceptions, students seem largely

uninterested in knowing let alone understanding and analysing the past, what is

currently going on around them and the global issues.

• Some lecturers should strive harder to provide a better qualitative service to

University, the Department and its students, and go beyond mere lecturing and

corrections. A small number of examiners take too long to forward exam questions

or to correct the scripts, or both. There is no doubt that with more participation and

enthusiasm by its members, the Department's general performance and activities

can be significantly improved and updated. New non-resident visiting lectures as

well as guest speakers were engaged during the year in order to enhance the service

provided to students.

• In truth everybody involved could do better and all should make a better effort to

find more time and space for Departmental and University matters and scholarship.
