Master of Science in Pharmaceutical and Regulatory Sciences

The Master of Science in Pharmaceutical and Regulatory Sciences offered by the Department of Pharmacy is targeted at pharmaceutical technologists, pharmacists, scientists and individuals with a relevant scientific background.

The Level 7 programme is based over 6 semesters and focuses on the development of skills relevant to pharmaceutical sciences and regulatory sciences. The course provides study units that meet the requirements for Qualified Person positions in the pharmaceutical industry. The Master degree offers the opportunity to specialise in one of the offered areas related to pharmaceutical and regulatory sciences.

Career Prospects and access to further studies

This Level 7 programme is ideal for individuals who wish to pursue a career development pathway towards leadership and managerial positions in pharmaceutical processes in industrial, quality and regulatory settings. It is also applicable for individuals who would like to further their education and read for a Doctor of Philosophy.

Academic Programme

Components covered within the programme include:

- ① Pharmaceutical Regulatory Sciences
- ① Pharmacovigilance
- ① Qualified Person Requirements in: Pharmacognosy, Pharmaceutical Technology, Pharmaceutical Chemistry and Applied Physiology and Biochemistry
- ① Industrial Pharmacy
- ① Pharmacoeconomics
- ① Pharmacy Administration

The course consists of core study units and elective study units so as to allow students to focus on areas that are relevant to their interest. The course includes a placement to be undertaken in an area relevant to the focus of study and a dissertation.
