#### Minister for Foreign and European Affairs of Malta at MEDAC

On 14 May 2021 MEDAC was honoured to welcome the **Hon. Evarist Bartolo, Minister for Foreign and European Affairs of Malta** who delivered a keynote address on contemporary security challenges in the Mediterranean to the Academy's Master students.

The Hon. Minister provided a systematic overview of the main security challenges in the Mediterranean. The keynote lecture focused on a plethora of issues including irregular migration, the state of play in Libya, and regional relations in the Eastern Mediterranean.

Hon. Minister Bartolo also articulated the importance of addressing security challenges in the Mediterranean in a regional manner. MEDAC's postgraduate students participated in a lively discussion with the Hon. Minister Bartolo on numerous themes elaborating on Malta's vocation to actively promote a more peaceful and stable Mediterranean region.

#### **MEDAC Guest Lecturers**

On 3, 5 and 7 of May 2021 MEDAC was honoured to host **Ambassador Martin Dahinden** as a visiting distinguished diplomat to its post graduate Diplomacy programme. Ambassador Dahinden delivered a series of lectures on the themes of development and poverty, demography and the use of language. The titles to the lectures were the following: 'Development Agenda: from Poverty Eradication to Sustainable Development'; 'Political Demography: Focusing on Long Term Patterns'; and 'Using Language Effectively: A Practical workshop'.

Amb. Dahinden has served in numerous prestigious positions throughout his career including as Head of the Directorate of Corporate Management of the Federal Department of Foreign Affairs, (FDFA), Director of the Swiss Agency for Development and Cooperation (SDC) and more recently as Switzerland's Ambassador to the United States in Washington D.C.

Throughout this series of lectures MEDAC students engaged in a dynamic discussion on the diverse issues being addressed.

The support of the Embassy of France in Malta made possible another learning opportunity for MEDAC students, this time by distinguished **Professor François Héran**. On 29 and 30 April, MEDAC hosted Professor François Héran who delivered a series of lectures on the theme of International Migration and the 'Refugee Crisis'.

#### MEDAC and the German Embassy in Malta co-organise high-level event on multilateralism

#### Opportunity to participate extended to MEDAC alumni

MEDAC and the German Embassy in Malta co-organized a webinar on 'A Multilateralism for the People: The German Approach' on 16 September 2021 which was held at the Valletta University Campus.

The German Federal Government adopted a White Paper on the subject earlier in 2021. The webinar aimed at introducing the White Paper as well as at bringing together officials and experts from the largest (in terms of population) and smallest EU state to exchange views on the state and future of multilateralism.

The webinar was opened by German Ambassador to Malta, H.E. Walter Haßmann and the Chairman of the Mediterranean Academy, Prof. Godfrey Pirotta. It was addressed by Honorable Minister for Foreign and European Affairs of Malta, Evarist Bartolo and State Secretary of the German Federal Foreign Office, Miguel Berger. Joining them was Director for the United Nations and Counterterrorism at the German Foreign Office, Katharina Ahrendts. Speakers included German and Maltese experts, including Prof. Amrita Narlikar, President of the German Institute for Global and Area Studies (GIGA) and Professor at the University Hamburg and H.E. Prof. Simone Borg, Malta's Ambassador for Climate Change and Professor of International Law at the University of Malta.

The participants included diplomats accredited to Malta as well as about seventy MEDAC alumni and students, who engaged in discussions with the speakers. The event was moderated by the Holder of the German Chair for Peace Studies and Conflict Prevention at MEDAC, Dr. Monika Wohlfeld.



The 'Crimes Against Humanity: Towards a More Comprehensive Approach?' seminar was opened by the Rector of the University of Malta, Prof. Alfred J. Vella and included distinguished speakers from both Europe and the United States, including the Director of the Centre, Dr. Omar Grech, who lectures on the MEDAC programme. MEDAC postgraduate students had a unique opportunity to gain profound insight into the complex dynamics of the concept of crimes against humanity exploring it within the different contexts of food, starvation and conflict; human trafficking; migratory flows, and terrorism amongst others.

# MEDAC Director participates in international debate on intercultural trends in the Mediterranean

On 23 September 2021, Prof. Stephen Calleya, MEDAC Director addressed a debate organised by the Mediterranean Universities Union (UNIMED) and the Anna Lindh Foundation (ALF) entitled 'Meeting around the Intercultural Trends Report: Strengthening our Euro-Mediterranean multicultural background.' The Intercultural Trends Report is a publication of the ALF which is in its fourth edition and is based on a unique public polling methodology co-designed with Gallup and Ipsos-MORI. It aims to measure intercultural trends in the Mediterranean basin. During the debate Prof. Calleya underlined the need for civil society to take a leading role in promoting dialogue in the region and the importance of grassroots level organisations with strong support from the bottom up.

ALF is an international organization working from the Mediterranean to promote intercultural and civil society dialogue and is based in Alexandria. UNIMED is an association of Universities from the countries of the Mediterranean basin. It currently counts 108 associated Universities coming from 23 countries of both shores of Mediterranean. UNIMED's aim is to develop university research and education in the Euro-Mediterranean area in order to contribute to scientific, cultural, social and

## MEDAC and ALF organize the 3<sup>rd</sup> YOUNG MEDITERRANEAN VOICES LEADERSHIP SEMINAR

The third from a series of three week-long leadership seminars, was co-organized by MEDAC and the Anna Lindh Foundation (ALF) in the framework of the Young Mediterranean Voices (YMV) project in January 2021. Unlike the previous two, the seminar was held online as a result of COVID restrictions with the MEDAC classroom being transformed to broadcast the Seminar. Ellada Evangelou, coordinator of YMV for ALF and Lourdes Pullicino, coordinator for the YMV Leadership Seminars for MEDAC prepared the programme.

The Seminar took place over the course of five days from 25 to 29 January 2021 during which the 27 young leaders had unique access to experienced global leaders, EU policy-makers, media mentors and influential peer networks from politics, business and civil society. The overall aim of the Seminars is to build the participants' capacity for shaping policy and media narratives while enhancing their cultural intelligence and leadership skills.

The 27 young leaders of the third seminar came from 18 countries including Albania, Algeria, Austria, Bosnia-Herzegovina, Cyprus, Egypt, Finland, Italy, Libya, Lebanon, Malta, Morocco, Palestine, Portugal, Romania, Spain, Syria and Tunisia and were selected from around 200 applicants.

A highlight of the third seminar was participants working in teams on elaborating policy recommendations under the mentorship of Members of the European Parliament Lena Düpont, Lidia Periera and Maria Walsh and Elena Grech, Head of the European Commission Representation in Malta. The teams were supported by the valuable input of public policy expert Mike Waldron. The participants worked in inter-regional teams on designing, formulating and advocating for a policy proposal on one of four selected Sustainable Development Goals - SDG4: Quality Education; SDG8: Decent Work and Economic Growth; SDG10: Reduction of Inequality and SDG16: Peace, Justice and Strong Institutions.

The keynote opening speech was delivered by the President of Malta, H.E. George Vella, under whose tenure as Foreign Minister the YMV programme was launched at the Anna Lindh Mediterranean Forum held in Malta in 2016. The opening session also included Nabil Al-Sharif, Executive Director of ALF and MEDAC Chairman, Prof. Godfrey Pirotta. The President of the World Leadership Alliance: Club de Madrid, Former President of Slovenia Danilo Türk participated in an inspirational conversation with participants on the fourth day.

On the final day, the teams presented and defended the policy recommendations they formulated in front of a High-Level Panel moderated by MEDAC Director Prof. Stephen Calleya and consisting of Tarja Halonen, former President of Finland; Miriam Dalli, Minister for Energy, Enterprise and Sustainable Development; Henrike Trautmann, Acting Director of DG Near, European Commission; Bernie Mizzi, Director at CHSMC and Head of Chiswick House School and Michael Köhler, Deputy Director General, DG ECHO, European Commission. Both latter sessions were broadcast

live on Facebook on the MEDAC FB page. In addition to the co-organizers—MEDAC and the Anna Lindh Foundation, the World Leadership Alliance: Club de Madrid is an important and constant partner of the Seminar. The programme also involves co-partners of the YMV programme such as the British Council and is co-funded by the European Union.

#### **MEDAC Outreach**

MEDAC's good relations and consistent outreach provided exceptional opportunities for MEDAC students to engage on a number of themes with high-level personalities. Over the course of three months, MEDAC was privileged to host Ambassador Brigitte Curmi, French ambassador to Malta; Amb. Rita Adam, Ambassador of Switzerland to Italy and Malta; Ambassador Lamberto Zannier, High Level Expert with the OSCE Parliamentary Assembly and former OSCE secretery general and Ambassador Hana Hubackova, Czech Ambassador to Italy and Malta. The ambassadors addressed themes as diverse as the geopolitics of Covid-19, Swiss soft power, minorities in international relations and the Czech foreign policy agenda leading to 2022 Czech EU Presidency.

On Monday 22 February 2021, **Ambassador of France to Malta, H.E. Brigitte Curmi,** delivered a keynote lecture to MEDAC students and faculty on the theme of 'The Geopolitics of Covid-19'. H.E. Brigitte Curmi articulated eloquently how the Covid-19 pandemic has pushed international relations and geopolitics into a new era and spoke of how the outbreak of the pandemic serves as a stark reminder that multilateral cooperation across borders is key to overcoming global challenges.

Ambassador Curmi noted that the effects of the pandemic on the Mediterranean region will not be equal for all, highlighting the varying level of inequalities and discrepancies when it comes to the health services' capacity of various countries, the capacity of governments to organize national inoculation programs and countries' ability to re-start their economies. The keynote lecture was followed by a Q&A.

On 23 March 2021, MEDAC was privileged to welcome **H. E. Rita Adam, the Ambassador of Switzerland to Italy and Malta**, who delivered an address on the theme 'Swiss soft power for a more peaceful and secure world'.

The Ambassadorial lecture took place online and provided the postgraduate students at MEDAC with the opportunity to participate in a lively discussion with Ambassador Adam. This special occasion allowed MEDAC faculty and students to achieve a better understanding of Switzerland's foreign policy when it comes to projecting soft power in contemporary international relations.

On 24 March 2021, **H.E. Ambassador Lamberto Zannier** addressed the issue of 'Minorities in International Relations' in a lecture attended by MEDAC's students and academic staff. Amb. Zannier spoke of his experience as the High Commissioner on National Minorities of the Organization for Security and Co-operation in Europe and focused on guidelines and thematic recommendations as well as best practice approaches developed by this office to address situations in which tensions involving national minorities could develop into conflict.

This involves identifying and addressing cases of tensions and conflicts as well as short-term triggers and long-term structural concerns. Amb. Zannier engaged in a lively Q & A session with MEDAC students, which covered issues such as the role of youth, media, education, understandings of history and approaches towards disputed monuments.

Amb. Zannier currently serves as High Level Expert with the OSCE Parliamentary Assembly. His career included engagements with the United Nations, Organization for Security and Co-operation in Europe and the North Atlantic Treaty Organization.

Hubackova provided an indepth analysis of the main Czech Republic foreign policy agenda including a focus on the forthcoming 2022 Czech EU Presidency. MEDAC is grateful to Chairman Prof. Godfrey Pirotta for facilitating this opportunity.

#### **Ambassadorial Lectures**

The Foreign and European Ministry of Malta is an important stakeholder in MEDAC with exchanges taking place on a regular basis. One privilege of this strong relationship is the number of Maltese representatives to different countries and institutions who engage with MEDAC students.

Following the appointment by Minister for Foreign and European Affairs Evarist Bartolo of three new 'thematic' Ambassadors - Cecilia Attard Pirotta as Ambassador for Women, Peace and Security, Professor Godfrey Baldacchino as Ambassador for Islands and Small States, and Professor André Xuereb as Ambassador for Digital Affairs – MEDAC felt it was right to bring this reality into the class. Through these appointments, the Ministry aims to address new realities and keep pace with the continued transition and development in international relations. Another key appointment by the Government of Malta was that of Ambassador Vanessa Frazier as the first woman Permanent Representative to the United Nations in New York. Ambassador Frazier has been tasked to lead Malta's bid for election to the UN Security Council for the period 2023-24.

MEDAC hosted **H.E. Amb. Vanessa Frazier**, **Permanent Representative of Malta to the UN** and a MEDAC alumna on 15 April 2021. Amb. Frazier shared with MEDAC and International Relations students a very rich presentation of Malta's programme and priorities in its bid to secure a seat on the UN Security Council in 2023-2024. The session included a dynamic Q&A where Amb. Frazier elaborated on Malta's goals if elected to the UNSC including championing Climate Security and chairing the Committee on Libya.

On 13 April 2021 MEDAC was privileged to host a keynote lecture by Malta's **Ambassador for Islands and Small States, H.E. Prof. Godfrey Baldacchino**. During this address, Prof. Baldacchino provided a profound analysis of Malta's four phases of development highlighting the historic milestones already achieved and future oriented strategic perspectives.

MEDAC students and academic staff participated in a dynamic exchange during the Q&A session and benefited immensely from the expertise shared by Prof. Baldacchino on this wonderful occasion.

On 1 March 2020, **Malta's Ambassador of Women, Peace and Security H.E. Cecilia Attard Pirotta** delivered a keynote address to MEDAC students and faculty on the theme of 'Women, Peace and Security'.

Ambassador Pirotta, a MEDAC alumna, provided a concise historical context of the foundation of the Women, Peace and Security (WPS) agenda and presented an indepth analysis of the United Nations Security Council Resolution 1325. H.E. Attard Pirotta's address emphasized how women, although disproportionately impacted by both traditional and emerging security threats, continue to be excluded from participation in peace process and peace building initiatives.

H.E. Attard Pirotta also highlighted the importance of having a National Action Plan to implement the WPS agenda, reiterating that "in order to raise women's voices internationally, change needs to happen in local communities".


#### MEDAC PUBLICATIONS

The publication was presented to H.E. President Vella by MEDAC Director Prof. Stephen Calleya on 19 May 2021.







MEDAC's most recent publication 'Championing Diplomacy in the Mediterranean.
