Nominations are to be duly proposed and seconded by enrolled students. Nominated students are required to signify, in writing, acceptance of their nomination.

Nominations received will be published on the University of Malta website on <u>Wednesday 3</u> <u>March, 2021</u> and all students will be informed of this by email.

<u>Eligibility to vote:</u> All students enrolled at the Islands and Small States Institute during the current academic year.

Voting for these elections will take place on <u>Thursday 18 March</u>, <u>2021</u> between <u>9:00 a.m.</u> and <u>6:00 p.m.</u>

An **ONLINE** election system will be used. On the day of the election, you will receive an e-mail on your University e-mail account with a link to vote. You can only vote once and your voting choices will remain anonymous.
