There are **two** vacancies on the Board of the Faculty of Information and Communication Technology and the term of office shall extend from 09 November 2023 till 08 November 2025.

Nominations are to be duly proposed and seconded by enrolled students. Nominated students are required to signify, in writing, acceptance of their nomination.

Nominations received will be published on the University of Malta website on **Friday 27 October, 2023** and all students will be informed of this by email.

**Eligibility to vote:** All students enrolled at the Faculty of Information and Communication Technology during the current academic year.

Voting for these elections will take place on **Thursday 09 November, 2023** between **9:00 a.m.** and **5:00 p.m.**

An **ONLINE** election system will be used. On the day of the election, you will receive an e-mail on your University e-mail account with a link to vote. You can only vote once and your voting choices will remain anonymous.
