CALL FOR APPLICATIONS

BACHELOR OF LAWS (HONOURS) FOURTH YEAR, MASTER OF ADVOCACY AND MASTER OF NOTARIAL STUDIES STUDENTS (2018/9)

The Faculty Board of Laws approved that the Faculty should publish a Dean's List. The rules regulating the Dean's List are the following:

1. Entry into the Dean's List is to be based on objective and measurable academic criteria (quantity of good grades obtained) and not on ranking among students.
2. The awards are to be made on an all-faculty basis, without discriminating between departments, units and programmes.
3. The Faculty is to offer the award at the beginning of the fourth year in the LL.B. (Hons.) course covering the first three years of the LL.B. (Hons.) degree, and at the end of the second semester of the Master of Advocacy and Master of Notarial Studies courses.
4. Account should be taken of students' performance during all the previous years.
5. The criteria being adopted by the Faculty for the **LL.B. (Hons.) course are the following:**
 - (i) 80 ECTS – Grade A or A+;
 - (ii) 40 ECTS – Grade B or B+
 - (iii) 20 ECTS – Grade C, C+, D or D+;
 - (iv) No fail/resit;
6. The criteria being adopted by the Faculty for both the Master of Advocacy and Master of Notarial Studies based on student's performance in the first two semesters of the course (the third semester is excluded) are the following:

- (i) 45 ECTS - Grade A;
 - (ii) 10 ECTS – Grade B;
 - (iii) 5 ECTS – Grade C or D;
 - (iv) No fail/resit;
7. Students who meet these criteria will feature in the Dean’s list and will be eligible for the award. Further details will be announced at a later stage as to the prize to be awarded.
8. Students who feel they meet the criteria listed below should apply, filling in the corresponding special form attached hereunder. A copy of the official/unofficial transcript should be attached with the application form. **Closing date for the receipt of applications is noon of Friday 7th Sept, 2018.**
9. Late applications will not be considered.
10. The application form for each course is set out as an Appendix to this call.
