Ftit tal-ġimgħat ilu, eżattament bejn l-24 ta' Settembru u l-10 ta' Dicembru 2010, inagħtajt l-opportunita' li nirrappreżenta l-Korp tal-Pulizija ta' Malta waqt kors ta' taħriġ ta' hdx-il ġimgħa ġewwa l-FBI National Academy li tinsab fi Quantico, Virginia, l-IStati Uniti tal-Amerika.

L-Akkademja tinsab ġewwa l-Marine Corps Base, fi Quantico, mifruxa fuq medda ta' art ta' 93 mil kwadru. L-Interpreti, Il-Qrati u l-Pulizija

Dawn l-aħħar snin, kemm il-Qrati kif ukoll il-Pulizija qiegħdin jitolbu l-kollaborazzjoni tal-interpreti ta' diversi lingwi fil-ħidma tagħhom. Dan għaliex żdiedet il-preżenza f'pajjiżna ta' persuni ta' nazzjonalita' barranija għal raġunijiet ta' negozju, żwieġ bejn Maltin u barranin, kif ukoll residenza ta' barranin f'Malta minn persuni li joriġinaw mill-Unjoni Ewropeja.

L-interpreti mal-Pulizija u l-Qrati jissejhu għal xogħol li jinvolvi kemm akkużati kif ukoll vittmi. Spiss ukoll, l-interpreti jintużaw meta jkun hemm xhieda li la jesprimu ruħhom bil-Malti u lanqas bl-Ingliż.

Il-Konslu tal-Ambaxxata Franciża f'Malta, Monsieur Philippe Foiret, li attenda diversi seduti fil-Qrati Maltin li jinvolvu persuni ta' nazzjonalita' Franciża, sejjah ix-xogħol tal-interpretu bħala « pivot » [fulkru]. Dan għaliex l-istess interpretu jaħdem f'seduta waħda mal-prosekuzzjoni, l-avukat tal-akkużat, l-akkużat innifsu u l-Maġistrat jew l-mħallef. Madankollu, jekk il-parti ċivili teħtieġ interpretu, dan irid jiġi provdut minnha stess. Naturalment, l-interpretu għandu wkoll kodiċi tal-etika u ma jstax, per eżempju, jiżvela lill-prosekuzzjoni jew lill-istess Qorti, dak li ntqal bejn l-akkużat u l-avukat tiegħu.

L-interpretu mhux biss irid ikun jaf tajjeb iż-żewġ lingwi li jkun qiegħed juża, iżda wkoll is-sena u l-arti tal-interpretazzjoni. Dan minħabba l-fatt li żewġ lingwi mhux bilfors ikunu jixxiebu bħal-lingwi « kuġini » tal-familja Latina il-Franciż, it-Taljan, il-Portugiż, l-Ispanjol u r-Rumen. Ħafna jaħsbu li r-Rumen mhix lingwa Latina iżda Slava. Fil-fatt ir-Rumen hi lingwa Latina minkejja l-fatt li dawk li jikkellmuha jgħixu f'pajjiż tal-Ewropa tal-Lvant – fis-sens Ġeografiku.

Flessibilita' u Versatilita'

L-ewwel tip ta' flessibilita' jew versatilita' mistennija mill-interpretu hi dik fejn, kemm jista' jkun, ikollu kompetenza

f'aktar minn lingwa waħda. [F'Malta ma naffordjawx interpreti esperti f'qasam wieħed tal-lingwa, per eżempju nterpretu tal-Franciż ekonomiku jew Ġermaniż xjentifiku] Dan jgħin kemm lill-interpretu nnifsu għax jipprovdi aktar okkażjonijiet ta' xogħol, kif ukoll lill-Pulizija u l-Qrati li ma jkollhomx bżonn ifittxu ħafna biex isibu nterpretu disponibbli.

Naturalment hu diffiċli li persuna tkun kompetenti ugwalment f'numru ta' lingwi peress li l-kompetenza hi relatata mal-frekwenza tal-użu ta' din l-għodda lingwistika. Madankollu xorta waħda ikun diffiċli biex issib interpreti f'kull lingwa. Darba akkużat li t-tieni lingwa tiegħu kienet il-Franciż u l-ewwel waħda kienet il-Bambara, talab li jinstab interpretu għalih li jikkellm bil-Bambara. L-ispettur Prosekutur kien paċenzjuż biżżejjed biex jispjega li rarissmu l-Qorti jew il-Pulizija jiġu bżonn interpretu tal-Bambara u għalhekk ma kinux jafu persuna li tista' tagħmel dan.

Il-flessibilita' u l-versatilita' tal-interpretu jintużaw fejn jidhru dak li jissejjah Creole, cioè lingwa magħrufa nfluwenzata minn lingwa ndiġena. Halli nagħti eżempju minn pajjiż li minnu ġieli kien hemm każi għand il-Pulizija u fil-Qrati. Dan hu l-każ tal-Kosta tal-Ivorju fejn waħda mil-lingwi ufficjali hi l-Franciż. Iżda, barra minn dan, hemm mhux anqas minn sbatax il-lingwa Afrikana f'dan il-pajjiż. Kull waħda minn dawn il-lingwi tinfluwenza l-Franciż lokali, ngħidu aħna bħall-Anglo-Malti f'Malta fejn xi persuni jgħidu « tifflowtja » eċċ., u b'riżultat ta' dan jinħoloq il-Creole. Meta nterpretu espert fil-Franciż jikkomunika ma' persuna l-warjana, jkollu janalizza l-espressjoni Creole b'tali mod li l-messaġġ jiġi iffiltrat biex johroġ il-messaġġ Franciż. Mhux faċli ! Per eżempju wieħed mill-Creoles johloq il-kelma « takis » mill-Franciż « taxi » jew « fi-la » mill-kelma “ la fille.” F'każi bħal dawn, ix-xogħol tal-interpretu jista' jkun frustranti.

National Council Meeting 2010: As you were duly informed through our e-News and Il-Pulizija our National Council Meeting was held on Sunday 30th January between 09.30 and 12 noon, at the Police Associations Centre Marsa, starting with the Sunday Mass concelebrated by Fr. Ray Bonnici. After Mass the meeting was opened at 10.15hrs by the National President Dione Bugeja who after thanking those present for their participation and support, invited the Secretary General Romeo Micallef to proceed with the administrative report. In his report Romeo went through the committee meetings and the activities held during 2010, including also assistance rendered to foreign IPA friends, and community work. Following this presentation the National Treasurer Joe Mamo took the floor and through his power point presentation gave to those present a detailed report about the financial state of our Sections and the profit and loss account for 2010. As it was predicted at the beginning of the year due to the purchasing of 200 lapel badges, we ended 2010 with a slight loss

of 14€. Being aware of such a situation, as a committee we did our utmost, even through personal donations, to maintain the loss as low as possible, and in fact we nearly succeeded. Notwithstanding such a situation we still did our duty and donated money towards charity and as aid, when this was needed. At present the accounts stand as follows:

For the next item on the agenda the president put forward two amendments for the National Rules with regards to Article 3 Administration – to include paragraphs 2a, 3a and 3b. However after a healthy discussion and suggestions, involving a number of members, the NEC decided to withhold proposed paragraphs 3a and 3b, and only paragraph 2a was put forward and accepted. This stated that:

- 2a If a position within the National Executive Committee becomes vacant during any period of the term of office, the NEC shall have the power to either:
- i) Leave the position vacant until the period of office expires, or
 - ii) Co-opt another member.



Following the Statute and Rules amendment, the President proceeded by giving a brief presentation about the achievements and works performed by the National Executive committee during the term of office 2008 – 2011. At the end of this presentation it was evident that the committee had managed to perform considerably well, both locally and internationally, notwithstanding our limitations. Off course there is always space for improvement and to perform better,

especially with regards to recruitment of new members. Different suggestions were put forward by members which were noted for consideration. One of these suggestions which was accepted by the NEC, was that in the future when nominations for the NEC posts are announced, apart from being published on our e-News, this announcement should also be sent to members as a separate item, to avoid being missed.

Congratulations: On half of the NEC and all IPA members we would like to congratulate our friend and NEC member Fr.

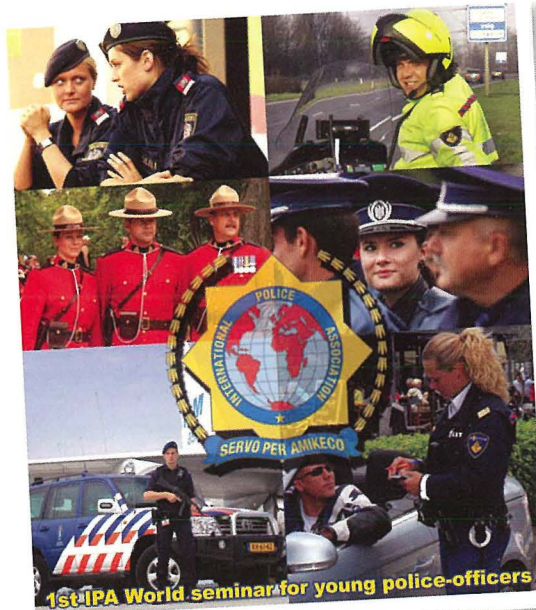
