John Rizzo: Commissioner of Police

John Rizzo, son of Gerald and Concetta nee Ear was born on 10 May 1956 in Cospicua. He is married to Catherine and has four children, Elaine aged 18, Keith aged 16, Jeffrey aged 10 and Kurt John aged 4.

He received his primary education at the Cospicua Primary School and his secondary education at St Joseph Secondary School, Paola.

In 1976 he joined the Malta Police Force as a constable and performed district duties in the Valletta and Cospicua Police Stations. In 1980 he was promoted to Sergeant and in 1984, following a competitive examination, he was promoted to the rank of Inspector.

In 1986 he obtained a Diploma in Law and Administration from the University of Malta. In 1991, Mr Rizzo was posted to the Criminal Investigations Department. While serving in this post, he attended a European Homicide Investigation's course for senior detectives from European Police Forces at this Police Staff College in Branshill, UK. He also carried out duties with Metropolitan Police officers, investigating unsolved murder cases.

In 1996 Mr Rizzo was promoted to the rank of Superintendent and in 1997 as an Assistant Commissioner. In 1997, he attended a familiarization visit to several section of the Metropolitan Police Services, while in 1998, he attended a training course in International Law Enforcement Cooperation at the National Police Agency in Japan.

Mr John Rizzo was appointed Commissioner of Police on 2 November 2001.

This is far better than the uncomfortable conditions that the illegal immigrant where kept in at the detention centre at Ta' Kandia with all staying in one dormitory with few facilities. The new building can accommodate 90 illegal immigrant and around 36



llegalment u kemm dawk li jkunu hawnhekk u jkollhom talba pendentti ghal status ta' refugjat. Id-distinzjoni bejn immigrant klandestin hija netta u għandha tkun cara għal kullhadd.

Sa ffit tas-snин ilu, l-immigrant illegali kienu jitpoggew il-habs jew jithallew għal-xhur shah ficelel tad-Depot li kienu ntizi għal akkomodazzjoni għal-massiġġu ta' 48 siegha, u anke għal-tali detenzjoni qasira tal-post kien għiekk kundan anke mill-Qrati Maltin. Fil-fatt anki r-rapport tal-Kunsill ta' l-Ewropa kemm 1990 kif ukoll 1995 kien appellaw lill-Gvern sabiex jirrimedja għal din is-sitwazzjoni peress li dawn l-immigrant ma setgħux jitqisu bhala kriminali.

Kien għalhekk li l-Gvern iddecida li jirranga post dilapidat li qabel kien f'idejn is-servizzi sabiex jakkomoda l-immigrant u dawk li jaapplikaw għal status ta' refugjat. Ta min jghid li sa ffit taz-zmien ilu dan il-post kien kompletament abbandunat u fi stat dilapidat.

Fil-fatt, mill-1979 sal-lum dan il-bini ffit li xejn intuza. Minn meta ingħata lill-Korp tal-Pulizija sar hafna xogħol fih u hawnhekk nixtieq nifrah lit-trade section li taht it-tmexxija tal-Kummissarju għamlu l-almu tagħhom kollu biex joffru post dicenti u uman għal dawk kollha li jsibu ruhhom fih. Dan il-post huwa hafna ahjar minn dak li kien hemm Ta' Kandja li kien tajjeb għal numru limitat ta' immigranti izda meta kien ikun hemm influss kbir kien johloq problemi ta' sovraffollament.

Ic-centru l-għid jilqa fih madwar 100 persuna u fih il-facilitajiet kollha li wieħed għandu jsib f'post ta' detenzjoni. Bhalissa f'Malta hawn madwar 70 immigranti, li l-parti l-kbira tagħhom applikaw għal-

status ta' refugjat. Nixtieq niehu din l-opportunita sabiex infahhar il-hidma tal-Pulizija ta' l-Immigrazzjoni għal hidma ta' dawn l-ahħar xhur kontra l-immigrazzjoni illegali. Ta' min ifakk il-2001 gew rifutati fl-Ajrūport u fis-Seaport 2266 persuna barranija, 731 persuna ttellghu l-Qorti biex jigu deportati. Minn dawn madwar 60 persuna għadhom Malta minhabba li għandhom talba pendentti għal status ta' refugjat.

Fl-ahħarnett ta' min ifakk li kif weghħDNA fil-White Paper, il-Parlament approva klawsola li biha kull min jinqabbar iwettaq ir-reat tat-traffikar fl-immigrant jehel; piena ta' hames snin (qabel kienet sitt xhur) u jew multa minima ta' 10.000 lira Maltin u ma tistax tingħata sentenza sospiza, piena anqas mill-minimu, jew 'probation'. Dana oltre il-piena applikabli f'kaz ta' hsara li ssir fuq il-persuna ta' l-immigrant.



7 muturi ġodda għat-taqṣima tat-traffiku



u Gymnasium li qiegħed fit taqṣima ta' S.A.G. f'Ta' Kandja Gew imbierka mill-Kappillan tal-Pulizija Fr. Raniero Zammit. Ghall-din l-okkazzjoni attendew il-Ministru ta' l-Intern Dr. Tonio Borg u l-Kummissarju tal-Pulizija John Rizzo. Prezenti kien hemm bosta uffiċiali għoja tal-Korp.

Diskors tal-Kummissarju

Mill-bidu tal-ezistenza ta' dan il-kumpless kient inhasset il-htieġa li jkun attrezzat b'Gymnasium fjen ikun jista' jsir it-taħriġ fiziku li tan huwa mportanti fil-qadi tad-doveri tal-Pulizija seċjalment għall-skwadra speċjali bhalma hija l-Special Assignment Group. Hafna drabi membri ta' din l-iskwards jiġu msejħa fuq operazzjonijiet seċjali, diffiċċli u b'sogru kbir ghall-hajja kundizzjoni fizika. Mal milja taż-żmien inhasset il-htieġa li l-gymnasium ezistenti jiġi mkabbar u attrezzat b'aktar apparat modern. Fil-fatt kif qed tgħarraw inbena dan il-Gym fjen fihi wieħed isib apparat modern għat-taħriġ fiziku. Ta' min isemmi li dan

ix-xogħol tista' tgħid li sar kollu minn membri tal-istess skwadra. Diskors Tal-Ministru

Sur Kummissarju, Sinjuri Il-membri tal-Korp tal-Pulizija għandhom wieħed mill-aktar xogħolijiet diffiċċli. Il-Pulizija għandu jieħu ħsieb is-sigurta' pubblika. Izda għandu l-poter ukoll li juža l-forza biex jipproteġġi lill-haddieħor. Il-Pulizija qiegħdin hemm biex jipproteġġuna mill-kriminalita', Iżda fl-istess waqt għandhom jipproteġġu wkoll id-drittijiet tagħna. Biex jaġħmlu x-xogħol tagħhom b'mod effettiv, il-Pulizija jridu jiksbu l-fiduċja u r-rispett tal-komunita' fejn iservu. Huma għandhom jizviluppaw relazzjoni ta' shubija maċ-ċittadin li jipproteġġu.

Fundamentali wkoll fix-xogħol tal-Pulizija huwa t-taħriġ. Illum il-ġurmata bis-saħħha ta' l-Akkademja tal-Pulizija kull rekluta ġdid li jissieheb fil-Korp jghaddi minn perjodu ta' taħriġ kemm akkademiku kif ukoll fiziku. L-Akkademja, matul is-sena torganizza wkoll refresher courses għall-Pulizija fil-livelli kollha. Dan il-gym ta' l-SAG

li qed ninawgħura illum, huwa ta' importanza kbira biex il-membri ta' l-SAG ikomplu għaddejjin b'taħriġ fiziku li għandhom bżonn biex ix-xogħol tagħħom jibqgħu jagħmluh kif jixraq. Ix-xogħol ta' l-SAG huwa x'aktarx l-aktar wieħed skabruż tal-Korp, Huma iservu ta' pulizija kontra r-rewwixti, ta' skorta ghall-VIP's u jakkumpanjaw it-traspost u l-esibizzjoni ta' oggetti prezzju. Iservu wkoll ta' gwardji ma' ambaxxati u postijiet oħra ta' importanza strategika – xogħol li l-volum tiegħu zdied hafna wara l-attakki tal-11 ta' Settembru.

Dan il-gym jintuza wkoll biex fihi isir taħriġ fl-arti marżjali. Fill-fatt instructors kwalifikati jagħtu taħriġ, mhux biss lill-membri ta' l-SAG, Iżda wkoll ill-Pulizija tal-Mobile f'dixxipli bħal ma huma l-Akido u l-Judo. Tajjeb li wieħed jenfasizza li x-xogħol kollu li sar fil-bini



u l-attrezzar ta' dan il-gym, għamlu il-membri stess ta' l-SAG.

L-okkazzjoni tal-lum qed isservi wkoll biex ninawgħuraw ufficjalment dawn is-seba; muturi li nxtraw għall-pulizija tal-mobile. Minbarra dawn il-vetturi l-ġoddha u oħrajn bħalhom, inxtrat il-magna li taqra l-fingerprints b'mod awtomatiku, ġiet stallata sistema ta' trucking għall-vetturi kollha, inxtraw għadd ta' bullet proof vests u se jinxraw oħrajn, u nbenew kwartieri ġenerali għodda għat-taqṣimiet kollha tal-Korp. Dan kollu kien possibbli permezz tad-deċiżjoni li ha l-Gvern, li fl-ewwel budget tiegħu wara l-ahħar elezzjoni, kien zied il-vot kapitali tal-Pulizija b'40 fil-mija u dan il-vot inzamm konsistenti fil-budgetsusseġġenti.

Din turi l-konsistenza u l-impenn minnaħha tal-Gvern biex ikompli jwettaq il-wegħda tal-programm elettorali biex jiġu attrati l-ahjar nies lejn il-korp, u jingħaaw aktar taħriġ spċjalizzat kif wkoll l-ahjar tagħmir għax-xogħol tagħhom.

PC494 Roger Debattista, missier ta' tlett itfal žgħar bniet u li għandu 34 sena minn Birkirkara, stazzjonat fit-Taqsima tal-Klieb, nqatel kiesaħ u biered, b'tif ta' arma tan-nar, waqt hold-up li spicċa f'delitt fahxi, li seħħ fil-fergħa tal-Bank of Valletta f'Ta' Farsina, f'Hal Qormi. Dettalji dwar kif seħħ dan id-delitt ingħataw aktar tard fil-ghaxja, waqt konferenza ta' l-ahbarijiet indirizzata mill-Kummissarju tal-Pulizija, John Rizzo. Kommox għall-ahħar b'din il-ġraja traġika li laqtet il-Korp tal-Pulizija, il-Kummissarju Rizzo spjega li l-qtil seħħ għal ġabta tal-10.45 a.m.



The Public Perception of the Malta Police Force

Public expectations from the Police

Every group in society seeks competent policing that addresses its concern. The Police Force is not only interested in identifying what local communities expect from it, but also wants to identify how well they are meeting those expectations. The Police have a principal function of maintaining law and order. They have a highly organized mobile response capacity immediacy and they have the symbolic and legal power to take action. Moreover, they fulfill public expectation that the service they render be both effective and fair.

Since the Police are the subject of public scrutiny, particularly through their regular exposition to the media, it is an integral part of policing that they have an understanding of the way in which they are perceived. The Malta Police Force is not an exception. This dissertation explores these issues. It deals with the overall satisfaction that the way Police attend to their duties, the public's knowledge of police activities and justification of Police errors. The research examines knowledge of the extent of community satisfaction by measuring public expectations of the Police Force. The study also explores the nature of the public's demand for a visible police presence.

For the purpose of this study a quantitative research was

used. Such research required the variables under consideration be defined, operationalised and measured. This study focuses on the socio - economic grouping of the Maltese society, from 18 years onwards. A sample of 320 participants was selected randomly from the telephone list of exchange working lines as registered with Maltacom. After designing the questionnaire and before administering it, the researcher carried out a pilot study in order to see whether or not it was likely to get the desired results. The collection of data was undertaken during a two month period between January and February 2001 through telephone interviewing. Data was primarily produced through random digit dialing (R.D.D.) SPSS program was used to highlight the findings


from the data collected. The response rate was 93.4 percent and descriptive one way analysis of variance, chi-square tests, cross tabs, and correlation were used as to check whether there was a relationship between different frequencies.

The research has shown that the overall public opinion of those interviewed responded positively towards their perception of level of satisfaction with the services provided by the Police Force. This study was based on the number of contacts the public had during the past year with the Police, And the nature I of such contact. The public's awareness of security during day and night, Police accountability, Police manners and effectiveness. The researcher also tackled the problem of police presence and the public views on key objectives for policing.









Chinese General - Tang Dynasty



Seminar attended by members of the Law Administrative Law Enforcement

During June 2001 members of the Administrative Law Enforcement Branch were invited to attend a four days course at the Birdlife Malta Headquarters. Also invited to participate were members of the Armed Forces of Malta, Customs and members of the Department for the Protection for the Environment and security personnel at the Malta

International Airport.

Aim of this course is to compare foreign environmental laws and regulations and methods used by the Scottish police vis-à-vis the Maltese legislation's and field work. Main speakers were Mr Dave Dick officer from the Royal Society for the Protection of Birds (Scotland) and Mr Alan Stewart in his capacity as Wildlife Liaison Officer with the Tayside Police Scotland. Mr Stewart is a retired police inspector who worked in different branches of the Tayside Police for over two decades. An introductory speeches were made by Mr Justin Vassallo and Mr Joe Sultana both of Birdlife Malta. Mr Vassallo stated that Birdlife Malta (Ex Ornithological Society of Malta) is a non-governmental organisation which have a limit finds available for its running and at present only employs one full time and another part-times person to run its Headquarters at Ta' Xbiex.

Mr Vassallo stated that the reason they felt to organised this course is that they would like to see that government bodies work close to each other and quoting "to work like a chain circle and to combat wildlife crime together".

Mr Joe Sultana an avid environment campaigner explained that in 1962 the then Malta Ornithological Society (Birdlife Malta) was established for the study of birds and nature in Malta. Its main objectives are to create public awareness for the protection of birds habitat for example Ghadira Natural Reserve, for the promotion and creating of new natural reserves like the island of Filfa which was

established in 1988.

The society is also involved in educating the general public by means of its publications. Mr Sultana also stated that some of its members are involved in bird ringing , members are also to be covered by a police licence. The speaker also spoke about legal and illegal practise in Malta and also aired the society preoccupation about organised hunting trips to Egypt and Tunisia, but not only. It's interesting to note that in the Maltese's legislation environment/hunting/trapping laws and regulations dates back to May 1492 and new legislation's/ regulations were passed from time to time during the following years:-

1911, 1936, 1980, 1993, 1996, 1997, 1998, 2000. A new Act no XX of 2001 Act to Protect the Environment was recently passed which repealed the previous act of 1991. The present regulations that the Police work on is Legal Notice 146 of 1993 and its subsequent amendments.

Another speaker was Mr Dave Dick of R.S.P.B who addressed the following topics:-History of the Royal Society for the Protection of Birds. European Wildlife Legislation History of Wild Bird Egg Theft. Taxidermy:- Illegal trade of Wild Birds. The Need for Training.

Use of the Media,

R.S.P.B was established at the beginning of the 19 th century when a movement was created against the widespread and indiscriminate shooting for wild birds in the United Kingdom. Hunting was at first done to collect a wide variety of feather from different birds. These feathers were then used for the manufacturing of ladies hats. It is estimated that it takes between six to eight bird (feathers) to create a normal sized colourful lady's hat. At present R.S.P.B has 1,000 full time employees with around 1 million paying members.

The R.S.P.B works with police forces, customs, army and coast guard patrol around the U.K for prevention of smuggling of wildlife endangers species or by-products. Their expertise is highly valued by the above mentioned forces and sometimes in difficult cases even university lecturers and museums curators turn up to have their advice

in this vast subject of flora and fauna.

As police officer we found the lectures of Mr Alan Stewart from the Tayside police Scottish of particular interest. Mr Stewart lectured on the following topics :- History of Police Wildlife Liaison Officers. Police Powers in Scotland.


Partnership for Action Against Wildlife Crime & Improving Scottish Legislation. Operation Easter , a U.K wide operation aimed at egg thieves. Education of the Public, Police Officers Training. Use of the Media.

Training the Public

During these lectures we found out that in Malta we are fortunate to have a branch like the Administrative Law Enforcement which at present is under the responsibility of Assistant Commissioner Mr. Josie Brincat, and helping him are Superintendent Mr Andrew Logan , Inspector Mr Alex P Miruzzi and 22 other ranks (five sergeants and seventeen police constables.). This was emphasised by all speakers in this course.

Instead in the United Kingdom every police Constabulary (district) have its own Police Force Wildlife Liaison Officers. At the moment since England and Wales are divided into 33 different constabularies , thus 33 persons occupies said post of Liaison Officers. Said position is held by different rank from one constabulary to another. For instant the Staffordshire Police is occupied by Deputy Commissioner Mr Dave Johnston whilst that of Hampshire Constabulary is held by Police Constable Geoff Culterton, and work independently from each other.

In Scotland there are 8 constabularies each having its own liaison officers. The main function of a Police Wildlife liaison officer is to help and assist field officers, since they don't have a specialised environment police unit For example, if for instance the drug squad is to conduct a raid at an area or residence regarding drugs, the Liaison officer should be notified , either to attend personally if person is known to be involved in wildlife crime or to give hints on how to conduct a search for wildlife related offences. It is to be noted that in Scotland most wildlife crime is committed by collectors of wild birds eggs. These so called egg collectors

are not satisfied to collecting one egg of each species , which by its self is illegal, but they disturb the whole nesting by taking all its contents. Some seized collections amounted to thousand of egg shells.

It was established that our section (A.L.E) comparing to the Maltese islands side and population with that of Scotland is more successful in capturing a non-abide citizen who infringe the bird hunting and trapping regulation and environmental legations. This success vary from one country to another. Firstly Malta have a full time branch (ALE) which does not exist in Scotland , secondly we have a smaller area and population to cover and also our present legislation is severe when infringed and simpler to prove than the Scottish legislation, which in the near future have to be change to European standards.

For instance there is no power to arrest in Scotland for certain infringement of environmental laws unlike legislation in Malta. It is worth saying that our Police Academy should include more in its syllabus / curriculum both at Police Officer cadet level and Other Ranks training courses , studies of legislation regarding the environment.

The Media and its effect was also discussed. A give and take policy was a common factor to established as good relations between the force and media. But sometimes its not possible to answer to all their demands for information. Its needless to say that ALE section relay heavily on the C.M.R.U for press releases and other news value items. There where instances when our ALE men were invited by the media either to participate on T.V or Radio programs or for an interviews with news papers.

This is always done by prior approval and permission from the Commissioner of Police. The speaker Mr Alan Stewart have a constant contact with schools all over the Tayside area. Lectures, school outings under police guidance, essays and painting competitions and quizzes are organised regularly by the police to keep pupils from tender age first of all familiar with their area police officers and also with the surrounding habitat for flora and fauna and informing them about present laws and regulations concerning the environment (what's legal , what's illegal). At some degree this is also being done when this section is invited to participate locally. Maybe in the near future similar activities can be organised

An open discussion developed after each topic

by the Police conjointly with the Department for the Protection for the Environment and the Ministry of Education and also with the help of non-government bodies. Again the C.M.R.U can give a helping hand to the A.L.E in setting up this idea if it is favourably seen by our superior officers as an idea which in itself is a proactive method which by sacrifice and time in the near future this sort of crime will be minimise considerably.

During the course we visited a problematic site at Dingli Cliff area. During the morning session no infringement of the law was observed however this contrasted with the after noon session which was mainly

organised for ALE personnel. During this visit a shotgun, and illegal bird trapping and a mist net (ranja: xibka wieqfa) and protected species were seized. Another idea which the Malta Police Force can benefit from , if applied is the making of a video type feature which can be produced by our police personnel since we have the necessary apparatus. Said video is to be shown and used during refreshing course, new recruits and cadets courses. This film should contain legal & illegal activities, how to act and what to find in theses instances. It should also contain present legislation as a form of question and answer format. (This is another method which may be used as police officer with the aim for educating our personnel at the police academy courses.)

The above indicates that as a police force (A.L.E) we are not trailing behind others police forces in enforcement, keeping in mind of our limited resources available. Position may get better for instance if adequate means of transport is provided both at land and sea or from time to time new human resource are employed in this section. In a recent visits by members of the International Animal Rescue, who some years ago donated to this section a dinghy, were most pleased to see that said dinghy is being used and well kept in contrast with others police forces who also benefited from their donation but according to them it seems not to care at all about its maintenance.

An open discussion developed after each topic. Our men went to this seminar to share our experiences and difficulties, we as a branch encounter when enforcement is required in connection with wildlife laws and regulations. It was a seminar worth attending.



Intervista ma l-ex Surgeant 255 George Muscat

(minn Alfred Debattista P.R.O.)

Illum sejrin inkomplu (u ntemmu) l-intervista li tana l-ex kollega tagħna George Muscat.

George kompla jirrakuntalna ġrajjiet ta' meta kien iservi tas-Sliema fil-bidu tal-gwerra. Kien hemm dak imsejjah "Curfew" li miegħu kienu marbuta regolamenti ħorox.

Kien żmien ukoll illi l-Qorti kienet ġiet trasferita għal Hal Balzan. Semmilna każ ta' tliet suldati li dahlu għand mara fi Triq Prince of Wales fejn anke wieħed minnhom spara tir ta' revolver. Kienu marru fuq il-każ wara telefonata li kellhom u wara l-każ, dawn is-suldati weħlu seba' xħur ħabs kull wieħed.

Mad-dikjarazzjoni tal-gwerra. George u oħrajn minn shabu Pulizija, kienu gew iddettaljati biex jaħdmu l-Belt fuq xogħol ta' "shadowing". Kien żmien meta s-Sur Axixa lahaq Kummissarju u s-Sur Ullo sar Kap tax-C.I.D.

Meta l-gwerra kienet qorbot sew (1939) George flimkien ma PC. 37 Vella gew magħżula biex jinhattru Surgenti. Kien hawn li minn fuq ir-Radio instemgħa Chamberlain jiddikjara gwerra kontra l-Germanizi. il-poplu beda jiġi ppreparat għal xi attakki li kien mistennija fuq Malta. Il-pulizija bidlu l-uniformi għal "Battle

Dress" a u ġew probdu bil-maskri tal-Gass.

Fil-11 ta' Ġunju 1940, meta kien fl-Għassa tas-Sliema, George irċieva messaġġ biex tindaqq is-Sirena biex tindika l-ewwel "Air Raid" fuq għżejtna. Fit-tieni jum tal-gwerra waqghet bomba ftit il-bogħod mill-Għassa. Hafna nies irħewla ghall-irħula jfittxu l-kenn u ħafna mid-djar tas-Sliema tħallew battala. In-nies li kienu baqgħu tas-Sliema kienu jiġu lejn l-Għassa ma kull Raid. Hawn inħass il-bżonn li jithaffer Xelter mill-bitħha ta' l-Għassa fejn in-nies setgħu jsibu kenn.

Minn fuq il-bejt ta' l-ġħassa George darba ra Ajruplan Germaniż ġej minn naħha tal-Belt għal fuq tas-Sliema. Sakemm niżel jiġri jghid lil shabu ħdejn ix-xelter, bomba kbira spiċċat fi Triq Prince of Wales, ftit il-bogħod mill-Għassa

u għamlet ġerba shiħha, bit terrapien li ttajjar jasal sal-bitħha ta' l-ġħasssa.

Il-pulizija fid-Distretti kellhom telephone dirett mad-Depot fejn kien hemm stazzjonat stakkament "Stand By" sabiex joħroġ jagħti l-ġħajjnuna fejn ikun hemm bżonn.

Meta l-gwerra battiet xi ftit, ghadd ta' Pulizija gew mgħajjita l-Belt biex jaħdmu xogħol ta' skorta kemm fuq vapuri kif ukoll fuq trakkijiet li kienu jittrasportaw provvisti għal kullimkien, inklużi Barracks tas-Suldati ngliżi, fi żmien il-Convoy". Kien hemm





regolamenti horox għal min jabbuża. Bejn l-uffiċjali tad-Dwana u l-Pulizija ġew fl-inkwiet u tkeċċew għax fuqhom sabulhom xi affarijeit żgħar li jkunu ddubbaw għal familja.

Dak iż-żien il-Pulizija ma kellhomx awtorita fuq il-baħar u ma setgħux, per eżempju, jintervjenu fuq serq ta' dghajjes li kien isir. Kien biss meta l-ligi ġiet riveduta u l-Pulizija bdew jilbsu l-Battle Dress. Bl-istess poteri ta' l-armata li setghu jiproċedu. B'hekk ukoll, il-Pulizija ġew intitolati għal "War Medals".

Kienet teżisti wkoll problema dwar ta' min kienet ir-responsabilita għall-intervent meta jiġgarraf xi bini. Sa dak inhar, min kien jasal l-ewwel bejn l-A.R.P., il-Pulizija jew tad-Demolision, kien jaħdem u meta tinqala xi problema, kienu jirrispondu l-Pulizija. Wara kien sar qbil illi l-Pulizija jidħlu l-ewwel biex jaraw hemmx mejtin jew feruti u wara jidħlu l-Korpi l-oħra. Minbarra li kienu jifittu l-identità tal-persuni, il-Pulizija kien jieħdu ħsieb ukoll li jindukraw xi ogħġetti ta' valur u jżommu sorveljanza. Bħalma baqghet l-užanza anke saż-żmien reċenti, min kien ikun Station Sergeant bħal George kien jieħu ħsieb illi minn fuq ir-Rough Book, idaħħal l-okkorrenzi (u jieħu ħsieb xi nuqqasijiet, għal ġewwa l- "Clean" (C.O.B.)

George isemmi wkoll każ ta' meta darba, waqt "Night Shift", ġie l-Għassa tas-Sliema suldat Inglijż fis-sakra u hedded lilu u lil Orderly b'revolver u kif irnexxilhom jarrestawh. Irriżulta li dak irrevolver kien serqu mill-Għassa tal-Balluta waqt il- "blackout". Dak iż-żmien, minħabba l- "curfew" kull min kien irid joħroġ mid-dar qabel il-5 a.m. (l-aktar għax-xogħol) kien ikollu bżonn ta' permess speċjali.

Għall-ahħar ta' l-1945 George ġie trasferit għal Hamrun fejn ma naqsux il-problemi li jkollu kull distrett.

Inċident minnhom kien il-Marsa waqt it-tiġrijiet taż-żwiemel meta arrestaw raġel wara feriment. Waqt li kien arrestat biex jitressaq il-Qorti filgħodu, l-Ispettur fdah li jmur jorqod id-dar u dan, minnflok, mar fħanut l-Imsida u spara w'qatel raġel (mhux lil min ried jolqot). Kien weħel għomru l-ħabs.

George jiftakar ukoll fit-tragedja li kienet saret ir-Rabat meta waqa ajruplan fi Triq San Publju fejn intradmu u mietu ħafna nies.

George kien għadu kif žmonta f'nofsinhar mill-Għassa tal-Hamrun meta telgħha ma oħrajn jagħtu l-ghajnejha lil shabhom fir-Rabat. Meta deher li kienu qalghu lil kulhadd minn taħt it-terrapien, inkluż hu Kuntistabbli, dan ta' l-aħħar

qalilhom l-i kien għad fadal it-tarbija ta' ta' ħu li sa dak il-ħin kienet ghada ma nstabix. George u sħabu komplew ifittxu u sabu lil din it-tarbija li ġiet għalhekk salvata. Kien tifel u għadu ħaj sal-lum. Fl-ahħarnett George għaddilna kumment dwar il-Good Conduct medal - wahda minn ħafna - li jidħru fir-ritratt. Huwa spjegalna illi dik fil-fatt ma kienetx tiegħi iż-żda peress li kien cert li kienu sejrin jaġħtuhilu kien issellef wahda biex f'dak ir-ritratt jidher biha. Sfornatament din il-midalja baqa ma rċievijiex għalkemm għamel ħafna rappreżentazzjonijiet dwarha matul għadd ta' snin anke wara li spiċċa mis-servizz. Nahseb taqblu miegħi illi mittagħrif li akkwistajna, George kelli karriera mimlija u interessanti.


