INTERPOL AND EUROPOL

Introduction

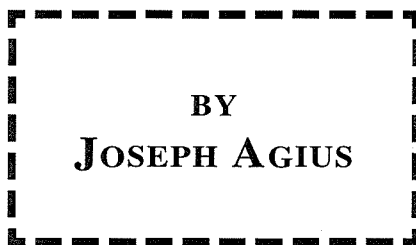
How many members of the Malta Police Force know about the work of two international organisations, Interpol and Europol? I am sure that most of them just know about their existence, but the nothing about their foundations, their activities and goals.

This is not an information that must be known only by the personnel working in the section of Interpol Floriana. The strategic position of frequently brings us in contact with those two organisations while investigating transborder crimes. We can get much out of such organisations, and so member of the force must know as much as possible about them.

Unfortunately in our libraries we have no books which deal direct those two organisations. They are many times just referenced in books dealing with drug trafficking and transborder crimes, but they are never discussed in detail. The aim of this brief study, taken from faxes and reviews issued by Interpol and Europol, is to understand better the efficient work do Interpol and Europol to fight international crimes and their relevance to the Malta Police Force. I would like this research project to serve as an information booklet to the members of the Police Force.

INTERPOL

The story of Interpol goes back to year 1914. During the first International Police Congress, held in Monaco, legal experts and police officers from fourteen different countries around the world studied the possibility of establishing an international records office and to find out a policy to introduce extradition



where necessary; this was interrupted by the First World War.

In 1923, at the end of the war, the Austrian chief of police, Dr. J Schober told the one hundred and thirty-eight delegates that he had invit Vienna, to found the *International Criminal Police Commission* (I.C.P.U.). commission was to establish new contacts between the people of the world. The International Criminal Police Commission was set up with its own status. This year Interpol is celebrating its 75 Anniversary. This organisation operated until the outbreak of the Second World War. At this stage, its members were from European countries.

In the next conference in 1946 in Brussels, new statuses were adopted and the commission's Headquarters moved to Paris. Its telegraphing address was 'INTERPOL'. By 1955 the organisation consisted of fifty members. They wished to expand the organisation and a new revised constitution was adopted to meet the requirements of world-wide co-operation. In 1966 its general secretariat moved to Saint Claude and the number of its state members reached a hundred by the end of 1967. Up to 1988, Interpol consisted of one hundred and forty-six members. It was forbidden to the organisation's members to undertake any intervention or activities of a political, military, religious or radical character.

GOALS OF THE ORGANISATION

Every organisation must have its goals, and the goals of Interpol are the following:

1. To ensure and promote the widest possible mutual assistance between all criminal police authorities within the limits of the laws of all different countries and the universal declaration of the human rights.

2. To co-operate efficiently and effectively for the control, prevention and suppression of ordinary law crimes.

Although Interpol's annual budget is around £45 million, not all the states contribute the same sum of money. Every state contributes according to his resources. One of the principles of Interpol is "Equality of all member states". All member states are provided with the same rights and service, irrespective to the financial contributions by any state. Above all that's why it is called contribution and not a fee. Every member has the interest to fight crime so every member has the same importance for the rest of the other members.

Every member within the Interpol must respect the sovereignty of the other members. They must operate within their own national boundaries and according to their own laws and constitutions.

The organisation has a universal co-operation. It co-operates through the National Central Bureaux to any government agency concerned with combating ordinary criminal offences. Its work is flexible enough to take account of the different structures and situations of other countries. In one sentence Interpol's co-operation has to depend on the co-ordination between the respective Police Forces to supply on request information or services where it is needed.

The structure of Interpol is composed of two deliberated organs;

the general assembly and the executive committee which takes decisions an supervise, and the permanent departments which make up the general secretariat.

The general assembly is formed by delegates appointed from the government of member states. This assembly at the time being meets once a year. It is the supreme governing body and its decisions are final. It adopts its policies working methods and control the organisation's finances. During an assembly each member state has one vote. Here we can see the principle of equality which governs the organisation and makes it a strong and united one. Decisions are taken in the form of a resolution or recommendations by voting.

The executive committee has thirteen members and are elected by the general assembly from the delegates. They elect a president for four years. Three vice-presidents and nine ordinary members are elected for a three-year terms of office.

Interpol has its own experts in every division of policing. They consist of experts in police skills, administrators, lawyers, financial and forensic experts and other skills which are needed world-wide to combat crime or to govern organisations who fight crimes.

It has also its research and study division. In this division, Interpol assemble the best experts in the field of crime control to co-operate with each other, share the knowledge of all involved states about criminality, and make research, analyse and circulate reference material on criminology, criminal law, procedure and techniques used world-wide.

To become more efficient, Interpol opened a support division. It consists

of telecommunications, criminal affairs and intelligence sub-division and a thirteen million pounds data processing department.

The database department is responsible for processing criminal intelligence and maintain computer records of the following:

1. Names organisation aliases of people implicated in case of international crime.
2. Offences classified by type of offence, place of commission and modus operandi.
3. Drugs seizures.
4. Counterfeit currency seizures.
5. Theft of works of art.
6. Identification numbers noted during the course of police investigations.
7. A ten print file using the Galton-Henry fingerprint classification system, containing the fingerprints of all ten fingers of each known intercriminal. By searching the file, it is often possible to establish the true identity of an offender (who may be using several aliases) of a dead body or of someone who has lost his memory.
8. A photograph file for specialised and habitual offenders and missing persons.
9. A system of electronic archiving with computerised indexing.
10. An electronic text and image server allowing NCB's, instant and remote consultation of a database of selected information.

All these electronic archives are centralised in the criminal information system known as CIS which is governed by the rules of international co-operation and on the internal control of archives. The use of this system is restricted to the general secretariat.

A supervisory board has the task to see that all work of all member states

is performed according to the provisions of the constitution, the material obtained is used according to its constitution; it is being done accurately and any information passed to a state, is kept for a limited period in accordance with the conditions made by Interpol.

Interpol is equipped with an automatic message switching system which processes about one million messages per year. A record of every message passed is recorded in the central computer for future references.

If Interpol is becoming more organised and efficient throughout the years, this change is also being made in the field of organised international crime. As the business of organised crime becomes international and involved in finance, raw materials and manufactured goods, organised crime is looking at established business very differently.

"Theft of moveable property is a mug's game. There are better, lower risk ways of making money."

(Intersec Vol.6)

Very few senior police officers in very few of the Interpol member states, admit the existence of organised crime in their own state. They all say that it comes from abroad, but from where? They all say that it is not a domestic organised crime group. Such inadmissibility makes the work of Interpol more difficult to handle. Every member state must carry his own burden so that the principle goals of Interpol may be reached. By the advance of travelling technology our world has almost become as one state, and within few hours one can travel from one side to the other across the globe. This gave the opportunity with each other and organise themselves so that things stolen from one place are sold in another country.

try. Persons who commit crime in one place may very easily find refuge in another place. Drugs are very easily transported from one country to another. This problem brought the need of another unit in the European Union (EU) to control drug trafficking called EDU or as known today as EUROPOL.

If Interpol consists mostly of police members, Europol consists also other organisations such as port control authorities and private associations but we shall discuss Europol later on.

According to Bill Tuckman, who is the director of the centre for police and criminal justice studies at the university of Exeter in the Intersec review Vol.6 of March 3rd 1996, he gave a look at commonly accepted organised crime groups. He examined the goals and the relationship they seek with existing businesses, both legal and semi-legal. He mentioned how the MAFIA and similar organisations such as the Yakuza were originally political in intent, but late on turned to crime as a means of obtaining funds to support their political cause. He showed how such people are corrupting port-control officers to achieve their goals. Interpol and Europol have to deal with such organised criminals and so the task of control is becoming more difficult.

Interpol covers all types of criminal activities, but it specialises crime of violence against the person, crimes relating to property, theft works of art, international exploitation of prostitutes, sexual abuse of children, pornography, traffic in human beings and other offences which may have international scopes. Without

the work of Interpol and Europol it would be difficult if not totally impossible to control such crimes.

DRUGS PROBLEM

One of the biggest problems faced by all states is that of DRUGS. They are being the cause of many other serious crimes. Many criminals, especially those of ordinary law crimes such as armed robberies, burglary and fraud are committing such crimes to get money to buy more drugs. Drugs are major killers. Drug addicts who survive may under the influence of narcotics, commit other offences such as violence and vandalism. It can be said that in modern times drug trafficking is one of the biggest roots of criminality. Interpol had to give this problem special attention.

Many Interpol officers are making presentations in the sessions of international meetings. During the last international conference on cross boarder crime and international co-operation in a Euro-Mediterranean perspective, Interpol was presented by Andrew Sandaralingun. He dwelled on the emergence of new trafficking groups such as the Iranian heroin connection, the Yugoslavian heroin network and the Lebanese involvement in heroin trade. In his presentation, he referred to the impact this trafficking had in various European countries, maintaining that the major recipient countries in western Europe are Germany, the Netherlands, Italy, Greece, Spain Belgium, France, the United Kingdom, and the Nordic countries. He explained how co-operation from the member states of Interpol is a must because most of the European countries including Malta are sieged by this problem. (Taken from the published results of the said conference)

Interpol established two working groups in the field of drugs:

- The Intelligence Group
- The Operational Group

The Intelligence Group in those two fields is the most important. Without gathering intelligence, Interpol could never catch the spider which is ruining our world with dangerous webs in which our new generation is getting entangled. This group is meant by officers who are specialised in specific drugs. It also prepares special reports and collects data about the subject. It operates the International Drug Data-bank and co-ordinates all states to get control as much as possible of this problem by furnishing its members with strategic intelligence and by publishing intelligence studies and statistics every two years.

The Operational Group is divided into ten geographic units; six in Europe, one near the Middle East, North Africa, Sub-Saharan Africa and South America. They monitor drug seizures and make assessments on the results. Their main activity is to fight drug trafficking in the regions.

Besides all its activities Interpol insists that all its members must be proactive to prevent crime. It makes various recommendations advising its members to adopt certain methods or structures, designed to implement or improve crime prevention techniques. It emphasises on its members to respect Art.(2) of its constitution to respect human rights in the execution of their duties as police officers. It also insists on giving assistance to police investigators conducting mission abroad.

Interpol makes surveys of the possibilities under immigration acts for refusal of entry to foreign offenders

or their deportation. Interpol also helps in the preparations of the cases of extradition. Besides, Interpol gives information about various extradition laws or acts practised in different states.

INTERPOL FLORIANA (MALTA)
During this collection of information the author interviewed the Assistant Commissioner Mr. Andrew Seychell who is responsible of the Security Service of the Malta Police Force under which section Interpol Floriana (IP Floriana) forms part. He gave his comments on Malta's contributions and achievements from our association with this organisation. He also commented on the history of Interpol. Seychell began with the history of Interpol: Malta joined the organisation in 1972 and has a national central bureau known as Interpol Floriana. At the time being, this office is temporarily transferred to Mosta. At the meantime the building at Floriana has been demolished, and new modern offices are being built. The bureau which forms part of the security branch is staffed by an Assistant Commissioner, a post of Inspector which at the time being this post is vacant and a number of other ranks. The Malta National Bureau is not an operational service, but has a computer link with all police branches and sections. It is equipped with modern communication equipment such as the X400 telex facsimile. This equipment is directly connected with Interpol's central database in France.

Interpol Floriana has access to enquire about wanted or missing persons, local and international criminals, international organised crimes and all other crimes which are dealt by Interpol. A problem encountered with in Malta is that of dealing with crimes such as prevention of money laundering which is governed by the Act of 1994 and the other problem

of telephone tapping. The Maltese executive Police powers on these areas are very limited.

Seychell commented with satisfaction on certain legal powers that are about to be given to the executive Police under the new Malta Police Force Act of 1997, which is currently under discussion by the Maltese Parliament. This Act gives the Police the legal power that may operate on the bases of national legislation, international convention, bilateral and multilateral agreements and other tools. In 1993 Malta joined the fore runner of modern international co-operation (Mutual assistance in criminal matters). Now, it has the ability to issue and execute search warrants and investigations at the request of another country. In 1966, Malta signed the United Nations convention against illicit traffic of drugs. In 1978, Malta legislated the present extradition act with intensive training to police officers in the international fora.

In the meantime, Malta is taking part in the general assembly of the ICPO-Interpol in order to keep abreast of current criminal patterns and resolutions adopted. Mr. Seychell concluded that because of its geographical position, Malta became a milestone of organised crime and crimes with transnational aspects such as drug trafficking and illegal immigration. Although Malta's situation is not so alarming, the Malta Police with the help of Interpol, is taking all the proactive measures to fight international crime as efficiently and effectively as possible.

At the time while doing this brief research, IP Floriana is busy in helping in court procedures to extradite one of the most wanted ex-Moroccan drug baron who was stopped at the Malta International Airport under Interpol directives. He was travelling from Morocco via Malta-Holland. After acquiring a Netherlands

citizenship, he used to traffic drugs between Morocco and the Netherlands.

There is much more to say about Interpol but it is not possible to mention everything in my brief and limited research. Malta has the disadvantage of position we have a potential advantage of helping Interpol in detecting criminals while crossing from Africa to Europe. Up to now, we have studied the mission, the vision and the goals of Interpol. A similar organisation in a smaller scale is doing more or less the same work of Interpol; this is the other purely European organisation known as Europol.

EUROPOL

During the 1970's undoubtedly, Interpol rendered great service to the police of Western Europe and North America as far as the exchange of the information about good people and criminal cases were concerned. (Fernand & Schlanitz 1975; Nepote 1970)

This did not stop Interpol being sharply criticised especially in Germany, Great Britain and Holland police circles. Although its equipment to investigate crime, according to critics, Interpol has seriously failed to make a tactical and strategic analysis of the development of crime. This was plainly expressed in a congress of German CID officers in 1974. They felt that Interpol had to be altered. The EC had to see that the Police Judicial Aid in the form of small frontier traffic, would be generally practised on the boarder-land between the affiliated states. (Harold 1974)

The EU felt that in the light of internationally organised crimes and serious contraventions of its EU regulations, it has to be able to launch investigations in its own right. Interpol reacted for this proposal,

and refused to make any changes. They rejected the regionalisation of Interpol through the formation of an organisation like the proposal of Europol. Why had Interpol not worked harder to be more closely involved in the international development? What about the MAFIA group in Italy in the sphere of weapon trade, and between the terrorist attacks of the IRA and its extortion and its smuggling activities in the boarder area of Northern Ireland?

On the 24th April 1986, in the Hage, the EU members adopted a resolution to look upon organised crime as an issue of European public order. The resolution adopted on that day contained the seed out of which an independent Europol could grow within the European community. Interpol was not taking terrorism seriously, under the excuse of Art.3 of its convention, which prohibited interference with political, military, religious or radical matters.

Terrorism and Drug trafficking were overpowering the European countries and now, Europe had to destroy the monopoly which Interpol had previously held in Western Europe, and introduce its organistions of Europol.

In June 1991, at Luxemhourg, during a summit of the European ministers of Police, it was decided to establish a European drug unit as early as possible. In December 1991, during another meeting in the Netherlands, it was decided that this unit must have a wider scope of tasks; the creation of a union-wide system for exchanging information within a European police office. Differently from Interpol, the members of Europol had to be also members of the European Union.

Interpol members are practically all police officers but the members of

Europol consist mainly of ex-Interpol members, police, customs and boarder services. Whilst Interpol is a world-wide organisation with almost a hundred and eighty countries affiliated, Europol consists only of fifteen members. Interpol is recognised under public international law and has been granted an observer status at the United Nations, while the legal status of Europol is still to come in force.

In order for Europol to become fully operational, all its members must sign the council act of the 26th July 1995. In this operation, there were massive political problems between the member states on the refusal to make changes in its way of operation. Greece, Italy and Belgium still have to meddle with such problems before they finalise the parliamentary procedures. Before legal status is given, Europol has no executive authority.

The advantages of Europol over Interpol is that it includes illicit traffic of radioactive and nuclear substances, crimes related to clandestine immigration, illicit vehicle traffic as well as criminal organisations involved in money laundering. Europol deals also with terrorism.

Interpol is more vast in its work and has its limitations as far a terrorism is concerned. Europol also has its limitations in finances: 18.89 million Euro a year against the £45 million of Interpol. The contributions of the one hundred and eighty members of Interpol are much greater than that of the fifteen members of the EU. So Interpol may spend much more money in research and equipment than Europol can. For the European countries, Interpol is more efficient because of its financial means, but Europol is more effective because of its determination. The problems in the relationship between Europol and Interpol are existent due to the

fact that there is no general consensus among the EU member states on the channel to be used in exchanging information and intelligence. It often happens that the requested states do not respect the choice by the requesting state and follows that alternative channel. Another problem is that Interpol is suggesting a link between its computer systems and that of Europol and Schengen. This is not possible because paragraph 1 of Art. 6 of the Europol convention states that, 'Europol should maintain a computerised system of collected information - with a restricted and precisely defined contents which allows rapid references to the information members of states and Europol. This information must under no circumstances 'be linked to another automated processing system'.

Art.101 of the Schengen convention expressly abolish the possibility of installing a terminal for direct access to S.I.S. data at Interpol's Headquarters. Information can thus circulate simultaneously via three different systems which cannot communicate with each other. This may result in overlapping of inconsistent data. How does the EU wish Interpol to participate in the new forms of police co-operation in Europe? The answer is clouded, and we have wait until any agreement will be reached. For the moment, the two organisations have to be contented within direct links to one another's database. This system for sure is not the ideal one.

Europol at the time being, is processing about six thousand three hundred messages a year against the one million messages processed by Interpol.

RIVALITY EUROPOL VS. INTERPOL

There is some type of rivalry between Europol and Interpol. Most

member of Europol are ex-Interpol members and so carried with them many tactics copied from Interpol. Europol removed the monopoly of Interpol in Western Europe and reduced its importance with the EU members. Most of European information transpass from the Europol centre and so in spite of its financial supremacy Interpol is losing such valuable information. However, in spite of the rivalry, both organisations try to give a different impression to the general public; that they are working together. An optimistic point of view is that to held various meetings and studies in order to avoid duplication of work.

Another advantage of Europol over Interpol is that state members Europol can be in the Interpol organisation as well, but members outside the cannot become members of Europol, thus the EU members are having more information as regards international crimes.

For the time being, Malta is not an EU member, and so it cannot benefit from the service offered by Europol. A possibility that Malta may enter the EU is still there, but the more time passes the more difficulties are raised: between our two main political parties about the question of whether Malta should become a full member of the EU or not.

The operation and output of Interpol and Europol can be evaluated on bases of their effectiveness, that means on the real successful results together with the confidentiality of data. This can be measured also with regards to reaction time between inputs and outputs.

The two organisations do not differ much from each other; they overlap many aspects. Many similarities prevail over the differences between the organisations. They must not give

organised criminals the advantage in finding the two organisations quarrelling about who is the most efficient or effective. Both must use all their energy to equip themselves and help each other. Although Europol is a small organisation, it may serve as a stimulant for Interpol to do its duty better when it knows that there is another organisation, which is smaller in number of members, but who is doing the job very well and is giving positive results in Europe.

CONCLUSION

Malta should not feel inferior to other states just because it geographically smaller in dimensions. As we are doing in the recent case of Moroccan drug barons, we may become a keystone which may tie the arc of boundary against international crime between Africa and Europe. During his message on the occasion of Interpol's 75th Anniversary celebrated on June 1998, the secretary general of Interpol, Raymond E. Kend encouraged all member states 'to ensure that they are using their links Interpol as effectively as possible. Belonging to Interpol means belonging worldwide partnership; and thus brings with it responsibilities as well benefits'.

(Taken from the message of Raymond E. Kendall on the 75th Anniversary of Interpol)

This can be applied for Europol, and above all, also for Interpol Floriana which forms a full member of Interpol's valuable work towards a better and safer world. Above all 'the duty of the executive police is to preserve public order and peace, to prevent and to detect and investigate offences, to collect evidence and to bring the offenders whether principals or accomplices be judicial authorities'. By means of Interpol and Europol we are happy to say we can perform this duty world-wide in

spite of our limitations as efficiently and effectively as any other country in the world.

How To Protect Your Home and Property from Vandals

Vandalism is a growing national problem. Last year this senseless crime cost huge money. Vandalism is a problem that gets to everyone in some form or another. It can affect your family, friends, property, community, and your pocketbook.

WHAT IS VANDALISM?

etc. Older youths often commit more serious acts such as damaging vehicles or machinery, burglary, arson or theft.

WHY DO PEOPLE VANDALIZE?

Although most vandals do not have a clear motive for their acts, studies show that basic social problems and attitudes are at the root of the vandalism. Among the many explanations for the crime are anger against society, boredom, drug and alcohol abuse, disciplinary problems, personal problems and racial/political conflicts.

HOW CAN VANDALISM AFFECT MY FAMILY AND FRIENDS?

- The innocent bystander who is so often a victim of the vandal's activities could easily be you or someone close to you.

- Many young people are readily influenced by their peers. By joining the groups of teenagers who are vandalizing out of boredom or are trying to impress other teenagers, your child could end up with a police record instead of a diploma.

- In 1978, vandalism cost schools in the United States over \$460 million dollars or \$13 per student, today's figures are much, much higher. The cost of your taxes could rise unnecessarily or the quality of your child's education could be lowered as a result of temporary school closings and

equipment shortages.

HOW DOES VANDALISM AFFECT MY COMMUNITY?

- Police, fire and emergency services are affected by the direct damage, increased workloads and false alarms.

- Facilities, such as parks and public rest rooms which everyone in the community uses, become unavailable or dangerous.

- The court system is affected by the strain of time-consuming hearings and trials which jeopardize a defendant's right to a fair and speedy trial.

HOW DOES VANDALISM AFFECT MY POCKET-BOOK?

- Taxes go up when public property has to be repaired or replaced.

- Your insurance may cover damage to your personal property, but rates will increase if vandalism becomes rampant in your neighborhood.

HOW CAN I KEEP VANDALISM FROM GETTING TO ME?

Teach By Example

As parent, you are considered responsible for your child's behavior. Parents can be held financially responsible for acts of vandalism committed by their children. Setting a good example is the best way to influence your children to behave properly.

- Respect the law, plus other people's rights and property.
- Don't offer excuses for lawlessness; don't be indifferent to it.
- Don't break laws, no matter how small (e.g. violating traffic rules).

Protect Your Personal Property

- Keep garage locked.
- Use outdoor lighting.
- Keep shed locked.
- Keep car doors locked.

Report Incidents

- Report suspicious persons or activities near your home or your neighbor's home to your local police.
- Report to authorities if you spot unusual activities at odd hours near your school, church, etc. Work with your local newspaper and radio stations to emphasize the nature and extent of the problem. Encourage them to publish a weekly "destruction list" enu-

merating acts of vandalism and the cost to taxpayers.

- If you are confronted by vandals, cooperate with your local police force to see that they are caught and punished.

Get Involved

- Encourage your family and friends to join anti-vandalism organizations. Join a townwatch in your area, or start one if there isn't one already in your neighborhood. Contact your local police department for information on townwatches in your area. Townwatches are neighbors that meet and plan preventive measures against vandalism and other crimes such as watching each other's property, patrolling the neighborhood, and reporting any suspicious activities.
- Become active in youth programs that provide young people with constructive alternatives to vandalism and enable them to take pride in their neighborhoods instead of destroying them. These include neighborhood beautification programs; community camping trips; basketball teams; or theatrical groups. You can also help develop counseling centers or anti-vandalism campaigns in schools or assist other youth groups such as the Girl Scouts, Boy Scouts, Campfire Girls, Boys Clubs, Big Brothers/Big Sisters or other youth oriented

community service organizations.

Be Aware

Your child will probably be exposed to vandals in his school. Make sure you discourage him from participating in their activities.

- Give your child enough attention. Give plenty of love as well as discipline.
- Encourage his activities, recognize his successes and help him learn from his failures. (Note: Vandalism is not only a problem among young males. Females are just as likely to become vandals. We are using the male pronoun "he", only for the ease of reading.)
- Be aware of who his friends are and know how he spends his time. Give advice when needed.
- If your child begins to develop serious personal problems, i.e., difficulties in relationships, drug or alcohol problems, etc., get professional counseling. It can keep minor problems from becoming major difficulties.

Now you know how vandalism can get to you. Take the time to protect your family, your community and your possessions from vandals. Make crime more trouble than it's worth.

Din l-informazzjoni kienet għaddiet lis-Supretendent t'Għawdex Pawlu Sammut li wara li vverifika din l-informazzjoni, ġiet ikkonfermata li kien hemm katavru fil-bir imsemmi.

Tajjeb wiehed jghid li dan il-Qassis ma kienx l-istess wiehed li kien imsemmi fil-gazzetti, li kien qal li Louis Galea, dakinhar filghaxija li kien gie nieqes, wara l-Quddiesa kien qallu li dakinhar kien sejjer jaqla' somma flus minghand xi hadd f'dik il-lejla u li kien se jsir sinjur.

Min ta l-informazzjoni lis-Sacerdot dwar is-sejba tal-katavru kien jidher li hu ġenwin. Jidher li l-persuna kien

ghaddej minn dawk l-inhawwi. Kien xamm riha hierġa minn dak il-bir u wara li ttawwal, sab li kien hemm katavru ta' persuna mejta. Għaldaqstant, peress li ma xtaqx jidher mal-Pulizija, hu kien ta l-informazzjoni lil Qassis. Il-pulizija fil-fatt taf min hi din il-persuna wkoll.

Minn aktar investigazzjonijiet li saru, il-Pulizija rnexxielha tibni b'mod komplut, il-hin kollu ta' fejn kien Louis Galea f'dik il-lejla tragika. Jirriżulta li fis-6.20 ta' filghaxija Galea kien qiegħed f'Tigrija Palazz fejn hemmhekk ukoll kellu xi kaxxi tal-logħob. Fit-7.50pm kien qiegħed hdejn it-Teatru Astra fejn kienu rawh xi persuni. Imbagħad mar id-dar biex fit-8.30pm reġa kien qiegħed l-Astra fejn reġġhu ikkonfermaw xi persuni li rawh fuq il-post.

Fid-9.20pm kien il-Victoria Hotspurs Football Club waqt li fl-10.30pm reġa' kien id-dar tiegħu, eżatt kif kienet ikkonfermat bintu. Fil-10.45pm kien hemm persuna li qalet li rat il-van tiegħu sejjer minn Marsalforn għar-Rabat waqt li fil-11.30pm kien hemm ohrajn li qalu li kienu rawh miexi minn Pjazza San Frangisk, Victoria lejn in-naha tas-Seminarju fir-Rabat.

Dan hu wiehed mill-każijiet l-aktar makabri u mhux solvuti li għandha f'idejha l-Pulizija. Każ ikrah fejn il-familjari tal-vittma, fosthom martu u wliedu, għadhom sal-gurnata tal-lum jistennaw li jsir haqq mal-persuna jew persuni li wettqu dan id-delitt. Qed nitkellmu fuq persuna li nqatel fl-aqwa ta' hajtu, meta kien għad kellu 41 sena. Halla warajh erbat itfal għadhom żgħar.

L-investigazzjonijiet għadhom miftuhin u l-appell tagħna hu li jekk hemm xi persuni li forsi l-Pulizija għada ma kellmithomx u forsi jafu xi haġa li b'dak li jghidu jistgħu jifgħu dawl fuq dan il-każ, dawn illum jistgħu jċemplu fil-Kwartieri Ġenerali tal-Pulizija fuq 221111 u jistgħu jzommu ruħhom anonimi. Kull informazzjoni tkun mistharra bir-reqqa kollha.

Il-persuna jew persuni responsabbli għal dan id-delitt, jekk jinqabdu, jitressqu l-Qorti u sussegwentament jinstabu hatja, jkun sugġetti għal piena ta' għomor il-habs.

Dan il-każ għadu qed ikun investigat mill-Assistent Kummissarju John Rizzo flimkien ma' l-Ispettur Antonello Grech.

tal-Konvenzjoni għall-Protezzjoni tad-Drittijiet tal-Bniedem u tal-Libertajiet Fundamentali

Mis-Suprefendent A. Casha B.A. (Leg. & Humansr.), Dip. N. P.

Għal dawn l-ahhar tlettax-il sena l-Konvenzjoni għall-Protezzjoni tad-Drittijiet tal-Bniedem u tal-Libertajiet Fundamentali, ffurmat parti integrali mill-korp tal-Ligijiet ta' Malta.

Fl-4 ta' Novembru 1950 (proprju hamsin (50) sena ilu llum u għalhekk l-okkażjoni ta' dan il-forum) din il-Konvenzjoni giet miftuha għall-firem ta' l-Istati membri tal-Kunsill tal-Ewropa. Biex inkompli ftit fuq id-dati, din l-Konvenzjoni dahlet fis-sehh fl-1953 u Malta, bħala Stat Sovran, irratifikat din il-Konvenzjoni fit-23 ta' Jannar, 1967.

Għoxrin sena wara, fl-1987, bis-sahha ta' l-Att XIV ta' dik is-sena, id-drittijiet msemija fil-Konvenzjoni saru esegwibbli bħala parti mil-Ligi ta' Malta - fejn ikun hemm xi ligi ordinarja li tkun inkonsistenti ma' dawn id-drittijiet, id-drittijiet imsemija fil-Konvenzjoni għandhom jipprevalu, u dik il-ligi ordinarja għandha, safejn tkun inkonsistenti, tkun bla effett.¹ Izjed minn hekk, din il-Konvenzjoni dahhlet fis-sehh id-dritt ta' petizzjoni individwali lil makkinarju ta' Strasbourg.

Il-Konvenzjoni Ewropeja tad-Drittijiet tal-Bniedem hija kkunsidrata bħala l-isbah gojjell fil-kuruna tal-Kunsill ta' l-Ewropa. Stati membri godda huma obbligati jiffirmawha appena jsiru membri, u jirratifikawha fi żmien sena.

Wiehed jista' ighid li l-predeċessor dirett ta' din il-Konvenzjoni hi d-Dikjarazzjoni Universali tad-Drittijiet tal-Bniedem tal-1948. Fl-istorja tal-bnedmin insibu precedenti importanti oħra bħall-Magna Carta fl-Ingilterra (1215); id-Dikjarazzjoni ta' l-Indipendenza ta' l-Istati Uniti ta' l-Amerika (1776) u d-Dikjarazzjoni Franciża dwar id-Drittijiet tal-Bniedem u ċ-Ċittadin (1789). Għallkemm illum 'il gurnata meqjusa inadegwati, dawn id-dokumenti huma kkunsidrati bħala stadji importanti fit-triq twila lejn it-tgawdija tad-drittijiet fundamentali tal-bniedem b'mod shih u ugwali għal kulhadd.

Barra minn hekk, il-Konvenzjoni hija l-ewwel impenn tal-Komunita' Intenazzjonali sabiex tipprotegi d-drittijiet fundamentali tal-bniedem li huma ċittadini ta' Stat Sovran. Dan qabel ma kienx possibbli, peress li taht l-ligi internazzjonali sa dak iż-żmien, kull Stat Sovran seta' jitratta ċ-ċittadini tiegħu kif jidhirlu hu, minghajr hadd ma jindahallu.

Il-Konvenzjoni Ewropeja stess tiddikjara li tirrapreżenta l-ewwel infurzar kollettiv ta' xi uħud minn dawk id-drittijiet imsemija fid-Dikjarazzjoni Universali tal-1948. L-Istati membri tal-Kunsill ta' l-Ewropa obligaw lilhom infushom li jggarantixxu lil kull persuna taht il-gurisidizzjoni tagħhom numru ta' drittijiet ċivili, politiċi u libertajiet elenkati fil-Konvenzjoni.

Protokollu suċċessivi, estendew l-elenku originali ta' drittijiet, filwaqt li l-gurisprudenza tal-Qorti Ewropeja tad-Drittijiet tal-Bniedem ikkonsolidat u żviluppat dawn id-drittijiet. Dan juri il-proċess dinamiku w evoluttiv tas-sistema mahluqa bil-Konvenzjoni Ewropeja.

Kważi l-Istati membri kollha tal-Kunsill ta' l-Ewropa inkorporaw il-Konvenzjoni fil-qafas tal-ligijiet domestiċi tagħhom. B'hekk il-gudikatura ta' kull pajjiż setgħet, b'mod aktar seren, tiehu inkonsiderazzjoni l-proċedimenti tal-Konvenzjoni u l-gurisprudenza tal-Qorti Ewropeja tad-Drittijiet tal-Bniedem meta tiddeċiedi xi każ.

Hekk kif jigu eżawriti r-rimedji lokali kollha, l-individwu għandu dritt li jagħmel petizzjoni għal rimedju quddiem il-Qorti Ewropeja fi Strasbourg, Franza. Dan il-makkinarju ta' Strasbourg m'għandux ikun meqjus bħala sostitut għal-Qrati lokali, iżda biss bħala wiehed komplimentarju li jsaħħah aktar d-dritt ta' l-individwu fil-konfront ta' l-Istat.

L-effett ta' din il-Konvenzjoni f'dawn

l-ahhar hamsin sena fil-pajjiżi membri tal-Kunsill ta' l-Ewropa kien wiehed vast u profund u wassal ukoll biex, bl-interpretazzjoni sostantiva tal-Qorti Ewropeja għad-Drittijiet tal-Bniedem, inbidlu xi ligijiet u proċeduri mhaddma fil-pajjiżi membri li kienu nkonsistenti mad-drittijiet imharsa fil-Konvenzjoni.

Per eżempju, fir-Renju Unit gie abolit il-corporal punishment fl-iskejjel tal-Gvern; l-Awstrija emendat b'mod sostanzjali l-kodiċi tal-proċedura kriminali, kif ukoll il-mod kif jigu trattati prigionieri fl-isptarijiet, u s-sistema ta' għajjnuna legali; l-Isvezja emendat il-ligi tagħha dwar it-tagħlim obligatorju tar-religjon; u l-Olanda emendat il-ligi tagħha dwar id-detenzjoni ta' pazienti b'mard mentali.

Is-sistema ġuridikata Maltija ukoll hasset dan l-effett. Wiehed biżżejjed isemmi il-każijiet riċenti ta' Aquilina u T.W. dwar il-proċedura użata fl-ghoti tal-liberta proviżorja f'ċertu każijiet. In fatti fl-emendi għall-Kodiċi Kriminali hemm il-hsieb li jsiru xi tibdiliet opportuni biex il-ligi tagħna fil-kamp penali tiġi aktar konformi mal-Konvenzjoni Ewropeja.

Il-magħor parti tad-drittijiet fundamentali li wiehed isib fil-Konvenzjoni Ewropeja jsibhom imnaqqxin ukoll fil-Kostituzzjoni ta' Malta taht xi forma jew oħra. Jidher li hemm xi differenzi - iżda dawn id-differenzi huma aktar apparenti fil-forma milli fis-sustanza.

Wiehed mid-drittijiet li nsibu fil-Kostituzzjoni, l-artikolu 39, jitratta dwar disposizzjonijiet biex tiġi żgurata l-protezzjoni tal-ligi lill-individwu. Dan l-artikolu tal-Kostituzzjoni jikkorrespondi bejn wiehed u iehor ma' l-artikolu 6 tal-Konvenzjoni. F'dawn iż-żewġ artikoli wiehed isib disposizzjonijiet dwar smiegh xieraq fi żmien raġonevoli minn qorti indipendenti w imparzjali mwaqqfa bil-ligi. Dritt kardinali iehor imsemmi f'dawn l-artikoli hu li "Kull min jiġi akkużat b'reat kriminali għandu jiġi meqjus li hu innoċenti sakemm jiġi ppruvat jew ikun wiegħeb li huwa hati."

Wiehed isib ukoll kriterji minimi li kull min ikun akkużat b'reat kriminali ghandu jkollu, fosthom li ghandu jithalla jiddefendi ruhu personalment jew permezz ta' rappreżentant legali.

Kif probabbli smajtu, l-emendi għall-Kodiċi Kriminali se jinkludu dan id-dritt ta' l-individwu anke waqt il-perjodu ta' l-arrest. Dan għall-pulizija ġab miegħu ċertu apprensioni. Pero' wiehed irid jara l-introduzzjoni ta' dan id-dritt flimkien ma' emendi oħra imhabbra fil-liġi, bħal dik tar-*Rule of Inference*. F'dawn iż-żewġ kelmiet xtaqt naqsam magħhom xi hsibijiet fuq dan id-dritt għall-avukat waqt il-perjodu ta' l-arrest.

Dritt għall-assistenza legali waqt l-arrest investigattiv

Nibda biex nġid li d-dritt għall-assistenza legali matul il-perjodu ta' l-arrest investigattiv ilu jeżisti f'numru konsiderevoli ta' pajjiżi u Malta ma setgħetx tkompli għegbed u ttawwal biex dan id-dritt ma jidholx ukoll fis-sistema ġuridika penali tagħna.

Infatti, sa mill-1992 *il-Kummissjoni Ewropeja dwar il-Prevenzjoni mit-Tortura (CPT)* f'rapport² li għamlet wara żjara f'pajjiżna bejn l-1 u id-9 ta' Lulju 1990, kienet irrakkomandat lill-awtoritajiet Maltin li, b'effett immedjat, persuni miżmuma taht il-kustodja tal-Pulizija jkollhom id-dritt li ta' l-anqas jikkomunikaw bit-telefon ma' avukat, kif ukoll sabiex jiġu identifikati dawk iċ-ċirkostanzi fejn dan id-dritt seta' jiġi temporanjament miċhuda.

Id-delegazzjoni tac-CPT qalet li ma kienx aċċettabbli li persuna kienet qed tiġi miċhuda mid-dritt ta' assistenza legali għal 48 siegħa shah; fakkret ukoll li d-dritt ta' assistenza legali lil persuna waqt il-perjodu ta' l-arrest kien mod ta' protezzjoni kontra l-mohqrija jew trattament hażin.

Issa tgħiduli li skond il-liġi dan id-dritt ta' assistenza legali jeżisti biss minn dak il-mument li persuna tkun akkużata b'reat kriminali. Il-Qorti Ewropeja tad-Drittijiet tal-Bniedem f'numru ta' deċiżjoniet bħal *Huber Case* (1975), *De Weer Case* (1980) u *l-Erkle Case*

(1987) irriteniet illi l-Qorti tippreferi kuncett u interpretazzjoni aktar sostanttiva milli formalistika ta' "persuna akkużata".

Il-Qrati tagħna jidher li jaqblu ma' din l-interpretazzjoni wiesgħa tal-kelma 'akkużat' li l-mument minn meta jidhlu fis-sehħ ċertu drittijiet fundamentali li hemm fil-Kostituzzjoni u l-Konvenzjoni għal smiegh xieraq u gust jista' jkun qabel ma persuna titressaq formalment il-Qorti - jiġifieri meta ċ-ċittadin jirrejalizza illi s-suspett fir-rigward tiegħu kien qed ikun sostenut b'mod li jista' jwassal għall-akkuża fir-rigward tiegħu.³

Pero' dan mhux kriterju ċar biżżejjed. U għalhekk il-Qorti Kostituzzjonali f'appell minn din id-deċiżjoni qalet li għanda tiġi preċiżata l-linja, li meta tinqabeż, dik il-persuna, minn dak il-mument, għandha titqies li hija assoġġettata għall-proċeduri Kriminali u, li minn dak il-mument, għandu jkollha l-garanziji li tikkontempla l-Kostituzzjoni.

Għalhekk xi elementi essenzjali għal smiegh xieraq u gust għal persuna akkużata b'reat kriminali - bħal dak ta' assistenza minn avukat ta' l-għażla tiegħu - ġew estiżi għall-perjodu ta' qabel ma persuna tiġi formalment mimlija quddiem tribunal indipendenti w imparzjali, mwaqqaf b'liġi. Speċjalment u b'mod partikolari f'dawk iċ-ċirkostanzi fejn in-nuqqas ta' dan id-dritt fl-istadju inizjali ta' l-investigazzjoni jistgħu jkollhom riperkussjonijiet fl-intier tal-proċeduri kontra l-akkużat.⁴ (*Imbrioscia vs Switzerland* (1993)).

F'dawn iċ-ċirkostanzi il-kuncett, anzi d-dritt, għal smiegh xieraq u gust li nsibu fl-artikolu 6 tal-Konvenzjoni u l-artikolu 39 tal-Kostituzzjoni ta' Malta, normalment jirrikjedi, illi l-akkużat sa mill-bidu ta' l-interrogazzjoni tal-pulizija jingħata l-benefiċċju li jikkonsulta ma' avukat, nonostante li dan id-dritt (ta' avukat waqt l-investigazzjoni tal-pulizija) mhux espressament miktub fil-Konvenzjoni Ewropeja u lanqas fil-Kostituzzjoni tagħna.

Jista' jkun hemm restrizzjonijiet fl-

applikazzjoni ta' dan id-dritt għal raġunijiet tajba - sakemm dawn ikunu in konformi mal-liġi, indirizzati lejn għan legittimu u li dawn il-limitazzjonijiet ikunu mhux iżjed minn dak mehtiegħ biex jinkiseb dak il-għan legittimu.⁵

Sabiex jiġi determinat jekk l-akkużat ġiex imċahhad minn smiegh xieraq u gust, dawn il-limitazzjonijiet għandhom jiġu eżaminati fid-dawl tal-proċess kollu kontra l-akkużat. Pero' din n-negazzjoni ta' dritt għall-avukat ma tistax tkun assoluta - tista' tiġi ristretta, iżda mhux mċahhada għal kollox, speċjalment fil-każijiet fejn dak li jgħid, jew li ma jgħidx l-arrestat, jista' jkollu konsegwenzi ulterjuri fid-difiża tiegħu. (*Murray vs United Kingdom* (1996))

Wiehed għad irid jara ukoll kif il-Qorti Kostituzzjonali tagħna se tikkonsidra dan kollu fid-dawl ta' drittijiet speċifiċi kemm fil-Kostituzzjoni w anke fil-Kodiċi Kriminali bħall-presunzjoni ta' l-innoċenza u d-dritt li persuna ma tinkrimina lilha nifisha fi proċeduri għar-reat kriminali.

Nemmen li għandu jinstab bilanċ bejn id-drittijiet ta' l-individwu li jkun sugġett għal proċeduri kriminali kontra tiegħu, u d-dritt tas-soċjeta' li tiproteġi lilha nfisha kontra atti kriminużi li jkunu ta' detriment għas-soċjeta' kollha.

Fl-opinjoni umli tiegħi, meta persuna arrestata mill-pulizija tagħzel, wara li tkun ikkonsultat mal-avukat tagħha, li teżercita d-dritt għas-silenzju, jkun legittimu għall-gudikant li jasal għal dawk il-konkluzjonijiet li jidhirlu xierqa iċ-ċirkostanzi, speċjalment meta dawk iċ-ċirkostanzi jkunu korroborati b'fatti oħra li l-akkużat ma jagħtix kont tagħhom.

Fis-sistema tagħna, l-imputat m'huwiex obligat illi jixhed, anzi għandu d-dritt ta' skiet. L-unika riserva illi hemm fil-liġi tagħna s'issa, hi li s-skiet tiegħu ma jistax jsir monopolju minnu mill-Prosekuzzjoni.

Pero' dan ma jimpedix lill-Qorti tikkumenta fuq in-nuqqas ta' deposizzjoni da parti ta' l-imputat f'ċertu ċirkostanzi fejn kontra l-imputat jkun

L-oneru tal-prova ma jgix necessarjament spustat fuq l-imputat, anzi jista' jinghad illi f'kazijiet rarissimi biss hemm dan l-ispustament ta' l-oneru tal-prova.

Pero is-skieta ta' l-imputat f'hafna cirkostanzi, jista' jservi biex il-Qorti tkun sprovista minn dik l-ispjegazzjoni li talvolta tkun assolutament necessarja biex il-versjoni ta' l-imputat tkun tista' b'xi mod issib konfort. (il-Pulizija vs. Mark Aquilina et - Qorti ta' l-Appell Kriminali - 1993)

Kif se jigi applikat dan id-dritt?

Il-Pulizija f'Malta trid ta'cetta l-fatt li llum jew ghada d-dritt ghal avukat waqt il-perjodu investigattiv irid jidhol fis-sistema penali taghha.

In fatti dan id-dritt jezisti fid-diversi Stati Membri tal-Kunsill ta' l-Ewropa. Uhud minnhom gha'zlu li jaghtu dan id-dritt ta' l-avukat ghal waqt il-perjodu kollu ta' l-interrogazzjoni; ohrain gha'zlu li dan id-dritt jidhol fis-sehh wara certu numru ta' sighat. L-importanti hu li meta wiehed jezamina l-proccess kriminali fil-konfront ta' l-individwu, dan ikun inghata smiegħ xieraq sa mill-bidu ta' l-investigazzjoni tal-Pulizija kontra tieghu.

Il-Qorti Ewropeja fil-kaz *Quaranta* qalet li l-Konvenzjoni Ewropeja "leaves to the Contracting States the choice of the means of ensuring that it (the right to legal assistance) is secured in their judicial systems, the Court's task being only to ascertain whether the method they have chosen is consistent with the requirements of a fair trial". Izda l-istess Qorti qalet ukoll illi "the Convention is designed to 'guarantee not rights that are theoretical or illusory but rights that are practical and effective.'" "Meta avukat jinduna li xi inkarigu jista' jgib mieghu ksur ta' ligi jew tal-Kodiċi ta' l-Etika, huwa ma għandux jaċċettah, jew jekk ikun diga' aċċettah, għandu jieqaf milli jkompli jespletah, dana dejjem jekk ma jkunx possibbli li l-klijent jimmodifika l-inkarigu biex ma jdaħħalx l-avukat f'xi ksur ta' ligi jew il-Kodiċi ta' l-Etika."⁶

Wiehed irid jezamina jekk il-konsekwenzi hal ksur ta' dan ir-regolament humiex biżżejjed biex jiskoraġġixx mgieba li tista' tintralea il-kors tal-gustizzja.

Marbut ukoll ma' dan id-dritt għall-avukat waqt il-perjodu ta' l-arrest, nittama li l-emendi jipprovdu ukoll għal sistema ta' assistenza legali (legal aid) għal dawk il-persuni barranin jew persuni li ma jkollhomx avukat partikolari. Ir-rwol tal-pulizija f'pajjiż demokratiku, jgħifieri t-tharis u l-infurzar tal-ligi b'rispett u protezzjoni tad-drittijiet Fundamentali tal-bniedem, huwa diffiċli u jesigi hafna. Izda jekk dan ir-rwol jigi eżerċitat b'mod xieraq u skond il-ligi, dan mhux biss jgħin biex jitjieb is-sens ta' gustizzja f'pajjiżna, imma jtejjeb ukoll ir-reputazzjoni tal-Korp u r-rispett lejn il-Pulizija.

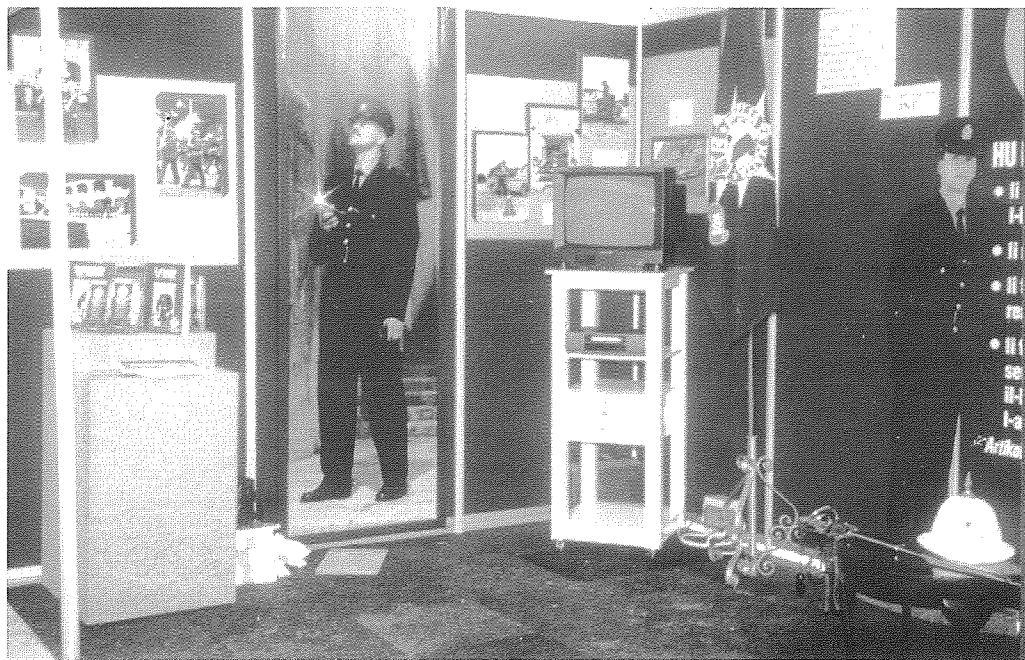

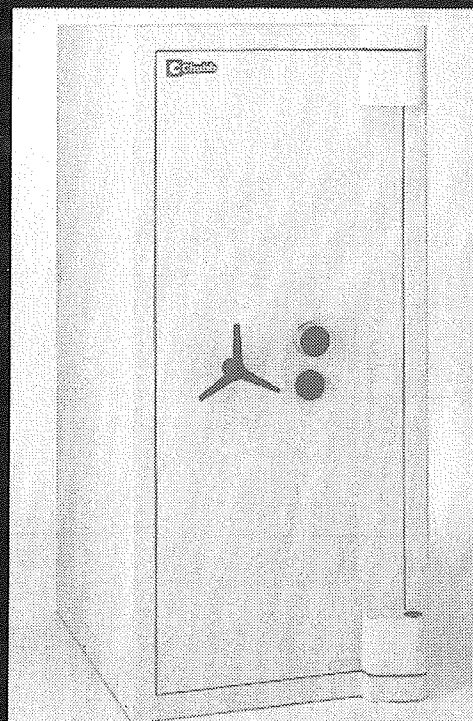

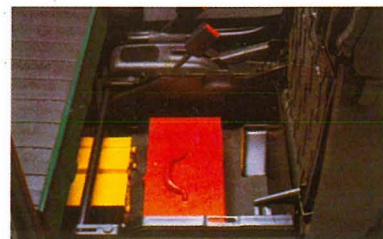

CASE OMBUDSMAN NOTES

Case No. 2586

COMMISSIONER OF POLICE

REFUND OF TOWING CONTRAVENTION FINE

A person claimed that his car had been unjustly towed away by the Police when it was parked under a Bus Stop which was not in the normal bus route, and therefore, was not yet in use. After obtaining confirmation in writing from the Local Council concerned that the bus stop was not in use, complainant wrote to the Police demanding a refund of the LM45 he paid to retrieve his car. This was refused, and it was suggested to him that if he had any objection, he should consult a lawyer with a view to seeking redress in court.

From the Ombudsman's investigation it resulted that the Local Council of the locality concerned and the Public Transport Authority, had reached an agreement to effect some changes in the bus-route of that locality. It was planned that the bus would start passing from a new street, however before this could be authorized the council had to perform certain works. These works did not materialize, so the bus route was never changed. However, in the mean time, the Public Transport Authority had installed the new bus-stop sign. The Authority claimed that the sign was originally covered; however it was possible that vandals later removed the covering material.

According to Legal Notice 94 of 1997, the Police may tow a car which is parked in a marked towing zone, or if it is parked in such a way that it is obstructing or slowing the normal flow of traffic. The point at issue in this case was whether the Police acted correctly by towing complainant's car from under a bus stop placed in a street through which buses never passed. The Legal Notice does not specify whether a bus stop represents a towing zone. However it is reasonable to consider parking on a bus stop an obstacle to traffic-flow. The difference in this case was the fact that the bus stop involved has never been in use, and the sign was in fact covered when originally installed. The Ombudsman pointed out, that it is the duty of every law-enforcing official to make sure that the law has in fact been

broken where he is authorizing sanctions. Since in this case, the constable was probably unaware that the bus stop was not in use, he did not abuse his authority by ordering the towing of complainant's car. However, the fact remained that the car was not an obstacle to traffic and therefore it should never have been towed. The Ombudsman felt that the suggestion made by the Police to complainant, to seek redress in court was not practical. Even if complainant won the case most probably he would have ended up worse off financially.

In view of the above facts, the Ombudsman concluded that complainant's car should not have been towed and therefore recommended refund of the Lm45 towing fine to complainant.

Case No 2879

COMMISSIONER OF POLICE

ALLEGED UNLAWFUL TOWING

A person alleged that his car was unjustly towed away when it was not parked in a towing zone or on any clearly visible double yellow lines. He further alleged that the car was not causing obstruction. He sought refund from the Police Department for unlawful towing but to no avail.

In October 1998 complainant parked his car at Old Bakery Street about 1.5 metres from the corner with St John Street Valletta. When he returned he did not find his car and on enquiring at the Police Station he realised that his car had been towed away. Parking in Old Bakery Street is on the right of the street as the traffic flows, and traffic can turn to the right and go up the sloping St John Street.

The official version from the Police Department regarding the incident was that the car was parked less than five metres from the corner and "being within the regulatory five (5) metres limit", was towed away. The 5 metre limit is imposed by Reg 70 of the Motor Vehicles Regulations. The power of the Police to tow and remove an illegally parked car are laid down in LN 94 of 1997 Traffic Regulations (Clamping and Removal of Encumbering Objects) Regulation 1997. Regulation 3 thereof states as follow - "The Commissioner may remove, store and

dispose of any encumbering object which is causing inconvenience, or obstruction and is in a place or space which is not lawfully permitted to be used for such purpose, or if such place or space is specifically indicated as a towing zone".

This means that for a vehicle to be towed, certain requisites have to be fulfilled:

(a) the place or space is specifically indicated as a towing zone; or

(b) the car is encumbering and causing a nuisance, inconvenience or obstruction and the vehicle is parked in a place where parking is not allowed.

There is no doubt that complainant was parked in a place where parking is prohibited, in contravention of Reg 70 of the Motor Vehicles Regulations. There was however no indication that the place is a towing zone.

The definition of a "towing zone" given in the pertinent regulations is "any such place or area as may be indicated by notice by the Commissioner and by means of signs and markings in terms of the provisions of the Traffic Signs and Carriageway Markings Regulations, 1969, where the prohibited parking of vehicles is subject tothe towing away of such vehicles from such zone...."

By means of Press Release No. 1316 issued on 4 July 1997 the Commissioner of Police notified that apart from the places indicated as towing zone by the regulatory signs, an encumbering object may be removed if it consists of parking at a corner.

The exact wording of the press release is:

"Il-pubbliku huwa avżat illi barra dawk il-postijiet indikati b'tabelli bhala postijiet ta' rmonk kwalunkwe oġġett ta' ngombru jista' jitnehha wkoll f'dawn iċ-ċirkostanzi - Ipparkjar f'kantunieri."

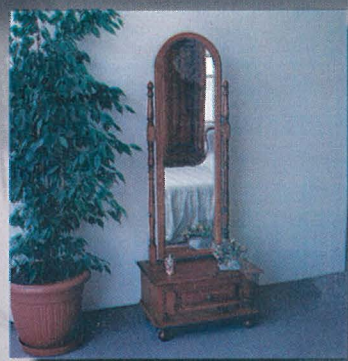
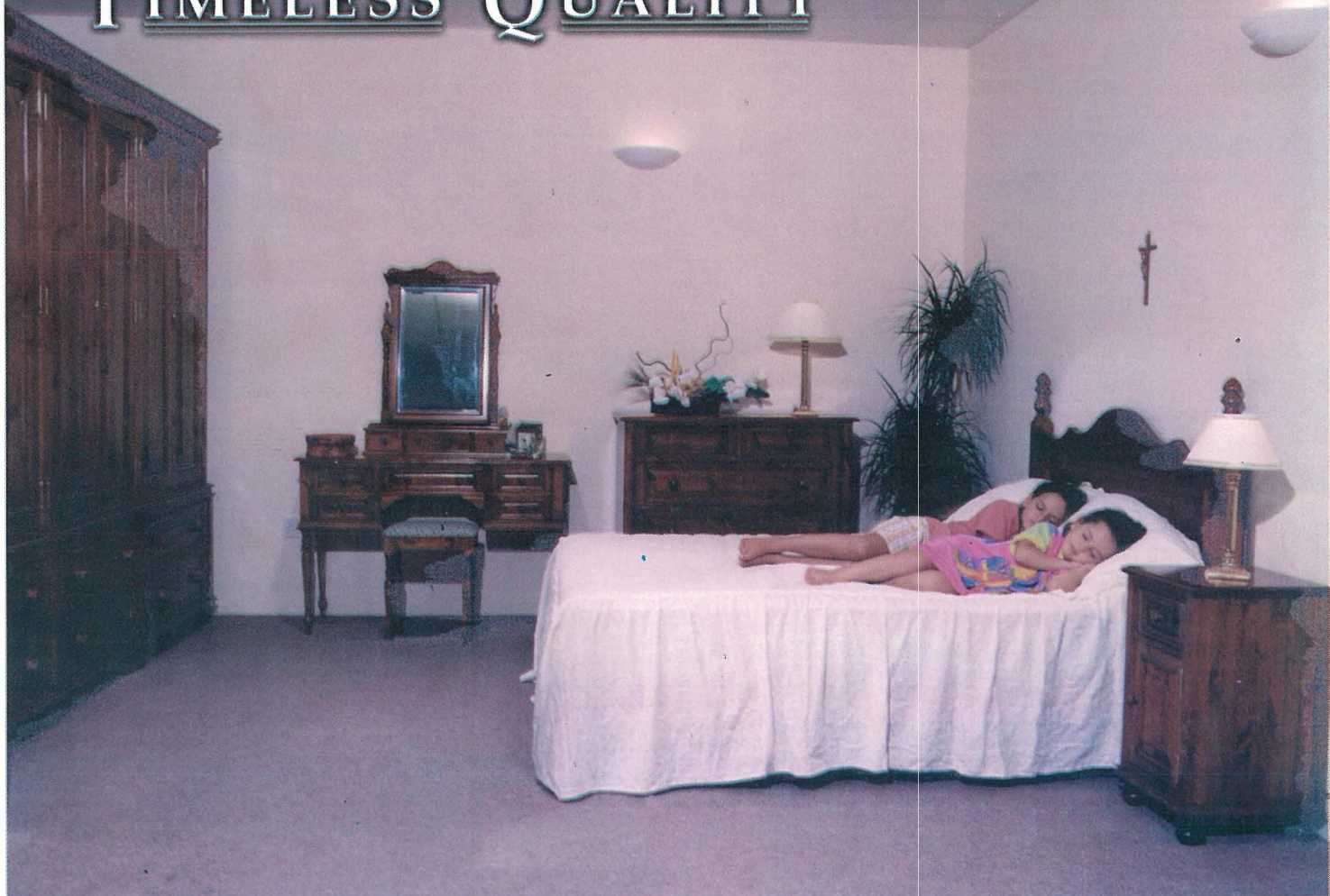
In the light of the above consideration the Ombudsman concluded that the Police acted according to law in towing complainant's car and, therefore, the complaint was not upheld.
