CRIME DETECTION

This takes you behind the scenes where crime and its opposing peace officers have come to grips in a battle for mastery. When you have carefully read this article you will have a good picture of the important part the trained man of today plays in this combat.

You will see that it is not the "higher education" which determines the ability of the detective, but ordinary common sense and a knowledge of the simple yet scientific processes with which the crime detector works.

Modern times have seen a new spirit come over the peace agencies engaged in the war on crime. This spirit rose with the

entrance of Finger Print science into the battle. Today Finger Prints take the lead, for they deal with exact facts. Many a case that ordinarily might have fallen down, in spite of a mountain of circumstantial evidence, today triumphs because some young man, trained for the purpose, finds a single piece of absolute proof.

The science of criminal identification is still growing up Year by year it moves forward on an ever widening front, with new technique; new inventions, more exact processes.

In America the public is at last awakening to the many advantages of civilian registration by finger prints. The opportunities for students are excellent. Should our government suddenly decide to finger print all citizens, at the present time there would not be, it is fair to say, nearly enough trained experts to do this

job thoroughly.

Today, with crime organized on a vast scale, the law finds it necessary to call on all the trained scientific help it can get hold of. The mystic days of the supersleuth may be gone, but romance and adventure still live in this profession—excitement still thrills—for the trained man of today finds his work as varied, as stimulating as ever did a Sherlock Holmes—his discoveries as animated and stirring.

When you have read these pages and learned how science does its crime work; when you have felt the thrill and excitement of real crime mysteries solved, you will begin to understand why a man of ordinary common sense, plus the desire to succeed, can make his mark and win his rewards by training for Crime Detection.

HOW THE INVESTIGATOR OPERATES

Crime detection today leans heavily on scientific methods for clues and disclosures. The trained detective of this era approaches his crime problems with a full realization of how skilfully science can serve him. He acts accordingly.

Let's take a trip with one of these able men at work. Let us imagine we are accompanying him on a case—say a store burglary. The first thing the investigation man does when he reaches the store is to order that nothing be touched. Next, he has the store closed, if it is practicable to do so, and keeps everyone out except the owner and the proper police officials. He cautions these, too, not to touch anything.

Then he seeks to determine how the thief gained entrance to the store. Did he open a window or door, or did he cut part of the glass from a window pane and then reach in and unlock the window, or did he possess a key? A very careful investigation of how the thief gained entrance to the store may reveal whether it was an inside job or not.

If the thief forced a window, door or skylight, or if he cut out part of a pane of glass, nine times out of ten there will be plenty of finger prints. The operative searches for them all over the door or window frame, all over the glass and all over the

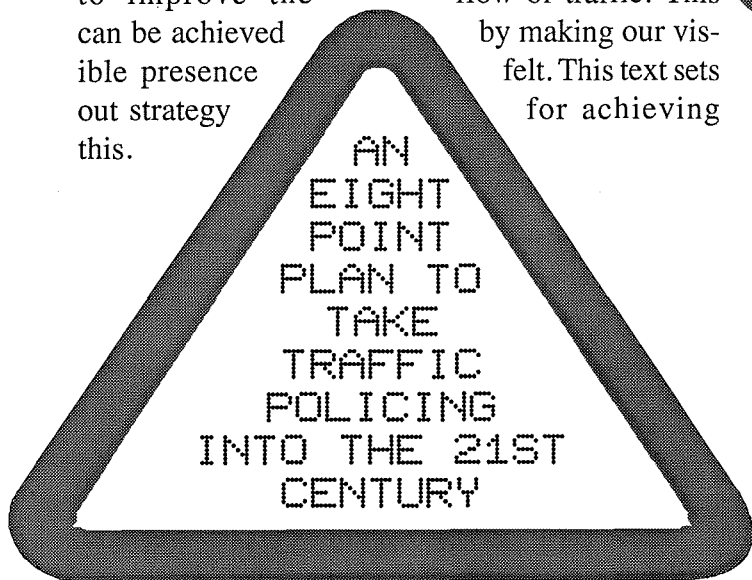

THE ROAD AHEAD

Every year on the roads of Malta several people are injured or die as a consequence of traffic accidents. The aim of the traffic Police is to make the roads safer for all; to instill discipline and education and; to improve the flow of traffic. This can be achieved by making our visible presence felt. This text sets out strategy for achieving this.

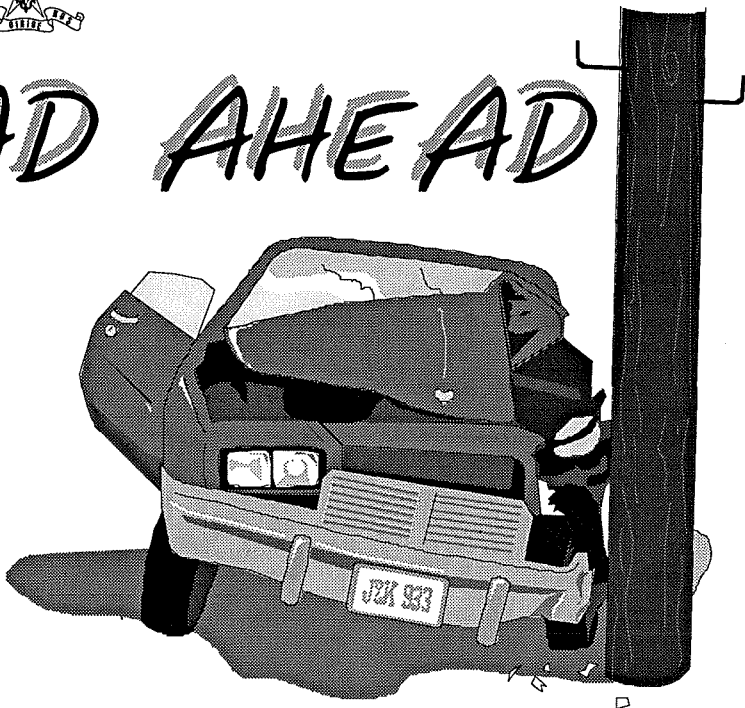


In partnership with the public and other agencies we will work together to;

1. ENHANCE ROAD SAFETY.
2. PROVIDE A RAPID RESPONSE TO EMERGENCIES.
3. RESPOND SENSITIVELY TO VICTIMS.
4. TACKLE INCONSIDERATE ROAD USERS.
5. TARGET MOBILE CRIMINALS AND CRIME.
6. IMPROVE THE FLOW OF TRAFFIC.
7. REDUCE THE NUMBER OF FATALITIES.
8. REDUCE THE NUMBER OF TRAFFIC ACCIDENTS.

ENHANCE ROAD SAFETY

- Forging partnerships with local authorities and other organizations, educating the public, identifying engineering problems and enforcing traffic laws.
- Introducing traffic calming measures.
- Introduce the use of camera and other technologies.
- Supporting national, regional and local



road safety initiatives.

- Enhancing the specialist training of our officers.
- Making the best use of Traffic Police to promote a partnership approach to road safety with the community.

PROVIDE A RAPID RESPONSE TO EMERGENCIES BY;

- Assigning the nearest appropriate officer to urgent calls regardless of police divisional boundary.
- Providing trained traffic officers to meet the needs.
- Using technology to improve communications with patrolling officers.

RESPOND SENSITIVELY TO VICTIMS BY;

- Providing support to victims and families of those involved in serious accidents or road deaths.
- Making appropriate referrals to victim support and other caring agencies.
- Improving the supply of information by Police through personal contacts and dedicated Victim Liaison Officers.

TACKLE INCONSIDERATE ROAD USERS BY;

- Assisting local beat officers to solve traffic problems with their communities and local



authorities.

- Providing speed detection devices.
- Continuing close liaison with the Traffic Control Board and other authorities.
- Deterring offenders through education programs and appropriate prosecution.

TARGET MOBILE CRIMINALS AND CRIME BY;

- Using traffic officers to spearhead action against all types of vehicle crime.
- Providing quality information to enable traffic officers to focus more effectively on current crime.
- Placing greater emphasis on gathering crime related information.
- Paying special attention to known active criminals.

IMPROVE THE FLOW OF TRAFFIC BY;

- Building more bypasses to avoid a heavy load of traffic from town centres.
- Introducing more pelican lights where pedestrian crossings are used frequently.

- Demolishing all roundabouts and introduce new traffic arrangements.
- Refreshing all road markings.
- Banning horse riding from roads.

REDUCE THE NUMBER OF FATALITIES BY;

- Showing a number of educational slots on all television stations before every news.
- To promote good driving on all news papers.
- To revise driving test.
- To detail more Police officers on the road.

REDUCE THE NUMBER OF TRAFFIC ACCIDENTS BY;

- Upgrading all road surfaces.

The effectiveness of the above strategy will be measured through a continuous monitoring process including public attitude surveys.

walls within close proximity of the door or window. In case he finds prints, he takes extra precautions to see that they are not disturbed. He gets permission to remove the door or window which contains the prints, to take them to his office. In case he cannot do this, he photographs them. But he is sure to have a witness with him when he does this, so when he gets his man in court, the witness can swear that the prints were photographed in the store and at the point where the thief broke in. (Judges, defence lawyers and juries are particular on all these little detail. However, the student of this profession is thoroughly taught all such points so that when he has a case he knows exactly how to handle it.)

In case he finds no prints where the thief broke in, or in case he cannot find where he broke in, he goes to the safe, cash register, show cases, cash box and everywhere else the thief may have been. He

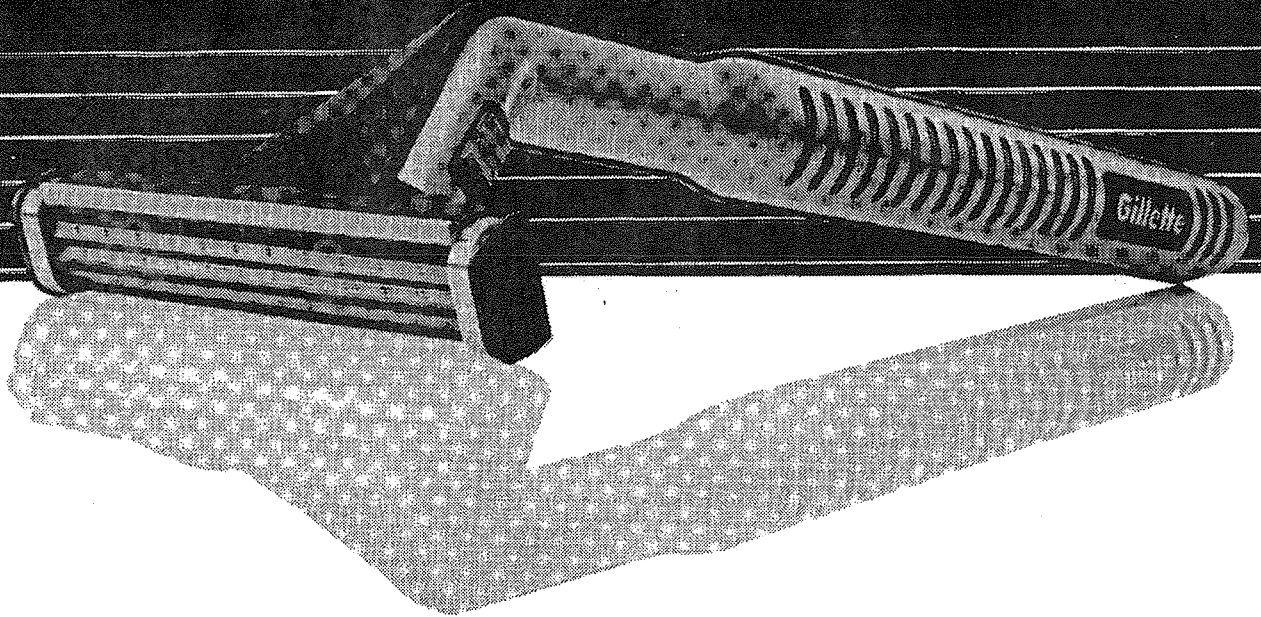
will almost certainly find prints in these places, usually dozen of them.

The next step after removing the articles which contain the prints or having prints photographed, is to finger print every person who has been in and about the store since the burglary, including the proprietor, all employees, and all detectives and police officials. This is absolutely necessary and may cause a great deal of trouble later on if not followed,

I remember a case of burglary where the thief stole over Lm30,000 worth of diamonds from a gold jewel case. The detective found wonderful thumb and index finger prints on the lid and side of the case. After spending considerable time and trouble searching the police files, he accidentally found the prints belong to a police officer, who had handled the jewel case before the detective was called in. The detective neglected to finger print his chief, although he knew he had been in the house.

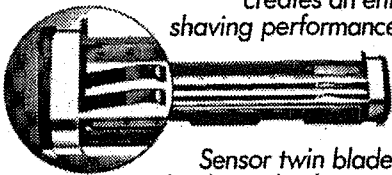

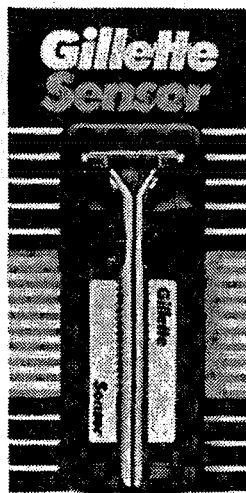

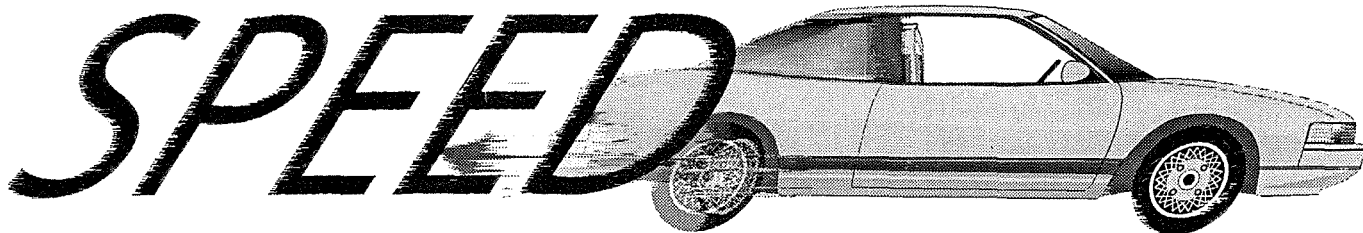

COULD YOU STOP IN TIME?

The two most common causes of road accidents are drivers travelling too fast and misjudging speed and distance. Most people would agree with the Highway Code's advice to 'Leave enough space between you and the vehicle in front so that you can pull up safely if it slows down or stops suddenly'. Few drivers actually put this into practice judging by the many shunts that occur and the practice of 'tailgating' on main roads. The shortest stopping distance and any speed is a combination of thinking distance (i.e. reaction time x speed) plus braking distance.

STOPPING DISTANCE DEPENDS ON

- How fast you are going.
- Whether you are travelling on the level, uphill or downhill.
- The weather and state of the road.
- Your driving ability and reaction time.

Many people drive much too close to the vehicle in front or too fast for the road and traffic conditions. This is probably because they think they can pull up in a shorter distance than they really can. This in turn is often because they cannot judge distances properly.

It is all very well to be able to recite a table of stopping distances, but imagine the result if what you think is forty (40) meters is actually twenty seven (27) meters.

On the open road try to keep a gap of two (2) seconds between you and the vehicle in front. As the vehicle in front passes a fixed object e.g. a traffic sign or an electricity pole) start saying slowly 'Only a fool breaks the two second rule' .:If you pass the same object before you

finish the saying, you're too close. This should give you adequate time to react in good conditions. Double the gap in bad weather by saying the phrase twice.

TOO CLOSE FOR COMFORT

If you have to take panic action because you have insufficient room to act smoothly, you are either going too fast or driving too close to the vehicle in front.

If you are following a vehicle closer than your thinking distance you will hit it if it stops suddenly. When its brake lights come on - it's already stopping while you travel your thinking distance before your foot reaches the brake pedal.

GIVE YOURSELF A CHANCE

- Choose the right speed for the conditions and road layout - that is slow enough to be able to stop within the distance you can see to be clear ahead.

TWICE THE SPEED MEANS FOUR TIMES THE STOPPING DISTANCE.

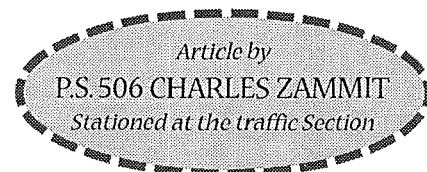
- Always make allowance for variations in the road surface, the effect of weather conditions and the possible sudden appearance of other vehicles and pedestrians - especially children.

SPEED CAN KILL

- Check your vehicle regularly and have it serviced according to the manufacturer's instructions. Ensure the brakes are efficient, the tyre pressure are correct and the tread has more than the legal minimum depth.

WORN TYRES ARE LETHAL

- Make sure you are fit to be at the wheel. If you are tired or unwell avoid driving if you can. If you are taking medicines - check the label for warnings about their effect on driving or ask your



general practitioner. Have your eyesight tested at least every two (2) years; even if you think your eyes are all right, changes in vision can be gradual and you may not be aware of them.

SEE WELL FOR SAFETY

Alcohol reduces co-ordination, lengthens reaction time and impairs judgement of speed and distance.

Ex-P.S. 464 Carmelo Buhagiar jirrakkonta dak li għadda minnu fil-Cottonera u żmien il-Gwerra.

Rappreżentanza mill-Kunsill tal-Għaqda komposta mill-Viċi-President Vincent P.Zahra, mis-Segretarju għal-Finanzi Louis Vella, u l-Membru Joseph M.Spiteri kellhom laqgħa mall-Ex-P.S.Carmelo Buhagiar, dan beda biex qal li dahal fil-Korp fil-25 ta' Ottobru 1930. Hu twieled il-Birgu fit-30 ta' Ottobru 1910, il-bidu tiegħu fil-Korp beda meta billi fl-1929 kien inkiteb biex jidhol fil-Korp, għal hekk kienu jibgħatu għal xi uħud minn dawn meta jkollom bżonn bhala Riserva, dawn l-aktar li kien ikollom bżonnhom kien ikun meta tkun ġejja xi Elezzjoni Ġenerali, kienu jkunu pajżana, biss kienu jilbsu Armlet irrigata bajda u blu fuq il-komma tal-ġlekk fuq ix-xellug. F'dan iż-żmien l-Uffiċċju Ġenerali tal-Pulizija kien fi Triq il-Merkanti l-isfel il-Belt Valletta quddiem fejn għad hemm il-Kamerata. Wara li kienet tghaddi l-Elezzjoni kienu jibgħatuhom. Fil-25 ta' Ottobru 1930 bagħtu għalih biex jidhol fil-Korp. Kif beda kien għamel perjodu ta' tahrig ta' drill mill-Maġġur Busuttill, li kien isir taħt id-Depot, tidhol minn Triq Bjar Qodma hdejn il-Kavallerija għal erbgha sigħat kuljum. Kienu jgħamlu tahrig tal-First Aid u Life Saving, l-Maġġur Johnson kien johodhom jagħmlu tahrig fil-bahar l-Rinella.

Dwar duty fuq il-beat kienu johorġu erbgha sigħat ma Pulizija iehor Strada Stretta fejn kien ikun hemm numru kbir ta' bahrin u suldati u l-inkwiet meta

kienu jkunu xurbana ma kienu jonqos.

Darba waqt li kont qed nghamel id-drill ġie s-Supretendent Leone Enriques u qal lill-Maġġur Busuttill biex jibgħatni stazzjonat il-Birgu fejn kien incharge hu, dan kien fis-sena 1931.

L-Għassa tal-Birgu kienet Couvre Porte fejn kienet ukoll bhala Uffiċċju Prinċipali tal-Lvant.

Bdejt nghamel għassa fuq il-beat li kellna, x-Xatt fejn kien hemm il-Laneċ u d-dghajjes, l-Pjazza, u l-Għassa mat-Telefon. Strada Britannia kien jgħarma s-Suq fejn kien jbiegħu kollox.

Il-Birgu kien ikun hemm dak li jbexxex it-Toroq, kien jieħu l-ilma minn hdejn l-Għassa, u minn fuq is-Sur ta' San Giovanni.

Fl-Għassa kelna Kappella li kella pittura tal-Qalb ta' Gesu', dan qalluli jinsab id-Depot, il-Furiana.

F'żmien il-Ġimgha l-Kbira kienu jgħamlu l-Viżti hemm ukoll għax kien ikun armat, is-Sepulkru.

Kelna wkoll statwa ta' Maria Addolorata, u Kristu mejjet.

Supretendent f'dan iż-żmien kien għadu Leone Enriquez li dam hafna l-Birgu u kien joqgħod hemm bid-dar.

L-attività ta' xogħol l-aktar kienet ġejja mill-preżenza ta' suldati Nglizi li kienu stazzjonati fil-Barracks ta' Verdala u kien jinżlu l-Birgu u sintendi bahrin mill-bastimenti li kienu jkunu ankrati fid-dahla tal-Birgu.

Kien hemm hwienet fuq is-Sur ta' San Gwann li kienu jahdmu l-hbula u ġo l-Foss ukoll.

Strada San Lorenzo ġewwa kien hemm hwienet tal-Ghamara, haddiema tas-sena mill-aqwa, hwienet li jahdmu l-Kaldaran, xogħol tas-Ramm, bhal borom, ktieli u xogħol iehor. Kien hemm ukoll Wenzu ta' Żammitellu u s-Sur Ġorġ li kienu jahdmu l-induratura tad-deheb, xogħol mill-isbah.

Is-Sorijiet tal-Karmnu kellhom skola tat-tfal u konna nieħdu hsieb meta jidhlu u johorġu.

Meta tidhol il-ġewwa jgħidulu hdejn l-Aċċjomu kien hemm mastrudaxxi kif diġà għidna ta' l-aqwa fis-sengħa.

Fuq it-Toqba kien hemm il-Fossos biex jahznu l-Qamh. Qabel il-Gwerra barra dak li semmejt li kien iġib l-

inkwiet kien hemm iż-żewġ Festi kbar dik ta' San Lawrenz il-Parrocca u dik ta' San Duminku, li minhabba fihom konna nitolbu li jintbagħtu Pulizija minn barra d-Distrett tagħna. Dan l-aktar minhabba li kienu jtellgħu l-San Lawrenz nghidulha fuq il-Lunzjata, qabel ma d-dur għal fuq is-Sur ta' San Gwann.

Issa se nitkellmu għaż-żmien meta bdiet tinhass li waslet li tibda t-Tieni Gwerra Dinjija, dan kien iż-żmien ta' 1938 u 1939. Milli jidher l-Awtoritajiet kien qed jahzbu li din kienet se tkun b'xi attacki mill-Ajru bil-Gass. Dan għax bdew jippreparaw Kmamar fl-Għassa li ġo fihom bdew iwaqfu serattizzi forma ta' kamra u jdawruhom bil-gviret biex il-Gass ma jidholx.

Bdew jibgħatuna fuq Kordin fejn kien hemm Centru għal tahrig kontra attacki bil-Gass,

Issa bdew jitqasmu l-Maskri, lilna kienu ta' kwalità u tal-Pubbliku kwalità ohra, aktar hfief, dan għax tas-Servizzi riedu jkunu tajbin biex johorġu barra bihom filwaqt li l-ohrajn aktarx kienu maħsubin għal ġewwa. Għat-trabi kien li jidhlu fihom b'kollox.

Fl-10 ta' Ġunju 1940 dahlet l-Italja fil-Gwerra u l-għada fis-7 ta' filgħodu ġew jattakkawna f'għoli li bilkemm kienu jidhru, tefaw l-ewwel bombi fuq Kordin, u Bormla fuq il-Mithna.

Dak inhar kien hemm ċertu Ġorġ minn Hal-Qormi jbiegħ il-haxix Bormla u dan telaq bil-ġirja għall-Għassa tagħna u trid tara liż-żiemel li kellu jġri warajh sa l-Għassa, kienet konfużjoni kbira. Peress li kif għidt ahna konna l-Uffiċċju Prinċipali tal-Lvant jiena li kont qed naghmel duty mat-telefon kont nirċievi r-rapport mid-Distrett kollu.

Nista nghid li l-Gwerra fuq Malta hadet xejra ohra meta niżlu l-Germaniżi fl-Italja, biss konna għadna ma nafux x'se jgħamlu.

Ma damx wisq li hadna din irrisposta. Kien il-Ġimgha bil-lejl meta sirna nafu li kien dahal Malta l-H.M.S. Illustrious, Aircraft Carrier li l-Germaniżi waqt li kien għaddej minn

Issa beda xogħol iehor, peress li n-nies riedu li jevakwaw minn il-lokalità li kienet hafna perikoluża.

Kanun Bofor ta' kontra l-Ajruplani li kien fuq is-Sur ta' San Gwann u li kienu fuqu suldati Nglizi giet bomba diretta fuqu, u miet kulhadd, peress li kienu Nsara qabel ġew għalihom nizzilnihom l-Għassa fejn il-Kappella.

Il-Koppla tal-Lunzjata li kienet għada kemm tlestiet mill-Pittur Battista Conti. Meta kien se jibda x-xogħol kont sejjer Ruma u Patri Humbertus Zampa O.P. talabni niehu ittra lil dan il-Pittur famuż. EVIDENCE - PRODUCTION OF FRESH EVIDENCE

It is an established principle that the Prosecution is to produce all its evidence before closing its case and that no fresh evidence can be produced by the Prosecution after that stage except in very exceptional circumstances.

The Police vs Leslie Freedman

17th March, 1977

Hon. Mr. Justice. Mizzi, LL.D.

The Court, By judgment of the Criminal Court of Magistrates of Judicial Police for the Island of Malta on the 4th February, 1977, Leslie Freedman was found not guilty and acquitted of the charge of having as Managing Director of Imperial Products Ltd., Industrial Estate, Marsa, during the last five years on a number of occasions, by several acts committed at different times, constituted violations of the same provisions of the law and committed in pursuance of the same design, sold and disposed of about one thousand five hundred and four (1504) garments manufactured from materials which had been released free of Customs duty under section 7(2) of the Aids to Industries Ordinance, 1959, without paying duty on these articles before their sale or disposal as provided in section 9(2)(b) of the same Ordinance and of having evaded payment of Customs duty thereon in contravention of section 61(c)(h)(i)(k) and (m) of the Customs Ordinance (Chapter 60), the amount of duty involved being three thousand, nine hundred and fifteen maltese pounds, fifty five cents and eight mills (Lm3,915.55,8).

The Attorney General has entered an appeal against the said judgment and is asking that it be revoked, that the case be heard all over again by this Court and that, on the respondent being found guilty, the penalties contemplated by the law be inflicted, the grounds of the appeal being: (a) that the judgement fell (probably) on its face" and consequently null; (b) that the Prosecution was not allowed at the

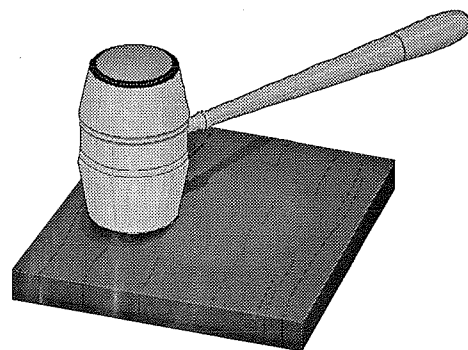
trial to produce, in respect of the charge, some indispensable evidence which was admissible according to law; and (c) that the judgment is based on wrong and incomplete enunciation of the law.

93 In his reply, the respondent has submitted that the judgment is subject to appeal and that consequently the appeal is null and subordinate, that the judgment is fair and should be confirmed.

After examining the record of proceedings and after hearing the submissions of the Senior Counsel for the Republic and Counsel for the respondent, this Court considers:

In regard to the first ground of appeal the Prosecution submits that the judgment of the first Honourable Court is "bad on its face" in that the Aids to Industries Ordinance was ruled out for the purpose of liability on the basis of considerations involving a number of non sequiturs. After pointing out that the respondent had sought the advice of the Comptroller of Customs merely as to whether he should pay the duty involved after instead of prior to a sale, the Prosecution argues that the judgment is "bad on its face" since it asserts that the respondent acted in accordance with what he was told to do and that his periodical statements were accepted for quite some time by the Customs Authority when there is abundant reliable evidence throughout the record that the duty was payable at the time of the sale and that the respondent had not conformed with the directions given him by the said Authority.

Section 425 of the Criminal Code, wherein it is specifically laid down when a judgment of the Court of Judicial Police may be appealed against by the Attorney General, has been constantly and repeatedly interpreted in a long series of decisions given by this Court in the sense that an appeal by the Attorney General does not lie on a question of fact but that, in view of



subsection (l)(b)(iv)(i), he may enter an appeal if the said Court, in applying the law to the fact as ascertained by it, makes a wrong or incomplete enunciation of the principles of law. In the present case, the Prosecution does not contend that as far, at least, as the offences under the Aids to Industries Ordinance are concerned the first Honourable Court, in applying the law to the fact as ascertained by it, made a wrong or incomplete enunciation of the principles of the law, but is clearly basing its appeal in the first place on the ground that the said Honourable Court failed to evaluate correctly the evidence, that is on the ground of a mere question of fact. In the circumstances, for the Court to extend the application of the above-quoted section 425 of the Criminal Code so as to cover the case under consideration would be tantamount to assuming an appellate jurisdiction which has not been given to it by the law.

The second ground of appeal is based on the contention that the Prosecution was not allowed at the trial to produce, in support of the charge, some indispensable evidence which was admissible according to law and consequently is entitled to appeal against the judgment in terms of section 425(1)(b)(vi) of the Criminal Code. It is submitted that the first Honourable Court relied on the oral evidence of the respondent without any corroboration whatsoever and refused to hear the witnesses by the Prosecution who were indispensable in order to enable it to control the testimony of the respondent in the interests of justice on the basis

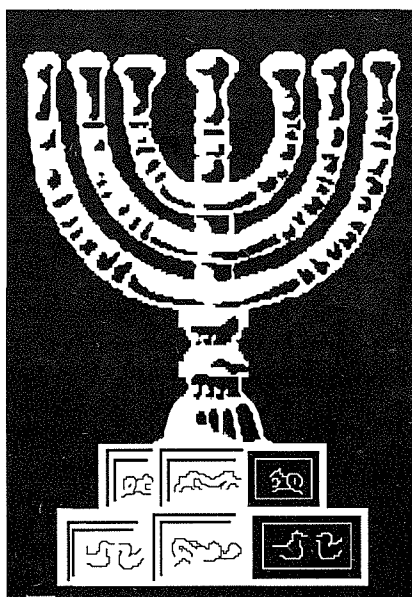

of the Best Evidence Rule.

Now, the first Honourable Court was undoubtedly entitled according to law to accept respondent's testimony even without any corroboration for although in terms of subsection (1) of section 634 of the Criminal Code "care must be taken to produce the fullest and most satisfactory proof available, and not to omit the production of any important witness" (a duty which is clearly incumbent, in criminal cases, on the Prosecution and not on the Court, unless it be a Court of Criminal Inquiry), subsection (2) of that section provides that "Nevertheless, in all cases the testimony of one witness if believed by those who have to judge the fact shall be sufficient to constitute proof thereof in as full and ample manner as if the fact had been proved by two or more witnesses". What is pertinent to the point at issue, however, is whether the witnesses offered by the Prosecution should or should not have been disallowed, depending on the nature of the evidence required of them and their admissibility or otherwise according to law.

It is relevant to premise that on the 5th March, 1975, the Prosecution formally declared that it had no further evidence to produce, whereupon the respondent asked that he be acquitted on the basis that the Prosecution had failed to produce the best evidence in support of the charges brought against him (p. 26). On the 14th March, 1975, the Prosecution requested to be allowed to produce further witnesses - a request which was opposed by the respondent but which the Court, by a decree given on the 16th May, 1975, granted after considering, *inter alia*, that the defence could suffer no prejudice at that stage since it had not yet produced its evidence and that it felt that it should allow the Prosecution to produce further witnesses in the supreme interests of the administration of justice (p. 37). On that same day, after calling three further witnesses, the Prosecution again declared that it had no further evidence to produce (p. 39). On the 15th September and 22nd October, 1975, after the respondent had taken the stand and whilst he was still being cross-examined, the Prosecution requested the Court to authorize the production of seventeen fresh witnesses, alleging that it could not have anticipated the explanations given by the respondent *en passant* certain exhibits (pp. 80-83 and 87-90). These requests, which the respondent again opposed, were rejected by the Court by two separate decrees dated 29th October, 1975 (pp. 85-86 and p. 88T).

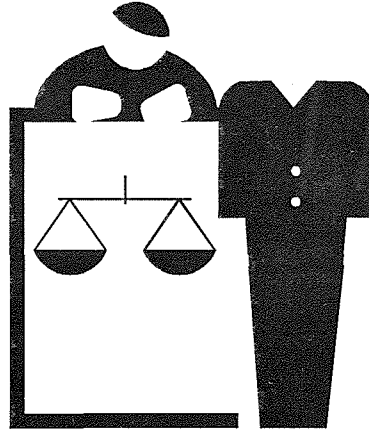
In disallowing the production by the Prosecution of these fresh witnesses, the first Honourable Court held:

(1) that it is an established principle that the Prosecution is to produce

all its evidence before closing its case and that no fresh evidence can be produced by the Prosecution after that stage except in very exceptional circumstances; and

(2) that the witnesses in question were known to the Prosecution before it had closed its case and their importance could not be considered as arising *ex improviso* which no human ingenuity could foresee.

According to section 387(c) with reference to section 386(i) of the Criminal Code, in proceedings instituted by the Executive Police before the Court of Judicial Police as a Court of Criminal Judicature, the defendant or his Advocate or Legal Procurator shall submit his defence and shall produce his evidence after the Executive Police has stated the facts constituting the offence and produced its evidence. If the Executive Police replies, the defendant or his Advocate or Legal Procurator is entitled to a rejoinder. The "order of the proceedings" (in the original Italian version, "ordine della discussione") may only be varied by the Court on good grounds. A similar principle, enshrined in section 475 of the Criminal Code, applies in regard to proceedings before the Criminal Court. Consequently, there can be no doubt that the first Honourable Court is correct in holding that, as a general rule, the Prosecution is not allowed to produce fresh witnesses after it has closed its case and that it is in very exceptional cases that such witnesses may be allowed at a later stage.

This Court, after examining in detail the relevant parts of the record of proceedings, is satisfied that the first Honourable Court is also correct in holding that the witnesses in question were known to the Prosecution and that no great ingenuity was required on the part of the Prosecution to foresee their eventual importance. Consequently, however important or indeed indispensable these witnesses could turn out to be in support of the charges proffered against the respondent (there is no available evidence in this respect except in regard to two witnesses in Suva, Fiji, which learned Counsel for the Republic declared during his oral submissions that he would not now be needing any longer), the first Honourable Court was fully justified in considering them inadmissible according to law and in disallowing the request for their production by the Prosecution in the particular stage of the proceedings when they were offered in evidence.

In regard to its last ground of appeal, the Prosecution contends that there is a wrong and incomplete enunciation of a vital principle of law in the judgment appealed against concerning the requirements of *mens rea* of the accused beyond reasonable doubt, but it should not be ignored that, according to section 73 of the said Ordinance, in any prosecution regarding the payment of customs duties, the proof that payment of such duties has been effected is on the defendant.

Terrorism

Together with sabotage terrorism is one of the primary weapons of the revolutionary. There are dozens of terrorist groups throughout the world, with many being highly trained and well equipped. However they have one thing in common, they are committed to the use of violence in the furtherance of their aims. Terrorist can attack by using bomb or bullet take hostages, hijack aircraft and committing acts of arson and extortion.

It was the massacre of the 11 Israeli Olympic athletes by the eight terrorists members from the PLO BLACK SEPTEMBER at Munich in 1972 that was the spur to development of special military or police hostage rescue units Organisations throughout the world and many of them are interconnected. In addition, several countries provide havens, financial backing for over 40 terrorisms for example: IRISH REPUBLICAN ARMY (I.R.A.) , BASQUE SEPARATISTS (E.T.A) , GERMANY RED ARMY and the ITALY'S RED BRIGADES. Many of this terrorist groups receive and use weapons and equipment from Soviet Union, China, North Korea, Vietnam, Iran, and Cuba as well as several Arab states: Algeria, Libya, Egypt, Yemen, South Arabia, Iraq, Syria and Jordan.

On 5 September 1972 eight terrorists of Black September shot their way into the apartments occupied by the Israeli Olympic athletes, two athletes were killed and nine other were held hostages. The Black September demanding the release of Arab prisoners from the Israeli jails.

At 21.30PM the terrorists and hostages left the apartments by helicopter, landing at Fürstenfelctbruck airport. The deal they made with the West German Government was to be

flow to Cairo or Tripoli with the hostages in a Lufthansa Boeing 737. But the West German police opened fire. They killed five of the terrorist, but not before they'd killed all their hostages. At that time there were no hostage rescue units or any hostage rescue tactics. In an effort to defeat international terrorism many Western governments have formed wanton terrorist units such as the British S.A.S, France's GIGN, West Germany's GSG-9, and before long had proved themselves highly effective.

CODENAME "PAGODA"

Pagoda is the codename of the S.A.S involved in ending the Iranian Embassy siege in 5 May 1980, was testimony of the wing (S.A.S) hostage rescue tactics. Although the Counter Revolutionary Warfare (C.R.W) using at Hereford was officially formed in 1973 when the S.A.S formally adopted the hostage rescuing training role in response of the Killing of 11 Israeli athletes at the 1972 Olympic Games of Munich, by the Palestinian group "Black September".

On 30 April 1980 the Iranian Embassy in London was siege by six terrorists armed with three 9mm automatic pistols, one 0.38 in revolver and some hand grenades, it was 11:30 hours. Since Wednesday 29 people in the Embassy had been held hostage by masked gunmen at the time of the takeover (4 British and 22 Iranian, 3 of the latter escaping in the first few minutes).

At 12:00 hours the masked gunmen demanded the release of 91 political prisoners held in Iran by the fanatical Ayatollah Khimeini's regime and set a deadline (12:00 hours, 1May)



The police stood by the usual rules of engagement in hostage situations which state that the military action may not be taken but once hijackers lose patience with the negotiation team and start killing hostages, then the assault team must be ready to move.

The terrorists found themselves involved in continuous contact with the police, discussing the release of the sick hostages, postponement of deadline and passing messages to and from third parties. This was all part of a recognized police gambit to establish and maintain contact, to set up relationships between the negotiating team and terrorists, and to begin the long process of wearing the terrorists down.

By the third day there had been numerous contacts and the terrorists agreed to release two hostages in return for a radio broadcast giving a statement of their aims. The siege continued through days 4 and 5, but on the day 6, 5th May 1980, at 13:30 hours Ablas Lavosani one of the prisoners had managed to get to a telephone but the terrorist shot him out then the second shot was heard, then a body was dumped outside the embassy front door at 17:00 hours. The second hostage had been killed and the decision was taken by Sir David Mc Nee Commissioner of police in charge of the negotiations to send the S.A.S. but the body was that of the Ablas Lavosani, but no one of the outside would have known that at the time. In fact the fire had been a bluff.

The S.A.S plane had been me-

Proċess iehor presjedut minn Sir George Borg flimkien ma' l-Imhallfin Dr. William Harding u Dr. Antoine Montanaro Gauci kien dak tal-Kaptan Eric Strologo li kien mixli minn Dr. Joseph H. Reynaud, Avukat Anzjan tal-Kuruna b'arrest illegali u maltrattament ta' tifel Malti Benjamin Caruana ta' sitt snin.

Minn xhieda mressqa matul il-proċess, irriżulta li l-Kaptan Strologo, fl-14 ta' Lulju, 1943, sab lit-tifel fuq truck tal-militar fl-Imdina. Wara li hataf lit-tifel u tah daqqiet b'idejh u b'saqajr, hadu fil-"guardroom" f'Ta' Qali fejn żammu arrestat għal tlett sigħat. Sadanittant, l-Ispettur Alfred Bencini li kien qiegħed jinvestiga dan il-każ, u wara mexxa l-Prosekuzzjoni fil-proċess, wissa u ta' ordni lil Strologo biex jikkunsinna t-tifel f'idejn il-Pulizija Civili.

L-Avukat Difensur Dr. Joseph Flores f'isem l-akkużat sostna li d-"Defence Regulations" ta' dak iż-żmien kienu jagħtu l-jedd lill-uffiċjali militari biex j arrestaw lil dawk li jkunu waqgħu taht suspett.

Iżda l-Qorti, fil-31 ta' Lulju, 1943, sabteq lill Kaptan Strologo hati ta' arrest illegali ta' l-imsemmi Benjamin Caruana, aggravat b'feriti ħfief fuq il-persuna tat-tifel u għaldaqstant, ikkundannatu għall-piena ta' tlettax-il-xahar habs b'xogħol iebes.

Il-Kaptan Strologo appella minn din is-sentenza fil-Kumitat Guridiku tal-"Privy Council" fl-Ingilterra minfejn huwa mexxielu jkseb il-helsien tiegħu. Il-"Warrant" għal helsien ta' Strologo mill-habs kien ġie ffirmat mill-Gvernatur Lord Gort fis-26 ta' Settembru, 1943.

Fil-25 ta' Lulju, 1944, il-Qorti Kriminali magħmula minn SIR GEORGE BORG bħala President u l-Imhallfin Dr. Luigi Camilleri u Dr. William Harding tat sentenza tal-mewt lill Vittorja Micallef, imwielda l-Hamrun, omm mhux miżżewwġa ta' dsatax-il-sena. Din kienet akkużata li bejn it-28 u 29 ta' Mejju, 1944, welldet tarbija, tifla, u qatlitha wara li kienet ikkaġunatilha feriti gravi f'rasha. SIR GEORGE BORG bħala Prim Imħallef, kien ressaq talba għal klemenza u fil-fatt din is-sentenza tal-



mewt giet mibdula f'wahda ta' piena ta' habs għal għomorha b'xogħol iebes permezz ta' "Warrant" mahruġ u ffirmat mill-Uffiċjal li jamministra l-Gvem fil-20 ta' Awissu, 1944.

Fis-17 ta' Gunju, 1944, il-Qorti Kriminali reġgħet lura fil-Belt Valletta meta parti mill-bini ta' l-"Auberge d'Italie" fi Triq il-Merkanti, l-Belt Valletta għet addattata biex tintuża bħala Qorti kriminali fejn kellhom ikompli jsiru l-ġurijiet u laqgħat oħrajn li jaqgħu taht il-ġurisdizzjoni ta' dik il-Qorti.

Fil-5 ta' Diċembru, 1944, fil-Qorti Kriminali magħmula mis-Sinjorija Tiegħu SIR GEORGE BORG bħala President u l-Imħallfin il-Professor Edgar Ganado u Dr. William Harding, intemm il-ġuri ta' Carmelo Hili, suldat territorjali fl-"R.M.A.", ta' wiehed u ghoxrin sena, imwieled il-Marsa. Dan kien ġie akkużat b'omicidju voluntarju mill-Prosekutur Pubbliku Dr. Joseph H. Reynaud, Avukat Anzjan tal-Kuruna. Il-każ kien seħħ fid-9 ta' Lulju, 1944 meta Hili spara azzarin ikkargat fil-kamp militari fejn kien stazzjonat, il-balla laqtet lill-Kapural George Mercieca, ippenetrat ġismu u fl-istess hin, wara li laqtet mal-hajt, il-balla reġgħet lura u feriet l-is-Surgent Anthony Falzon. Kemm Mercieca kif ukoll Falzon ġew feruti mortalment u t-tnejn mienu ffit tal-hin wara li twettaq id-deliit.

Il-ġurati bil-verdett ta' seba' voti kontra tnejn, sabu lill-akkużat hati ta'

Wara li rċevew direzzjonijiet ġodda fuq dan il-punt legali mill-Prim Imħallef SIR GEORGE BORG, il-ġurati reġgħu daħlu jddeliberaw u wara, harġu b'verdett ta' seba' voti kontra tnejn li l-akkużat ma kienx hati skond l-Att ta' l-Akkuża.

Fuq dan il-verdett, il-Qorti lliberat lil Carmelo Hili.

Fit-3 ta' Ottubru, 1945, quddiem il-Qorti Kriminali magħmula mis-Sinjorija Tiegħu SIR GEORGE BORG bħala President u mis-Sinjorija Tagħhom l-Onorabbli Mħallfin il-Professor Edgar Ganado u Dr. William Harding, tressqu għall-ġuri John Connell ta' 57 sena, imwieled Bormla; Joseph Connell ta' 33 sena, imwieled Bormla; u Edward Burnell ta' 55 sena, imwieled Haż-Żabbar.

L-ewwel Kap ta' l-Att ta' l-Akkuża kien jgħid illi bejn l-10 u l-11 ta' Settembru, 1944, John Connell u Edward Burnell, bil-lejl, hadu lil Karmena Connell, mart il-kuntistabbli Joseph Connell, f'Golf it-Tafal hdejn il-fortizza ta' San Anard, limiti ta' Haż-Żabbar, bl-iskuża li żewġha Joseph Connell kellu jasal hemmhekk b'dgħajsa li jkun fiha kaxxa deheb misruqa u jagħthielha. 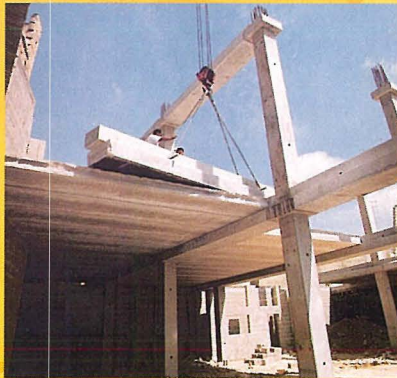

ticularly rehearsed. The S.A.S assault took place just 25 minutes later, using 12 men, in the usual S.A.S four-man team. The members of the assault were dressed from head to foot in black flame-retardant suit, black body armour and S07 gasmasks. They were armed with a variety of weapons, including Heckler and Kock MP 5 submachine gun as a primary weapon. Tear Gas was used together with "STUN" grenades, while the explosion of the shaped charge added to the noise and confusion.

The S.A.S plan was to blow in the first-floor armoured plate window at the front of the building using frame charges, with a four man team crossing from an-adjointing balcony to enter the Embassy. Two 4 men teams would also rapidly absail down from the roof at the rear to the first and second floor windows, and also blow up the back

door using a shot gun. The front window would be blown in first as signal to absail teams to begin their assault and as a means to distract the terrorist from the hostages.

At 17:30 hours on that warm early summer evening the S.A.S went into action. As the first pair of troopers reached the balcony at the front, a second pair absailed down to the first floor balcony at the rear, then came a hitch. One of the men in the third pair got his rope snagged. This means that the troops below him could not use their frame charge without injuring him, so they had to simply kick the window using the sledgehammer, hurrying their 'flash bangs' which cause disorientation but do not generally otherwise harm. As the second pair of troopers swarming in through the first floor windows at rear. The terrorist leader 'Oan' who had been temporarily distracted by a carefully timed telephone call, ran to the landing and

raised his automatic pistol (9mm Model 63 Machine pistol). Trevor Lock a police Constable of the Diplomatic Protection Group who was among the hostages, flung himself at the gunman, distracting his aim until an S.A.S trooper shot him.

On the second floor 15 male hostage and one terrorist was guarding the hostages, but when the S.A.S blow the armoured plate window using the frame charges two more terrorists ran in and began shooting at them. In the gunfire one Iranian official was killed and two more wounded, then the three terrorist throw down their guns and attempted to mingle with the hostages.

But the three terrorists were shot by S.A.S. Only one of the six terrorists, who had been guarding the women at the back of the building, was allowed to surrender. The whole operation had taken 11 minutes with 5 terrorists shot dead.

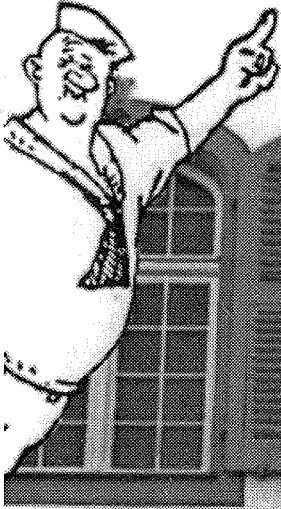

Kont ili snin ma nersaq lejn is-sagramenti tal-qrar u t-tqarbin.

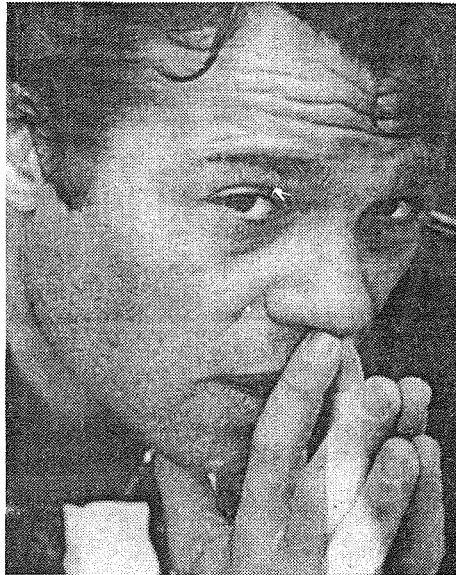

Din l-Emblema, li tistrieħ fuq skoll, li fih il-motto tal-Korp: "DOMINE DIRIGE NOS", għanda tliet qisien differenti magħrufa bhala: Collar Badge; Cap Badge u Helmet Badge, u din ta' l-ahħar għandha gost artistiku fir-riġel ta' l-emblema biex jgħaniha.

The Malta Police Force has a white metal Emblem, representing the white eight Pointed Cross of the Order of St. John, superimposed by a Shield with the traditionally Malta Emblem with the National Colours, White and Red, inside two circles forming the Police Symbol, "Belt and Buckle", at the lower part and at the upper part the words in Maltese, "PULIZIJA TA' MALTA". This emblem, which rests on a curved scroll with the motto, "DOMINE DIRIGE NOS", has three different sizes known as: Collar Badge, Cap Badge and Helmet Badge, which has an embellishment design at the legs.



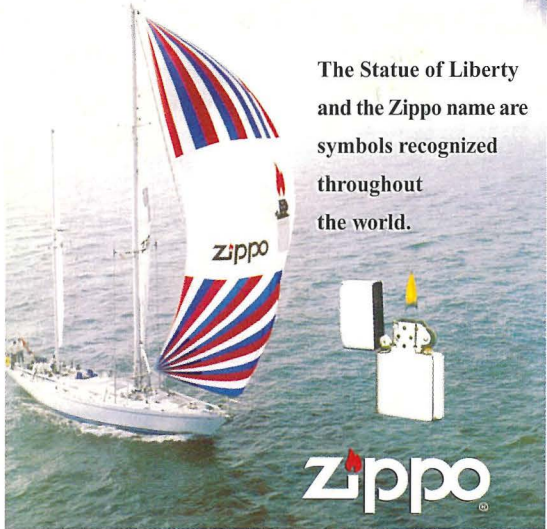
