ATT TA' MIN IFAHHRU

Nhar it-Tnejn, 28 ta' April, 1980 membru tal-Korp tal-Pulizija ta prova ta' dedikazzjoni ghax-xoghhol meta f'att kuragguz huwa rnexxielu johoda ma' nies armati waqt li dawn ippruvaw jisirqu l-fergha tal-Bank tal-Mid-Med tal-Gharb, Ghawdex.

Il-Kuntistabbli Michael Micallef, stazzjonat Ghawdex, kien ghassa ma' l-imsemmi bank meta f'xi 9.30 ta' fil-ghodu, tnejn min nies armati b'senter u b'rashom mghottija, dahlu fil-bank u mill-ewwel marru fuq il-pulizija li kien hdejn il-bieb ta' gewwa u ghamlu l-kanna tas-sentermieghu u wara marru talbu l-flus lillkaxxier. Il-kuntistabbli Micallef qaghad f'rokna tal-kamra ftit boghod minn dak li kellu s-senter f'idejh. Hekk kif dan ta' l-ahhar dawwar ghal ftit mumenti l-kanna tas-senter minn fuq il-Kuntistabbli, dan qabez ghal fuqu u wara taqtigha rnexxielu jnehhi l-ghammad minn go ras il-halliel u johodlu

s-senter. F'din it-taqtiha, l-kuntistabbli Micallef soffra xi griehi f'rasu u ttiehed l-Isptar Craig ghall-kura. Il-hallelin irnexxielhom jaharbu, izda dawn gew maqbuda mill-Pulizija xi hin wara.

Nhar it-Tlieta, 29 ta' April, il-Kummissarju tal-Pulizija, Dr. L. Pullicino zar lill-Kuntistabbli Micallef fl-Isptar Craig u wara li staqsieh kif kien ihossu wara l-incident qatta ftit hin jitkellem mieghu.

Il-kuntisabbli Micallef gie wkoll mitlub minn rapprezentant tal-Assocjazzjoni li wkoll zar lill-Micallef biex jaghddi messagg lill-membri tal-Korp li jkunu ghassa mal-banek. Wara l-esperjenza li ghaddiet minnhu, Micallef qal li l-Pulizija ghandu jkun dejjem attent u ma javdax lanqas ghall-icken mumenti u jekk jinqala xi haga, l-Pulizija ghandu jaghmel kuragg u ma jaqtax qalbu f'sit-wazzjoni bhal din.

L-Elezzjonijiet ta' l-Assocjazzjoni tal-Pulizija

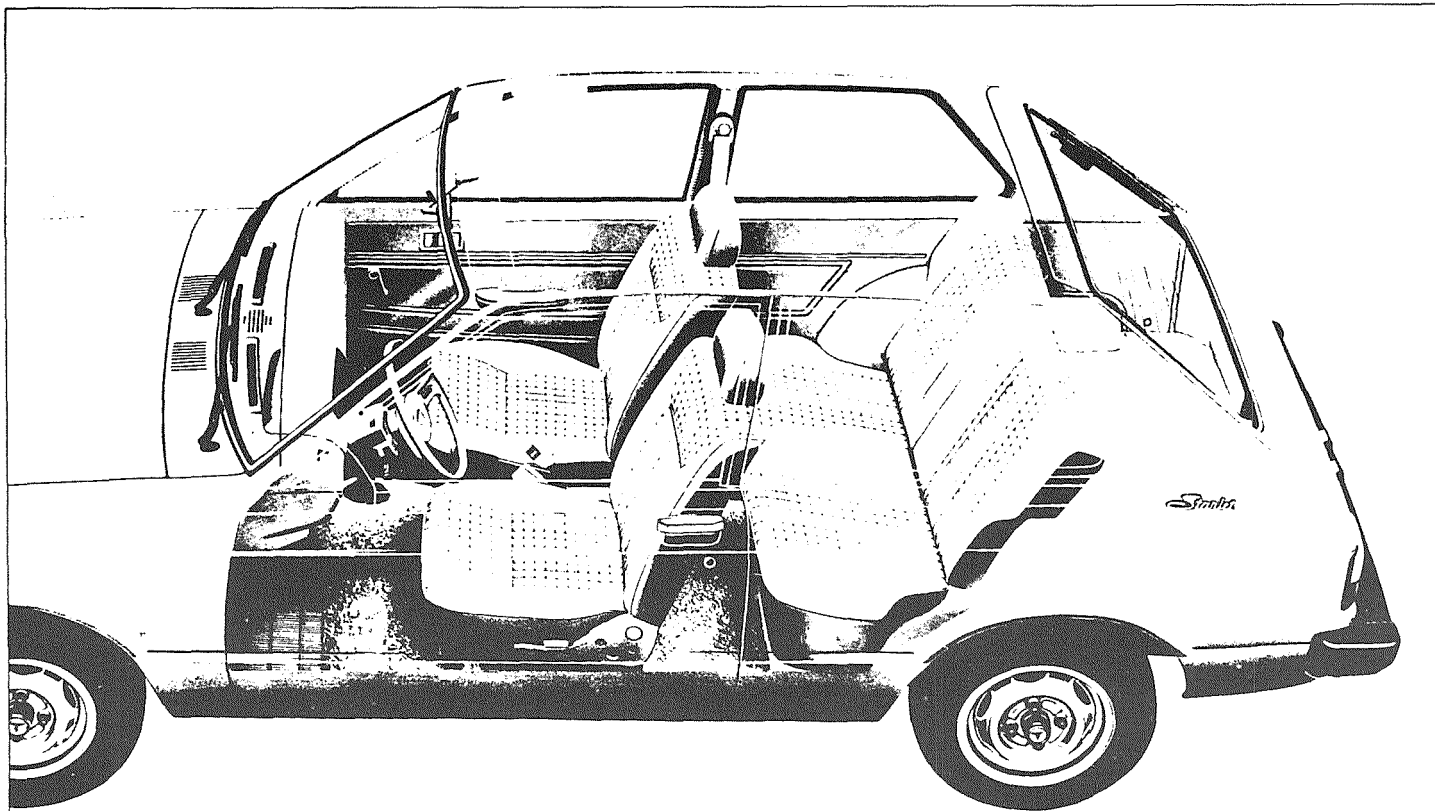

Dawn l-elezzjonijiet, li jsiru kull sena, se jkunu r-raba' elezzjonijiet minn meta regghet twaqqfet l-Assocjazzjoni u din is-sena jahbat ukoll gheluq il-hamsa u ghoxrin sena mit-twaqqif ta' l-ewwel kumitat ta' din l-Assocjazzjoni.

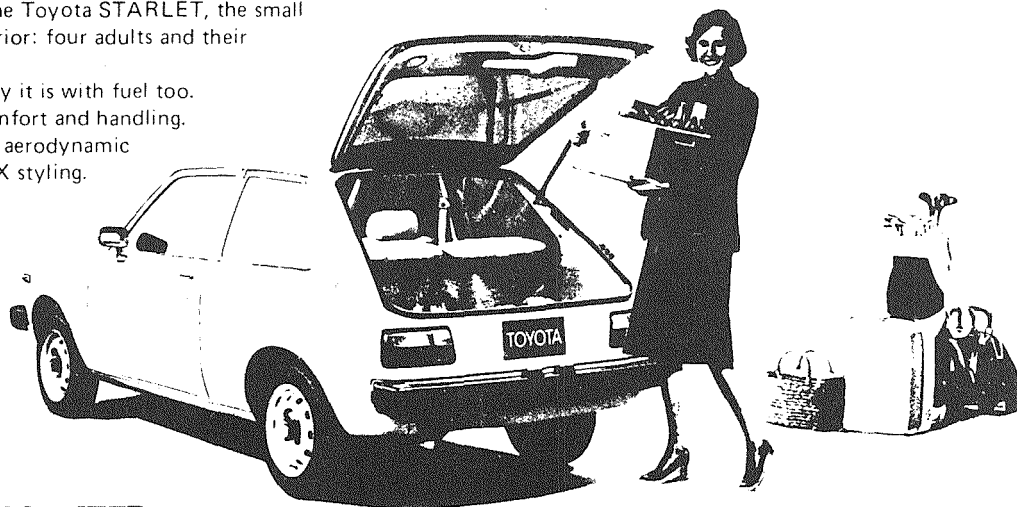

POLICE AROUND THE WORLD

U.S.A. - THE TEXAS RANGERS

BEGUN in 1823, formally organized in 1835, the Rangers have existed for 140 years. In 1821, Stephen S. Austin, known as the "Father of Texas", made a contract to bring 300 families to the Spanish Province of Texas. By 1823 probably more than 600 to 700 people were in Texas. These being the hardy colonists from the various portions of the United States at that time. These people settled not far from the Gulf of Mexico. They had quite a few neighbours, however; these neighbours gave them no end of trouble. The neighbours primarily were comprised of the Mexicans, who lived as far north as San Antonio, and the Indians who occupied all of Texas. By far the most troublesome of the neighbours were the Indians. There was no Army to send after the Indians, so Austin called the citizens together and organised a band to go after the Indians who would strike and melt away into the forest leaving no trail. Because this band ranged over the entire country, they were called Rangers, which gave rise to the force known as the Rangers. Austin first referred to this group as the Rangers in 1823.

Today as the law enforcement branch of the Texas Department of Public Safety, the Rangers have a force of 94 men, including a Senior Ranger Captain, an Assistant to the Senior Ranger Captain, six Captains, seven Sergeants, and 79 privates.

The State is divided into 6 Ranger Districts with headquarters at Houston, Dallas, Lubbock, San Antonio, Midland and Waco. At most company headquarters a Captain, a Sergeant, and two or more Rangers are stationed. A Senior Ranger Captain, the Assistant to the Senior Ranger Captain, a Sergeant, and two Rangers are stationed at Headquarters in Austin, and all other Rangers are located separately in towns considered to be strategic points throughout the State. The Company is commanded by a

Captain and the entire force is under the supervision of the Senior Ranger Captain, the Chief of Criminal Law enforcement, and the Director of the Texas Department of Public Safety. Qualifications for applicants for the Texas Ranger Service are; each applicant must be at least 30 and less than 50 years of age, citizen of the U.S.A., in excellent physical condition and have an outstanding record of at least 8 years experience with a bona fide law enforcement agency engaged principally in the investigation of major crimes, and be especially adapted for the particular type of work demanded by the Rangers.

Texas Rangers have undergone many changes since their birth in Texas back in 1823. But the objectives of the force remain much the same. They are specifically charged with these four major duties; 1. Protection of life and property through the enforcement of the criminal statutes of the State of Texas. 2. The suppression of riots and insurrections. 3. The investigation of major crimes, such as murder, rape, robbery, burglary, cattle theft, felonious

assault and other felonies. 4. The apprehension of fugitives. In this connection they transport prisoners and assist local prosecutors in compiling information for court action.

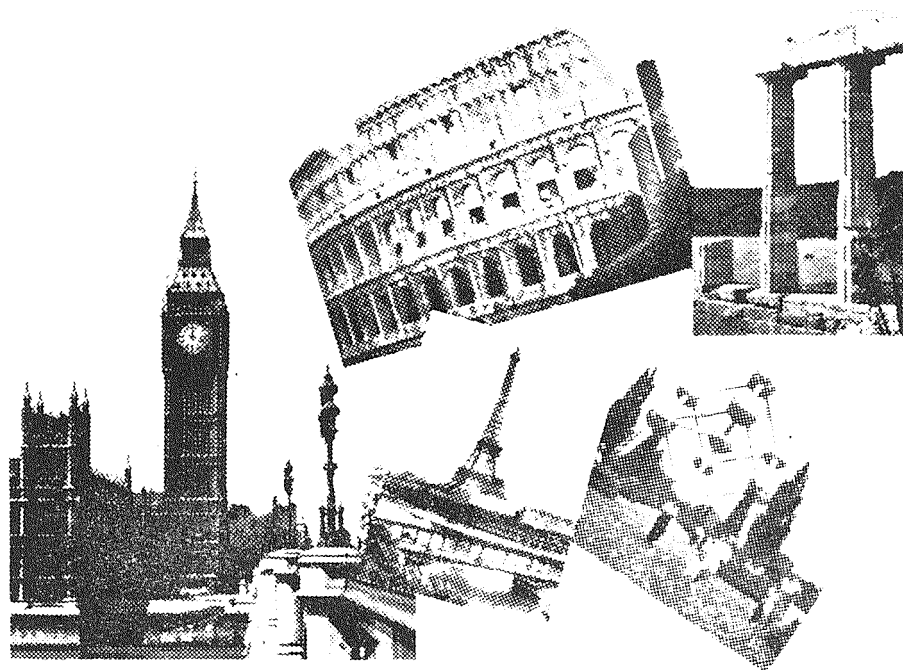
But the duties within these categories are varied. Texas Rangers might be called upon to move into disaster areas to save lives and guard against looting, suppress a prison riot or keep the peace wherever mob violence is threatened. They may be required to travel by automobile, airplane, motorboat, jeep or on horseback. It all depends on the locality and the job at hand. One of the Rangers force's main functions is to assist local enforcement agencies when called upon for their help. To do this job the modern Texas Ranger has the full facilities of the Department of Public Safety. These include the crime laboratories and the identification and criminal records division of D.F.S. There are also the latent fingerprint files, the chemical laboratories, questioned document section, the polygraph photography and firearms experts. and he knows how to gather and prepare evidence at the scene of the crime so that

Ftit Storja

Sa mill-qedem insibu l-Indjani fil-Messiku jomoghdu l-gheruq tal-kaktus tad-desert li jisimha *Peyote Cactus*, ghax meta kienu jaghmlu dan kienu jhossuhom fi stat ta' estasi u jaraw 'vizjonijiet'. Dan kien jigri ghax f'dawn l-gheruq tezisti sustanza kimika li llura tista' ssir anke fil-laboratorji li jisimha *Mescaline*.

L-istess kien jigri meta jieklu l-mushrooms messikani li jisimhom *Psilocibe Mexicana* ghax fiha s-sustanza kimika *Psilocybin*.

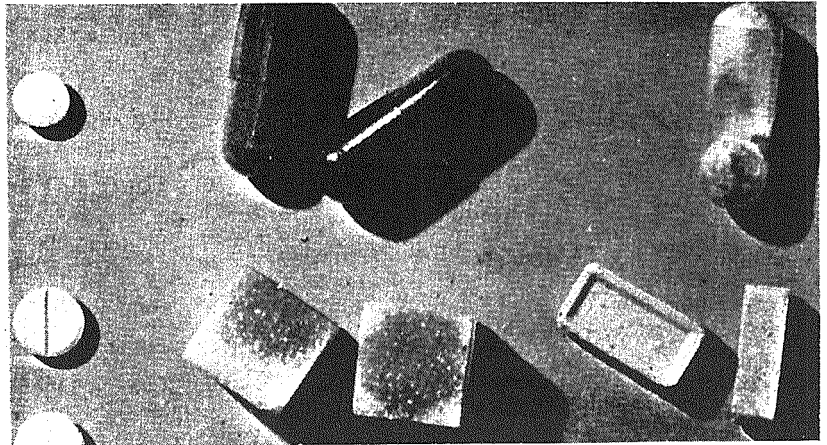
Dawn id-drogi u ohrajn jixbhuhorri, huma kollha illegali u l-uzu taghhom huwa marbut ma ricerki biex jikkonfermaw il-hsara kbira li jnisslu fis-sahha tal-bniedem. Il-kumitat specjali fuq id-drogi tal-Gnus Maghquda kkundanna minghajr riservi l-uzu ta' dawn id-drogi allucinatorji.

L-L.S.D.

Billi fil-prattika l-L.S.D. hija d-droga li ntuzat u li hija ferm perikoluza, jaqbel li nitkellmu bi ftit dettalji fuqha biex nipperswadu rwiehna li min juza dawn id-drogi jkun jixraqlu kura serja ta' mohhu. Fil-fatt dawn id-drogi allucinatorji jwasslu biex bniedem jiggennen verament.

Fid-dinja dejjem tiltaqa' ma nies b'idejat strambi u anke fl-uzu ta' dawn id-drogi nsibu nies intelletwali bhal Mr. Aldous Muxley li fil-ktieb tieghu "The doors of perception" ifahhar l-esperjenzi li wiehed jista' jakkwista bl-uzu ta' dawn id-drogi.

Nahseb li kulhadd qara fuq il-

Professur Amerikan Timothy Leary li xtaq jinkoragixxi l-uzu ta' dawn id-drogi. Leary u shabu ghamlu esperiment li baqa' jisemma' meta wzaw l-L.S.D. fuq habsin waqt li ndaqget muzika sabiha, ghax skond Leary li tiehu din id-droga qiesek qed tivjagga. Meta tittiehed doza ckejkna ta' 100 mikrogrammi ta' L.S.D. wiehed igarrab dawn l-effetti li sejrin insemmu. (Tajjeb li wiehed ikun jaf li l-aspirina fiha mhux anqas minn 500,000 mikrogrammi. Jigifieri d-doza tal-L.S.D. hija 5000 darba anqas minn aspirina).

Wara xi 25 minuta li tiehu l-L.S.D. is-sensi jithawdu b'mod li l-kuluri jidhru aktar minn 1000 darba qawwija u l-muzika thossok qed taraha u mhux tismaghha biss. Il-kuluri jibdedw jaghmlu l-hsejjes u thossok qed tissepara fi tnejn bhal ma bajda tohrog mill-qoxra taghha, u tibda thares lejk in-nifsek f'dan l-istat ta' separazzjoni. Meta jigri dan, thossok qed tivjagga u thossok kapaci ttir (mhux wiehed u tnejn qabzu minn tieqa u baqghu mejta ghax hasbu li kapaci jtiru).

Zi whud ikunu kapaci jintelqu u jimmaginaw li qed jivjaggaw u jduru mad-dinja minghajr ebda biza'. Ohrajn ihossuhom bhal arlogg li qed jittarrak bicciet minghajr kapacita li jahsbu u jirragunaw, sempliciment ihossu li huma parti mid-dinja li qed iddur bihom. Leary stess jistqarr li xi whud li hadu l-L.S.D. hassew

ansjeta u biza' kbir u ohrajn ma kienux kapaci jergghu ghal hajja normali ta' qabel hlief b'diffikulta kbira. Ohrajn li hadu dawn id-drogi ddeskrivew dawn l-effetti:

Tliet l-interess kollu tal-hajja — karriera, xoghol u familja ma saru jfissru xejn ghalija.

★ Hasejt il-bzonn uniku li nitghazzen u gibda biex infittex dawn l-esperjenzi tad-drogi. (L-L.S.D. ma johloqx dipendenza fizika).

★ Ma kontx kapaci nahseb fuq xejn hlief fuq l-esperjenzi tad-drogi.

L-Uzu tal-L.S.D.

L-uzu bla sens ta' din id-droga beda madwar is-sena 1949 minn xi psikjatri u psikologi f'esperimenti xjentifici. Il-professur Leary spicca biex gie mkecci mill-Universita ghax beda jghallem li din id-droga ghandha s-setgha li tiftahlek mohhok.

Dr. James L. Goddard li kien il-Kummissarju tal-ikel u d-drogi xehed quddiem is-senat f'Mejju 1966. "Hafna spartarjiet ghandhom provi cari li diversi morda wara li hadu l-L.S.D. tilfu mohhom — u mhumiex kapaci jahsbu, jirragunaw u jaghtu gudizzju".

Ghaddew aktar minn 30 sena minn meta x-xjenzati bdew jesperimentaw bl-L.S.D. Inkitbu aktar minn tliet elef artikolu f'rivisti xjentifici fuq l-L.S.D. Xi whud hasbu li l-L.S.D. setghat

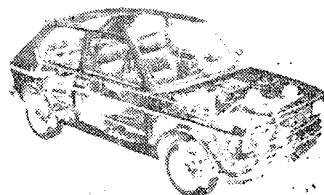

BHALA ritratt ghal din il-harga ghazilt wiehed ta' grupp ta' Pulizija tad-Dipartiment tal-Investigazzjonijiet Kriminali fittletinjiet imexxija mill-Ispettur M. Calleja (li wara nhatar Surpintendent) u li qed jippuzaw ghar-ritratt wara sejba ta' lampik li kien qed jinzamm kontra l-ligi.

Dan ir-ritratt akkwistajtu minn ghand iben is-Sur Calleja u gbart xi tgharif dwar il-membri l-ohra li jidhru fir-ritratt minghand xi ex-membri tal-Korp li jiftakru lil dawk fir-ritratt.

Skond it-tgharif li ghandi u li ma nafx kemm hu ezatt, dawk li jidhru huma: mix-xellug ghall-lemin: (Nibda mit-tielet ghaliex ma ghandiex informazzjoni dwar l-ewwel tnejn), Il-Maggur Toni Micallef, mgharuf bhala n-Nazot; l-Ispettur Calleja; Is-Surgent Sciberras; Is-Surgent Guzeppi Vassallo; (dak tat-tarf ma nafx min kien). Dwar l-Imghoddi

QED nipprova nlaqqa' t-tgharif dwar dan it-titlu ma dak li jidher fir-ritratt, **MILL-IMGHODDI**. F'din il-harga se naghti xi taghrif li jiena gbart minn dokumenti antiki dwar id-Dipartiment tal-Investigazzjonijiet Kriminali li fl-imghoddi kien maghruf b'diversi ismijiet kif se naraw il-quddiem.

L-ewwel isem ta' din it-taqsimta tal-Pulizija kien Detective Office li twaqqfet fl-1917 mis-Surpintendent (kif kien maghruf il-kmandant tal-Korp) C.W. Duncan. Mat-twaqqif ta' din it-taqsimta gddida tal-Pulizija gew inkorporati fiha taqsimiet diga' mwaqqfa fil-Korp bhal ma kienu l-Alliens Branch, it-taqsimta tal-kondotti u lis-Special Branch.

F'din it-taqsimta setghu jingagaw ukoll nies barra l-Korp u dan kien isir billi japplikaw ghal dan il-ghan. Bhala regola generali kienu jintghazlu dawk l-aktar addattati u li kellhom inklinazzjoni ghal xoghol ta' detective. Rigward l-ghazla ta' nies minn gol-Korp, din kienet issir billi tinghata konsiderazzjoni ghal dawk il-membri li kienu jahdmu sewwa u b'diligenza fuq il-'beat'.

Naturalment id-detectives kienu jahdmu pajzana u sa mill-bidu insibu li kellhom 'allowance' ghal dan ix-xoghol li kienet hekk: Kuntistabbli—1c7 kulljum; Surgent—2c5 kulljum; Spettur—5c kulljum. Fiz-zmien li qed in-semmu, jigifieri fl-1917 lis-'strength' kien ta' Spettur wiehed, 3 surgenti u 15 il-Kuntistabbli.

Skond ordnijiet antiki nsibu li x-xoghol ta' dawn id-detectives kien li jsiru jafu n-nies ta' kondotta hazina, fejn dawn imorru, ma min ikunu u nformazzjonijiet ohra bhal dawn. Dawn l-informazzjonijiet kienu jaghddu-hom lill-ispetturi l-ohra fid-diversi divizjonijiet tal-Pulizija.

Fl-ufficju ta' din it-taqsimta tad-detectives kien jinzamm ktie' ta' l-okkorrenzi dwar 'crimes' li kienu jaslu mid-divizjonijiet. POLICE AND THE PUBLIC PART I.

A PERSON'S conduct is determined on the one hand by what he wants to do and on the other by what he is afraid to do. His compliance with law and regulation is obtained either by developing in him a willingness to conform to the desired pattern of behaviour or by compelling him to conform by threat of punishment.

The two processes — enforcement and the development of attitudes favourable to law observance — cannot be completely separated, with the police free to choose one and reject the other. Instead, their use is a matter of degree or emphasis. The police in one jurisdiction may attempt to accomplish its purpose by enforcement with indifferent or no attention to winning compliance by other means; in others they will give first attention to winning compliance using minimum enforcement on individuals when other methods fail.

Compliance is won principally by force in totalitarian and police States. In those countries the police are a tool of the central government used to impose its will on the people and to perpetuate its administration. Some American police forces have been used in this manner and for the same purpose.

On the other hand, compliance with minimum enforcement is the democratic process; it is a basic characteristic of the best British, American, and Australian police forces. Their leaders are becoming more and more convinced that no lasting good will come of a control imposed on an unwilling people: that no real progress is made in the development of order and security except as an attitude favourable to law observance is developed in the people.

This does not mean that enforcement should not be used by the police in a democracy. It does mean, however, that it should not be used except as approved by the majority. Compliance won principally by force is a characteristic of police incompetence; it is the hard way to do the job. Compliance won principally by other

means is evidence of a high order of police ability, it is the easiest and most desirable method of accomplishing the police purpose.

In this article the principle will be developed that sound **public relations** is basic to the effectiveness of the police. The following deals with the development, organisation, and administration of a **public relations programme**.

Policemen Work with People

To the citizen in distress seeking assistance or information, and to the citizen in conflict with the law, the policeman is the city government. The public relations, not only of the police department but of the city government as a whole, rest squarely on the individual officer's contact with citizens. It should also be remembered that the children of today are the citizens of tomorrow. Effective police work with children on the basis of friendliness and help will pay returns to the community in crime reduction and to the police in a body of citizens in sympathy with and helpful towards the achievement of police objectives. Some aspects of these contacts may appear to be minor details if they are neglected, however, public resentment is likely to overpower goodwill.

Police Dependence on Citizen Attitudes

Protection of citizens is a primary function of government, and representatives of the people hire police officers to perform this important task. As in any other employment, there must exist a suitable employer-employee relationship. The police must recognise and understand this relationship.

The desired relationship between the police and the public is impossible to attain unless both have suitable attitudes. The actions and conduct of each are determined by their own attitudes, which in turn influence the attitudes and conduct of the other. The attitude of the public is moulded and built by the police themselves; it reflects the police

attitude.

While the police themselves are, the most important influence on public attitudes, others are in constant play. The press and motion pictures exert a powerful influence in shaping public opinion, and through misrepresentation they may create an attitude which is unfriendly and unfair to the police.

Strong personalities within a community, if not converted to the police point of view, may likewise do much to destroy public confidence in the police, to build resentment, and to prevent the creation of a desirable harmony between police and public. The police, however, may favourably influence these factors by proper attitudes of their own.

The city council and city administration have an important effect on public attitudes towards the police. Unless they have a proper appreciation of police problems, they may embarrass the police by enacting and insisting on the enforcement of ill-advised laws. The police must then bear the brunt of public reaction; this results in reduced efficiency and lowered morale.

The Police Point of View

Since a person's actions are determined by his frame of mind, policemen should scrutinise their own points of view. Their attitudes will be determined by their concept of the police function — of their duty towards the public. They should recognise the line of demarcation between the police function and the judicial function.

They should realise that the essence of a proper police attitude is a willingness to serve. They should distinguish between service and servility, courtesy and softness. They must be firm, but at the same time courteous; they must avoid an appearance of rudeness. They should develop a friendly, impersonal, and unbiased manner, pleasant and personal in all non-restrictive situations but firm and impersonal on occasions calling for regulation and control. They should understand that the primary police

purpose is to prevent violations—not to arrest offenders.

Police attitudes influence the public in proportion to the frequency of contact. Since the police make more public contacts in controlling traffic than in any other activity, it is especially important that continuous attention be paid to police attitudes in dealing with traffic offenders if increased respect and improved relations are to be obtained.

Public Attitudes

Generally speaking, police effort to control the public meets with resistance. Americans resist regulation; they resent being told what to do and what not to do. Rebellion against control is sometimes more than ordinary "sales resistance". It is equivalent to the resistance met by salesmen for products of poor quality or for products manufactured or distributed by an organisation with a reputation for inferior service. A police department that has been guilty of bad practices towards its citizens may meet a resistance which appears to be impenetrable. The stronger the resistance, the more important it is to break it down and establish a spirit of friendly co-operation. The best way to do it is to develop a strong public relations programme.

The police gain distinct advantages by maintaining a spirit of friendly co-operation with the public. There is an interacting relationship between high standards of police conduct and the public support on which those standards depend. Increased support of the police programme is **fostered by effective public relations which lay the foundation for higher standards of police work and form the basis for renewed public support.**

The police then find themselves in a favoured position. Commendation and praise build morale. This leads to increased police efforts which bring improved police services. With strong support from the community at large, it is possible to carry out difficult programmes. Progressive programmes and a general increase in police efficiency result in still greater appreciation of police efforts.

A co-operative public renders assistance to the police in many ways. A public that observes laws

and complies with regulations relieves the police of a large share of their normal burden. Because people want public esteem, the public's intolerance towards violations favourably influences law observance by individuals. The co-operation of the public is necessary in the enforcement of major laws as well as of minor regulations. It is necessary to the successful administration of any police department.

Fortunate are the police who have the support and co-operation of the public. Without it arrests are made more difficult and convictions are sometimes impossible. Unjust charges are frequently made against the police when their public relations are unsatisfactory. They are ridiculed, criticised, buffeted about, and censured at every move. Their sound and progressive programmes may be impeded, and they may find themselves in a mental state that causes them to be fearful of doing anything constructive because of possible criticism.

The police are inclined to assume that unfriendly citizens are their natural enemies and that all citizens are unfriendly. Neutral and even friendly citizens, when treated in an unfriendly manner, soon become unfriendly also.

Police morale is jeopardised, and the development of esprit de corps is difficult in an unfriendly community. Such a state is disadvantageous to the police. **An unfriendly public overlooks no opportunity to make the police task more onerous and working conditions less desirable.**

In an attempt to appease a dissatisfied public, the administration may take from the police many of their recently gained advantages of salary increases, shorter work week, improved sick relief, insurance provisions, pensions, and other security benefits for members of the department.

A public that co-operates with the police, that supports them in their efforts, and that observes laws and regulations has a proper attitude towards the police and law enforcement. The police administrator is confronted with the important task of creating this greatly-to-be-desired attitude.

Police dependence on citizen attitudes is so important that it is, in one sense, the subject of the

rest of this article. A favourable public attitude must be earned by the police, but the rewards are great in both public respect and self-respect. This attitude towards the police is influenced greatly by steps towards professionalism, development of police ethics, personal conduct of policemen, personal integrity, and respect for the due process of law.

The Police Profession

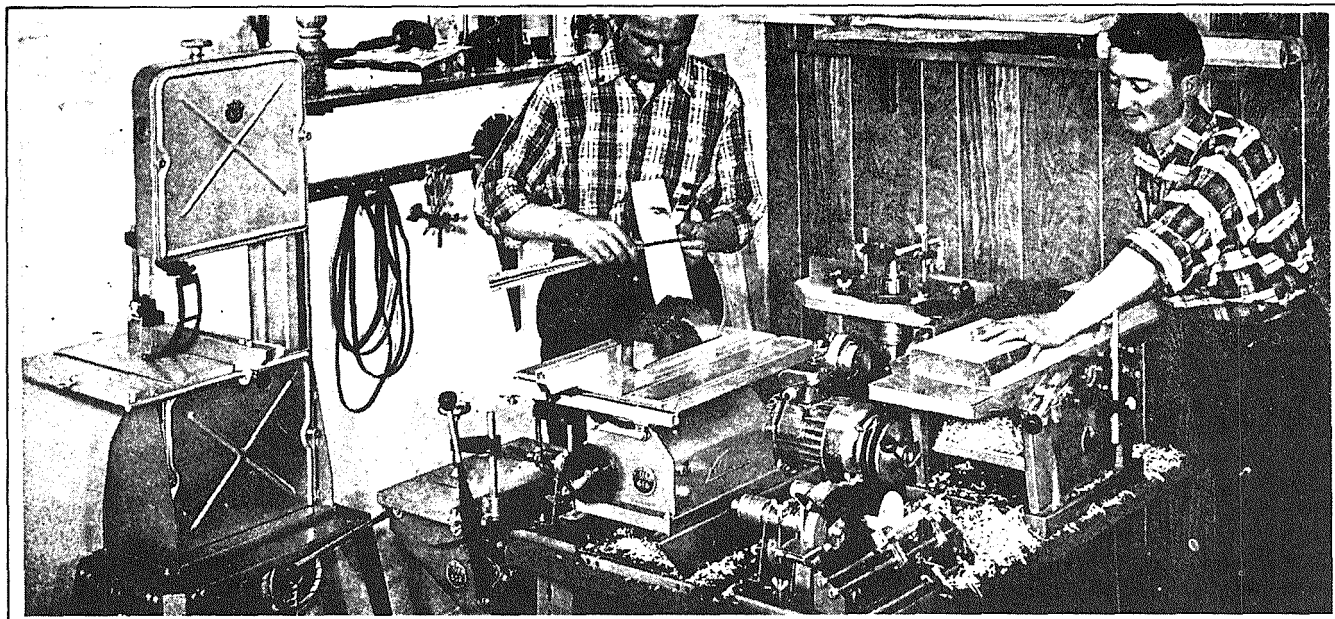
Men who have obligations toward mankind in general differ from those who owe their employers only a return for their pay. Those with higher obligations, rooted in religious or ethical philosophy, are the professionals. They violate oath, belief, and purpose if the size of their fees affects their skill in practice. This is an ideal, of course. Quacks, shysters, and racketeering evangelists bear little resemblance to the professional ideal. However, this does not erase the fact that each profession has its hard core of practical idealists who make professionalism a reality.

Professionalism

More specifically, what are the characteristics of a profession? The following definition is taken from a combination of observations: (1) the recorded opinions of professional men both living and deceased; (2) the oaths, canons, and ethical codes of professional societies; and (3) popularly accepted principles of western religion and western philosophy.
