Scholarships for Studies, Training or Research in Sweden

The Swedish Institute, a government financed foundation for cultural and educational exchange with other countries, is offering a limited number of GUEST SCHOLARSHIPS for the academic year 1978/79.

The scholarships are applied for in global competition. They can normally be granted only for *studies/research which cannot equally well be pursued in countries other than Sweden.*

The scholarships open to foreign students/researchers who wish to come to Sweden as guest students, who do not intend to settle permanently in Sweden and who cannot obtain financial aid from their home countries for studies in Sweden.

CRITERIA

Nationality:

The scholarships are open to applicants from any part of the world. There are no quotas as to countries. The Swedish Institute will distribute the guest scholarships as evenly as possible among applicants from different geographical areas.

Age:

There is no age limit.

Study Period:

The scholarships can be granted for study periods of short duration (3—4 months) as well as for longer periods up to three academic years.

Fields and Types of Study:

The scholarships are granted for studies within all subjects but only where Sweden can offer special scientific or scholarly advantages. *Scholarships are accordingly not granted for studies that can equally well or better be pursued in another country.*

The scholarships cannot be granted for a complete education leading to a degree, neither at the undergraduate nor at the graduate level, since this requires more than three years. Instead, the main purpose of the scholarships is to aid foreign students who wish to complete an education already begun, who wish to enter into a programme of further education or research, or who wish to take certain special courses of training or study which can be completed within three years.

The scholarships are not granted for the beginning of an education that will take more than three academic years to complete.

It should be noted that these awards are intended to serve purposes of educational and cultural exchange as distinguished from international assistance.

Where tenable:

Any university or educational institution in Sweden.

Study Leave:

The scholarships are intended for students in higher, secondary or adult education and for researchers.

Scholarship Condition:

The scholarships presently amount to 1.725 Sweden crowns per month. Each scholarship is only designed to cover the living expenses for ONE person.

There are no grants of any kind to family members. Nor are any travel grants available.

Languages:

A good knowledge of Swedish and/or English is required. Students without a working knowledge of Swedish may have to start their scholarship period by learning Swedish.

The scholarships are not granted for elementary courses in Swedish only.

Foreign students in Sweden:

Students already staying in Sweden are eligible to apply under the condition that they are not holders of a permanent residence permit or have refugee status.

Applications:

Applications should be made on the appropriate forms obtainable from the Department of Education (Personnel Section), Lascaris, Valletta, or from the Office of the Education Officer, Victoria, Gozo. These applications should reach the Department of Education, (Personnel Section), Lascaris, Valletta, by not later than Friday, 16th December, 1977.

Late applications will not be considered.

Applications by employees in Government Departments and Parastatal Bodies should be recommended by the Head of Department.


