**HOTELS AND CATERING
ESTABLISHMENTS BOARD**

Maximum prices per bottle of locally produced
wines, beer and soft drinks served in hotels and
catering establishments

IT is hereby notified that, in accordance
with subsection (1) of regulation 8 of the Hotels
and Catering Establishments Regulations, 1972,
the Hotels and Catering Establishments Board
has, with the approval of the Minister of
Tourism, fixed the maximum prices per bottle at
which locally produced wines, beer and soft
drinks may be served in hotels and catering estab-
lishments as shown in the Schedule hereto.

The maximum prices so fixed by the said
Board shall in no way exempt the hotel or cater-
ing establishment keeper from obtaining any
other licence from the Director of Trade as may
be required in accordance with the Sale of Com-
modities (Control) Regulations, 1972.

In every hotel and catering establishment,
there shall invariably be exhibited in a promi-
nent place and in such a manner that it can be
easily and clearly seen and read by members of
the public, a list of the prices herein mentioned
as applicable to that particular hotel or catering
establishment according to their respective class
as indicated in the Classification Certificate
issued by the Hotels and Catering Establishments
Board.

To the extent that they are inconsistent with
the above, Government Notices Nos. 109 of 23rd
March, 1978, 345 of 11th August, 1978 and 338 of
1st July, 1980, are hereby cancelled.
