Research Fellowship in the USA on Economic Policy Coordination among Industrial Countries

Purpose

With the support of the Fulbright Program, the Social Science Research Council in New York offers grants to American and Western European scholars whose research projects promise to increase understanding of the opportunities and constraints that condition economic policy coordination among the advanced industrial countries. Topics of interest to the programme include international economic policies and trends, international and regional institutions such as those within the European Economic Community, and the major policy making institutions and actors in each country as they affect international policy coordination. The study of economic and social policy and of international policy coordination is encouraged within a broad interdisciplinary framework.

American applicants must carry out most of their research in Western Europe. European applicants must carry out most of their research in the United States.

It is planned that a number of grant recipients and other scholars with relevant research interests will be invited to take part in an international conference on the programme theme in 1982.

Eligibility

Citizens of the United States and of the countries of Western Europe are eligible to apply. Applicants must be able to devote full time to their projects during the period of support. Generally, award recipients will be university-based scholars (including Doctoral candidates) but they may come from any academic profession or field.

Nature of Grants

The research grants provide support for periods from 2 to 6 months. Within a fixed maximum, the awards will include a monthly maintenance allowance (up to \$2,400 for senior scholars) and support for travel.

Each award will include one transatlantic round-trip economy fare and support for local travel in Western Europe or the U.S., if required by the project.

Recipients will be responsible for their own housing, insurance, benefits, and all other direct and indirect expenses during the period of their awards.

Selection Process

The selection of grant recipients will be based on the following criteria: scholarly qualifications and promise, importance and originality of the proposed research, and its relevance to the purpose of the programme.

Awards will be announced in mid-June 1981.

Obligation

Nominated candidates will be required to sign an undertaking to return to Malta on completion of studies and to be available to serve the Government of Malta or the private sector. Further details on this matter may be obtained from the Personnel Section (Room 25), Department of Education, Lascaris, Valletta.

Applications should be made on the appropriate forms obtainable from the Department of Education, Personnel Section (Room 25), Lascaris, Valletta, or from the Office of the Education Officer, Victoria, Gozo. These applications should reach the Department of Education, Personnel Section (Room 25), Lascaris, Valletta, by not later than Friday, 3rd April, 1981.

Applications from Government and parastatal employees will not be considered unless recommended by their Head of Department.
