WHEREAS it is provided by section 50 of the Constitution of Malta that whenever the holder of the office of President is absent from Malta the functions conferred upon him by the said Constitution shall be performed by such person as the Prime Minister, after consultation with the Leader of Opposition, may appoint or, if there is no person in Malta so appointed and able to perform those functions, by the Chief Justice;

AND WHEREAS the President is absent from Malta and there is no person in Malta appointed as aforesaid;

AND WHEREAS I have duly taken and subscribed the oath of office as prescribed by section 51 of the said Constitution;

NOW, THEREFORE, I, VINCENT SCERRI, DOCTOR OF LAWS, do hereby notify and proclaim that I have this day under the said Constitution assumed the functions of President of Malta.

Made at the Palace, Valletta, this 15th day of February, 1981.
