### HOTELS AND CATERING ESTABLISHMENTS BOARD

Fixed Prices for Guest Houses  
from 1st April, 1981

PURSUANT to and for the purposes of the Guest Houses and Holiday Furnished Premises Act, 1974, and in accordance with the Guest Houses and Holiday Furnished Premises Regulations, 1976, it is notified that the Hotels and Catering Establishments Board, with the approval of the Minister of Tourism, has fixed the maximum rates which may be charged by Guest House keepers, according to the class to which their Guest House has been assigned as prescribed in the following schedule:—

#### SCHEDULE

*Maximum rates allowable for Bed and Breakfast  
in Guest Houses*

1. In Guest Houses of FIRST CLASS:  
Three pounds and ninety cents (£M3.90c)  
for each person;
2. In Guest Houses of SECOND CLASS:  
Three pounds and twenty cents (£M3.20c)  
for each person.

The above-mentioned rates are subject to the following conditions:

(i) They shall be effected for the period commencing on the 1st April, 1981, until further notice;

(ii) the rates are fixed on the basis of the single rate, or rates per person, for all-inclusive bedroom accommodation together with the provision of breakfast;

2. L-għażla tad-disinn isir wara kompetizzjoni pubblika miftuħa biss għal ċittadini Maltin. Il-kompetitur jew kompetituri rebbieħa jistghu, għalhekk, jigu mitluba biex juru xhieda ta' ċittadinanza Maltija. ### Stamp Design Competition

The Postmaster General notifies that it is intended to issue this year a set of postage stamps to commemorate World Food Day. The set will consist of two stamps featuring one design.

2. The selection of the design will be made after a public competition open only to Maltese citizens. The successful competitor or competitors may, therefore, be asked to produce evidence of Maltese citizenship. Competitors residing abroad are to produce this evidence together with the particulars requested in paragraph 7 of this notice and to submit them as stated therein.

3. The design must also carry, on a detachable transparent overlay, the emblem adopted by the Foods and Agriculture Organization of the United Nations for "World Food Day", the words "MALTA" and "JUM DINJI DWAR L-IKEL", the date "16-10-1981" and the value tablet which may be indicated by three zeros. Each design must be accompanied by colour combinations appropriate for one other stamp reproducing the same design.

4. Competitors may submit more than one design. Each design should, however, be original in concept and suitable for full reproduction on the proposed set from the original artwork. The design should also be suitable for printing in a maximum of four solid colours; shades thereof may also be used provided these are derived from the addition

The above sizes may be horizontal or vertical in format. The designs should be neatly mounted on appropriate thick material. Stamp size simulations of the designs in colour may be submitted together with each entry.

6. Each design submitted in the competition must bear a *nom-de-plume* which should be inscribed on the back of the design. Other identity marks on the design or on the cover thereof will automatically exclude the design from being considered. If more than one design is submitted by the same competitor, a different *nom-de-plume* is to be used on each design. The *nom-de-plume* must not be such as to indicate the name or identity of the competitor in any way whatsoever.

7. The designs must be delivered to the Officer i/c Registry, General Post Office, Auberge d'Italie, Merchants Street, Valletta, not later than 5.00 p.m. on Monday, 23rd March, 1981, enclosed in a sealed envelope marked at the bottom left-hand corner "Stamp Design Competition". Not later than the date and time specified in this paragraph, each competitor shall also send in his full name and address, with an indication of the *nom-de-plume* adopted by him, in a separate sealed envelope, addressed to the Secretary, Ministry of Development, Energy, Port and Telecommunications, Auberge de Castille, Valletta, and marked "Stamp Design Competition".

8. The selection of the design will be made by the Minister of Development, Energy, Port and Telecommunications after consultation with the Stamp Design Advisory Board. The decision of the Minister shall be final.

11. The successful competitor will be later required to prepare designs for a stamp bulletin, first day cover envelope, date-stamp, advertisement and poster.

12. The successful competitor shall be bound to make alterations or adjustments to the accepted stamp design and the designs for the items mentioned in the preceding paragraph within such time and in such manner as the Postmaster General may direct.

13. The successful competitor may also be required to advise the Postmaster General during the whole production process of the stamps and the items mentioned in paragraph 11 of this notice to ensure the best possible result.

14. The stamp designs submitted may be exhibited at the General Post Office on such dates and during such times as the Postmaster General may direct.

15. If a competitor fails to comply with any of the above conditions, he may be disqualified from the competition.
