INDUSTRIAL RELATIONS ACT, 1976

Report by Registrar of Trade Unions

1980 — 1981

The Minister of Labour,
Welfare and Culture

Madam

I have to submit the annual report in accordance with Section 14 (1) of the Industrial Relations Act 1976 for the period 1st July, 1980 to 30th June, 1981.

2. This period began with 39 organisations on the Register which were made up of 19 trade unions and 20 employers' associations.

3. During the period under review there were registered nine new organisations. Six of these were trade unions i.e. Medwear Clothing Operators Union (No. 198) with 181 members, Għaqda Haddiema Bluebell (No. 199) with 34 members, Airline Pilots and Flight Engineers Union (No. 200) with 16 members, Union of Aviation Engineers (No. 202) with 14 members, Unjoni Haddiema tas-Servizz Turistiku u Haddiema Allejati (No. 203) with 10 members and Union of Government Licenced Tourist Guides (No. 205) with 78 members. The three employers' associations were Minibus Transport Association (No. 197) with 83 members, Assocjazzjoni tal-Principali tal-Mini Buses Kiri (No. 201) with 24 members and Għaqda tad-Dulciera (No. 205) with 78 members.

4. During the same period the Medwear Clothing Operators Union (No. 198) and Unjoni Haddiema tas-Servizz Turistiku u Haddiema Allejati (No. 203) were cancelled from the register at their own request. There were also cancelled the following organisations:

After ceasing to exist

Motor Agents and Traders Association (No. 150)

For failing to render returns under para. 12 of the Industrial Relations Act

Assocjazzjoni tal-Produtturi tal-Majjali (No. 190)

Union tal-Barklori (No. 194)

5. At the end of the period under review there were then on the register 43 organisations made up of 22 trade unions and 21 employers' associations.

6. A number of organisations failed to render a complete return as required by para. 14 (1) of the Industrial Relations Act, 1976 when this was called for on 2nd June, 1981. A letter of warning was issued to these organisations and an extension given. When this lapsed there were five trade unions which had still not complied i.e. Unjoni tad-Drama (UND), Agricultural Produce Brokers and Packers Union, Union of Film Artistes, Union tal-Lukanda Mellieħa Bay, and Għaqda Haddiema Bluebell. There were also 6 employers' associations which similarly did not comply, i.e. Mechanized Quarry Owners Association, Association of Hard Stone Quarry Owners, Association of Self-Employed and Employers, Yacht Traders Association, Assocjazzjoni Bejjiegħa tal-Laham, and Minibus Transport Association. All these were therefore on 3rd August, 1981 served with a Notice of Cancellation which would take effect in two months' time if there is still no compliance by then.

7. The membership strengths of Trade Unions and Employers' Associations as compared with those of my previous report are as follows:—

8. The above table shows a slight increase in the membership strength of trade unions and employers' associations. However, when taking stock of the overall position of these organisations, account has to be taken of the ten trade unions/employers' associations which have not yet submitted the returns according to law and which have been served with notices of cancellation. These trade unions/employers' association last year had between them 2,291 members.

9. The appendix which follows contains details of trade unions and employers' associations on the Register on 30th June, 1981.

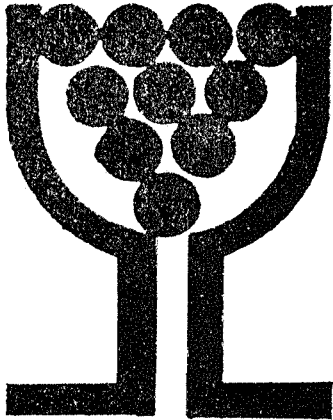

AN ACT further to amend the Old Age Pensions Act, 1948.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title and commencement.

1. (1) This Act may be cited as the Old Age Pensions (Amendment) (No. 2) Act, 1981, and shall be read and construed as one with the Old Age Pensions Act, 1948, hereinafter referred to as “the principal Act”.

(2) This Act shall have effect as follows:

(a) section 4 and paragraph (c) of section 6, as from the 3rd day of January, 1981;

(b) sections 2, 3, 5 and 6 (with the exception of paragraph (c) thereof) as from the 2nd day of January, 1982.

Amendment of section 2 of the principal Act.

2. For the definition of “severely handicapped person” in section 2 of the principal Act there shall be substituted the following new definition:

““severely handicapped person” means a person who still has a reasonable expectancy of life and who is incapable of supporting himself owing to a permanent handicap arising from —

(a) total deafmutism; or

(b) achondroplasia, hypopituitarism, osteogenesis imperfecta or other forms of dwarfism; or

(c) one of the following diseases, namely:

Multiple Sclerosis

Muscular Dystrophy

Spina Bifida

Hydrocephalus

Huntington’s Chorea;”.

3. In subsection (1) of section 3A of the principal Act, for the words "one hundred and fifteen cents" there shall be substituted the words "one hundred and twenty-five cents". Amendment of section 3A of the principal Act.
4. In paragraph (c) of subsection (1) of section 5 of the principal Act, for the words "two hundred pounds," there shall be substituted the words "the applicable maximum amount specified in sub-paragraph (a) of paragraph (1) or sub-paragraph (a) of paragraph (2) of the said Schedule, as the case may be." Amendment of section 5 of the principal Act.
5. In subsection (1) of section 11B of the principal Act, for the figures "£50" there shall be substituted the figures "£58". Amendment of section 11B of the principal Act.
6. The Schedule to the principal Act shall be amended as follows: Amendment of Schedule to the principal Act.
- (a) in sub-paragraph (a) of paragraph (1) thereof, for the figures "£10.25,0", "£8.75,0", "£7.20,0" and "£5.50,0" there shall be substituted the figures "£11.40,0", "£9.75,0", "£8.00,0" and "£6.10,0" respectively;
- (b) in sub-paragraph (a) of paragraph (2) thereof, for the figures "£13.05,0", "£11.30,0", "£9.50,0" and "£7.50,0" there shall be substituted the figures "£14.50,0", "£12.55,0", "£10.55,0" and "£8.35,0" respectively; and
- (c) in item (ii) of the proviso to sub-paragraph (c) of paragraph (3) thereof, the words "(other than leprosy assistance)" shall be deleted.

Objects and Reasons

The Bill aims to give effect to increases announced in the Budget for 1982 and to introduce some minor other improvements.
