NHAR il-Gimgha, 14 ta' Dicembru 1979, 111 membru gdid tal-Pulizija hadu l-gurament ta' Lealta' quddiem il-Kummissarju tal-Pulizija. Dan l-ingagg sar wara ezamijiet ghar-reklutagg fil-Pulizija dan l-ahhar.

F'din ic-cerimonja, l-Kummissarju indirizza lid-disa' kuntist-abbljiet li hadu l-hatra ta' Surgenti wara li ghaddeu minn ezamijiet.

Diskors tal-Kummissarju tal-Pulizija lir-rekluti wara l-gurament

ISSA li ghadkom kif hadtu il-gurament u hekk sirtu Pulizija fir-Repubblika ta' Malta, huwa xieraq li jinghad xi haga dwar it-tifsir ta' dan il-pass kbir li ghadkom kif hadtu kif ukoll id-dmirijiet ta' kull wiehed minnkom biex josserva il-punti kollha ta' dan il-gurament.

Illum inthom weggedtu li taqdu lil pajjizkom billi taghtu is-sehem taghkom kollu biex f'Malta isaltan il-paci, il-bon ordni kif ukoll tizguraw il-protezzjoni ta' kull cittadin Malti. Dan ma jistax isir, izda, jekk inthom infuskom ma tkunux leali lejn il-ligijiet ta' Malta u lejn id-doveri taghkom bhala Pulizija. L-ewwel ma jinhtieg huwa li tharsu lejn id-doveri ta' cittadin tajjed, taddottaw dawn id-doveri biex hekk inthom tkunu wkoll cittadini tajbin u imbaghad tkunu tistghu tizguraw illi l-ligijiet kollha jigu osservati minn kulhadd.

Il-hajja ta' Pulizija hija vokazzjoni; fiha it-tbatijiet taghha, fiha l-aspetti koroh taghha, izda ghandha wkoll is-sodisfazzjon taghha wkoll. U dan is-sodisfazzjon insibuh l-ewwel fil-fatt li nafu li qed naghtu servizz lill-pajjizna biex dan jimxi il-quddiem fil-prosperita. Kultant wiehed jahbat

jinsa id-dmirijiet lejn pajjizu, l-iktar meta ikun moghmi wara il-paga li tinghata lilu kull xahar u wara il-beneficci li qed igawdi fl-impieg tieghu. U hawnhekk inghid illi dan ix-xoghol ma huwiex semplici impieg iehor; inthom stajtu sibtu xoghol iehor kemm ridtu, hawn hafna u hafna postijiet bhal fabbriki u lukandi fejn stajtu timpjegaw ruhkom, imma xorta wahda ghaziltu li tidhlu maghna f'dan il-Korp li hu tant kburi bl-eghmil tieghu u bil-prospetti sbieh li ghandu quddiem ghajnejh. U inzid inghid li inhossni ferm kburi li qed nara quddiemni numru daqshekk sabih ta' rekluti godda li ghazlu din it-triq li' ghalkemm mhux imzejna imma thaddan ulied leali lejn il-mexxej taghha u ta' kull min jahkimha.

U huwa f'dan il-hsieb illi jiena inhossni fid-dmir illi nurikhom it-tajjed u il-hazin ta' dan ix-xoghol taghkom, ghaliex barra mis-sodisfazzjon hemm ukoll dak l-aspett iktar ta' min jabbuza minn dan il-poter illi din l-uniformi ggib maghha. Veru li ghandna ghaliex inkunu kburin illi ninsabu f'qaghda li nghinu lil kulhadd fi kwalunkwe hin, imma ghandna wkoll ghax nistkerrhu l-idea li forsi xi hadd minnkom jasal xi darba biex juza din l-uniformi ghal skopijiet tieghu innifsu biex jghinuh jakkwista dak li jixtieq. Inthom ilkoll tafu kemm hi keha il-korruzzjoni, kemm hdimna u behsiebna nahdmu biex tinqered din il-marda; tafu li f'Malta mhux kulhadd qaddis, jezistu il-kriminali u jezistu wkoll il-mishuta persuni li jittraffikaw fid-drogi u jghixu biss bid-delinkwenza. Inthom weggedtu li ma ghandkom xejn x'taqsmu ma dawn il-kwalita' ta' nies u qeghdin tweghdu wkoll li flimkien mieghi u ma shabkom l-ohra tiggieldu u tissieltu biex tinqered id-delinkwenza u tghinu lil zaghzagh ohra bhalkom li sfortunatament qeghdin jinqerdu ftit ftit bil-vizzju ikrah tad-drogi.

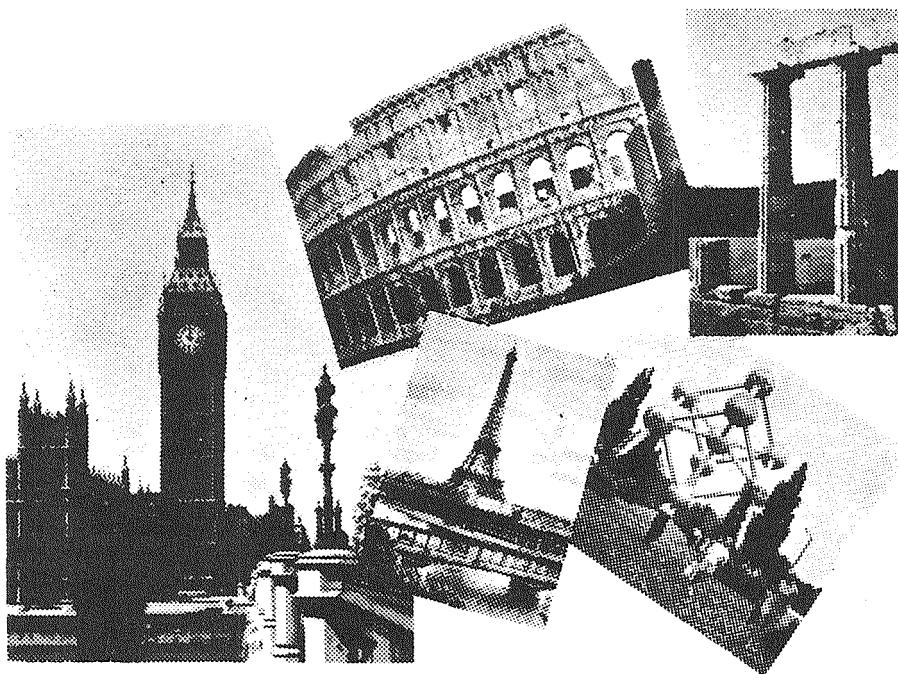

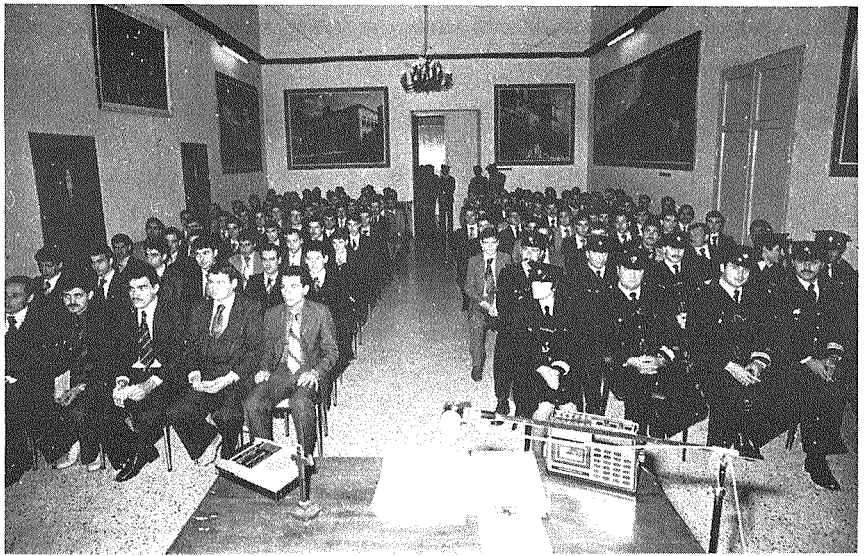

Dan naghmlu bla serhan, basta naf li jkolli nies li nista niddependi fuqhom, basta naf li ghandi sisien sodi l' fuqhom nista nibni Korp shih u efficjenti biex nigarantixxi lil min ihaddmna illi qeghdin naghtu l-iktar u l-ahjar ghall-gej-jieni sabih ta' pajjizna. Irrid nghid ukoll lil dak illi jibza, lil dak illi ma jhossux li jista jghinni u lil shabi l-ufficjali l-ohra f'dan ix-xoghol taghna, illi ahjar jahsibha darbtejn qabel ma jkompli fis-servizz tieghu. 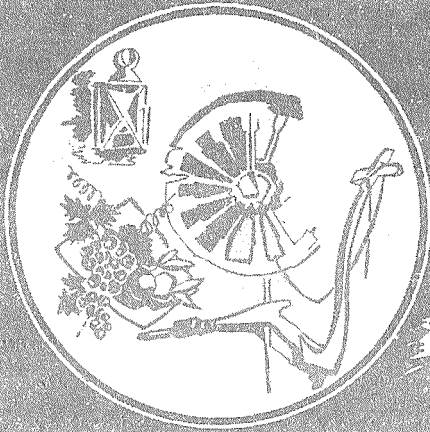

ID-DROGI li fuqhom sejr in nit-kellmu f'dawn l-artikoli jistghu jinqasmu f'hames kategoriji. Fl-istess hin ahna jkollna ideja agornata tar-regolamenti li jezistu f'Malta dwar il-kontroll tal-medicini.

Id-Drogi Perikoluza

F'din il-lista nsibu l-kokaina, il-haxixa, l-oppju, il-morfina, il-heroina, methadone, pethidine, etc.

Minbarra l-kokaina u l-haxixa, d-drogi l-ohra huma wzati biex imewtu l-ugiegh u jnisslu l-irqad fil-pazjent.

Meta jintuzaw bil-ghaqal mit-tobba kif indikati mix-xjenza medika, dawn il-medicini huma verament meraviljuzi, ghax inisslu kalma, jmewtu l-ugiegh u l-pazjent ikun jista jistrieħ u jaffronta bil-kalma kollha kwal-unkwe marda serja li jkun qed isofri.

Dawn id-drogi huma msejhin perikoluza ghaliex jehtiegu kontroll ghaqli tat-tabib fl-uzu taghhom, u meta jigu abbużati minghajr il-parir u l-kontroll tat-tabib, inisslu herba fis-sahha tal-pazjent kif ghad nistudjaw flimkien aktar il-quddiem.

Il-Medicini Ristretti

Fi Frar tal-1976 hareg l-Avviz Legali Nru. 31 li permezz tieghu l-medicinali li jissemmew fl-ewwel skeda ghandhom jitqiesu ristretti fis-sens li ebda persuna ma tista timporta, timmanifattura, tesporta, tixtri, tbiegh, tuza jew ikollha fil-pussess taghha xi wahda minn dawn il-medicini minghajr awtorizzazzjoni speċjali mis-Suprintendent tas-Sahha Pubblika.

Is-Suprintendent ma ghandux jaghti permess biex tintuza xi medicina ristretta hliet f'kazijiet speċjali għall-ghanijiet xjentifici jew għal ghanijiet medici limitati hafna fi stabbilimenti medici jew xjentifici taht il-kontroll tal-Gvern jew appruvati b'mod speċjali mis-Suprintendent.

Illum dawn il-medicini ristretti ma jintuzawx mit-tobba u l-uzu taghhom huwa dejjem marbut ma abbuż. F'Malta l-aktar li qed tigi abbużata hija l-haxixa jew qanneb Indjan maghrufa bl-isem xjentifiku ta' **Cannabis Sativa**. F'din il-lista nsibu wkoll id-droga peri-

oluza maghrufa bhala **L.S.D.** li sallum ghadha ma dahlitx f'Malta.

Il-Medicini Specifikati

Dawn huma msemmija fit-tieni skeda tar-regolamenti tal-1976. Il-medicinali msemmija f'din l-iskeda jinhtiegu ricetta tat-tabib.

Billi f'Malta kellna xi abbużi mill-medicinali tal-amfetamina methaqualone u methyl-phenidate, fit-22 ta' Dicembru 1978 permezz tal-Avviz Legali Nru. 127, dawn il-preparati u oħrajn jixbhuhom, bdew jinhtiegu l-awtorizzazzjoni mis-Suprintendent tas-Sahha Pubblika qabel ma tinghata ricetta. L-abbużi kwazi waqfu għal kollox permezz ta' dawn ir-regolamenti.

Medicinali oħra li mumhiex kontrollati bir-regolamenti l-fuq imsemmija jistghu jinxtraw minn spizeriji minghajr ricetta. Għalkemm dawn il-medicinali ma jsirx abbuż bihom, izda f'it taghrif fuq l-uzu taghhom huwa essenzjali mhux biss bhala taghrif generali, izda ukoll f'relazzjoni ma' saħhitna kif ghad naraw il-quddiem.

L-alkohol jew spirtu u mbejjed ecc., li għalhemm ma jinhtiegu ebda ricetta biex jinxtraw għandhom jitqiesu bhala droga — għaliex meta jittieħdu bl-addoc u minghajr kontroll inisslu hsara fil-fiziku u fil-mohħ daqs id-drogi li semmejna aktar il fuq.

Għalkemm it-tabakk fih sustanzi kimici li huma drogi wkoll, kulhadd jaqbel li l-uzu tat-tabakk jenhtieg jitqies u jigi studjat għalih, għaliex huwa fenomenu differenti mid-drogi u x-xorb. Għalhekk bi hsiebi nitkellem l-ewwel fuq id-drogi u x-xorb u zgur mintebhu kemm nistghu nitghallmu u nghallmu kif nevitaw perikoli li jtellfulna l-hena u l-paci f'hajjita, fil-familja u fis-socjeta Maltija. Kieku kulhadd jikkopera, f'Malta għandna facilitajiet kbar biex inxejnu dan il-gwaj li qed jagħmel tant hsara fid-dinja kollha.

L-Importanza ta' dan l-Istudju

Jekk nistudjaw il-figuri ta' mewt, kawzati minn accidenti u suwiciċidju fid-dinja kollha, fil-fjur taz-zoghzija, nintebhu malajr mill-importanza ta' dan l-istudju. Kemm accidenti u suwiciċidji kell-

hom il-bidu taghhom fl-abbuż tad-drogi u x-xorb?

Fis-sena 1973 gew registrati dawn l-imwied bejn l-etajiet ta' 15 sa 19-il-sena (A) u bejn l-etajiet ta' 20 sa 24-sena (B). Il-figuri juru l-persentagg għal kull mija l-mietu.

F'Malta fis-sena 1973 mietu 14 bejn il-15 u 19-il-sena u 16 bejn il-20 u 24-sena. Il-figuri ta' Malta għall-accidenti jinkludu wkoll kazi ta' suwiciċidju.

Semmejna dawn l-etajiet għaliex l-abbuż fid-drogi huwa komuni hafna fost iz-zghazagh u għaliex irrid intambar fuq il-htiega li ninqadew b'kull mezz possibbli biex nghallmu bil-kelma u bl-ezempju, biex jinqered dan l-abbuż li qed inissel stragi kbar fid-dinja kollha.

Fuq studji serji li saru fid-dinja kollha gew stabbiliti dawn il-fatti:

1. Habsin gew studjati rigward xorb u drogi f'relazzjoni mad-delitt li kkommettew. Gie stabbilit li x-xorb u d-drogi kellhom importanza fit-twettiq tad-delitt.
2. Rigward is-suwiciċidju gie stabbilit li x-xorb u d-drogi għandhom importanza kbira. Meta nistudjaw il-kawzi li jwasslu għal dan l-abbuż, naraw li huma l-istess kawzi li jwasslu għas-suwiciċidju anke meta ma jkunx hemra l-abbuż tax-xorb u tad-drogi.
3. Ma jezisti l-ebda dubju li mhux anqas minn 40 fil-mija ta' accidenti fatali stradali kemm rigward is-sewwieqa u kemm dawħ li jigu maqtula, jkunu dovuti għax-xorb u/jew drogi, Instab ukoll li r-rati ta' mwiet huma akbar għaz-zghazagh sewwieqa minn 18 sa 29-sena.
4. Meta nafu li l-vjolenza qegħda dejjem tikber fid-dinja, zgur li kulhadd jaqbel li huwa essenzjali li x-xorb u d-drogi għandhom jigu kkontrollati bl-akbar għaqal sabiex ma jnaqqasx il-kontroll, u b'hekk ma jkomplix jgħinnu biex tikber il-vjolenza.

SEARCH AND RESCUE DOGS

THE IDEA of using dogs for mountain rescue work conjures up a picture of a big lumbering St. Bernard, complete with brandy cask, trudging through the snow of the Alps looking for someone to rescue. The origins of the modern mountain rescue dog go back a long way, in fact to the 17th century and the now legendary dogs of the famous St. Bernard Hospice on the Italy/Switzerland frontier. It is most likely that the St. Bernard dogs were originally brought to the Hospice to guard it against bandits and robbers. The dogs were not avalanche rescue dogs as we know them today but they were sent out in bad weather to meet stranded travellers, and then, by using their bulk, they would break a trail back through the snow and lead the traveller to the safety of the Hospice.

Swiss origins

The use of dogs at night in the First World War as 'Red Cross' dogs to find wounded soldiers in 'no man's land' and the use made of dogs in the London Blitz, led to four German Shepherd Dogs being trained by the Swiss Army in 1945 in avalanche rescue techniques. This was the start of the use of dogs for mountain rescue.

In 1963, Hamish MacInness, BEM, Leader of the Glencoe Mountain Rescue Team attended a course for rescue dogs and their handlers in Switzerland. On his return he adapted the training to suit the British Isles and in 1956 the Search and Rescue Dog Association was formed. Now there are Rescue Dog Associations in most mountain regions of the world, including the Iron Curtain countries. The standards and training of the dogs are controlled by the International Federation of Rescue Dog Associations, which has its headquarters in Vienna. Since its formation in the British Isles the SARDA has become so large that it has divided into three ranches, England, Scotland and Wales. The branches work very closely together but each is responsible for its own training programme and fund raising. There are nearly sixty dogs based in mountain and moorland areas throughout the British Isles.

Abroad, the most widely used breed for rescue work is the German Shepherd Dog (Alsatian) but in this country Collies and Labradors have been used with success. The main qualities for a rescue dog are, a good nose, a good coat — to enable it to stand the worst of winter weathers, and that it is big enough to be able to negotiate deep snow and difficult terrain. The rescue dog depends on air scent to locate the missing person.

Training Courses

Each winter, the Association runs initial training courses in Glencoe, the Lake District and Snowdonia for novice dogs. Before being accepted on the course the dogs must have a good grounding in obedience and must normally be at least 12 months old.

The courses are held in the winter so that both avalanche search techniques and open country searching can be taught. The handler and dogs undergo a stock test — to judge their reaction to livestock. Should any dog fail any of the requirements it will not be certified by the Association. The sequence of training for avalanche rescue is the same throughout the world and consists of a number of 'burials' in the snow. It starts with the handler being buried under a light covering of snow. Then the dog is released to find its handler. On finding the handler, the dog is encouraged to dig down to him and to bark to indicate the find. The idea of digging is to let air through to the trapped person as the handler may be some distance away. The dogs nearly always go to the head as this is the area with the strongest scent. The finding of the handler is followed by the handler again being buried together with an assistant, the assistant lying on top of the handler so that the dog has first to locate the assistant before it gets to the handler. This is followed by the assistant being buried alone and finally a complete stranger being buried. From this point the distance the dog has to search and the depth of the burials are gradually increased. Dogs have been known to locate persons

buried in snow up to a depth of twelve feet.

On completion of its initial training the dog is attached to a local rescue team for use in search operations. Every two years the dog returns to the winter course to be either upgraded or retested as well as attending local training sessions throughout the year.

Fastest Method

A dog is still the fastest method known to man for locating an avalanche victim. At a recent demonstration a person was buried in a 25 yard square area of snow. The fastest time taken to locate the victim using conventional search methods was eight minutes. It took a rescue dog just 30 seconds to find the victim and to start to dig down to him. In summer search work in open country one dog is equal to twenty trained searchers and in conditions where the victim is likely to be covered with snow its potential is much greater.

The Search and Rescue Dog Association is affiliated to the Mountain Rescue Committee and the service is given free of charge. Like most mountain rescue teams the Association is a registered charity and it depends on public donations to exist.

The attitude of police authorities and chief constables varies greatly. Some forces send their police dogs to our courses for training in mountain rescue work whilst others pay an allowance to a policeman who owns a dog

which he makes available for mountain rescue. In some areas the handler is able to attend rescues whilst he is on duty and he is paid overtime for rescues attended in his off duty hours, in other areas all rescue call-outs must be undertaken in the handler's own time at his own expense. During the past year the Scottish Home and Health Department has lent the Association an ex-WD Ford signals van on a long term loan. This vehicle is based in Scotland for use in search operations and is equipped so that it can be used as a personnel carrier, an ambulance or as a base control vehicle. Although the primary use of the rescue dog is in mountain rescue, the training of the dog does equip it for other uses.

Last year dogs were called to search woodland and parkland for missing children on a number of occasions, and dogs based in Scotland were required to search a river bank for a missing angler. A dog located the angler's rod, indicating the place where the angler had fallen into the river. His body was later recovered by frogmen.

Emergencies

Other uses of the rescue dog are for searching scenes of disaster such as bombed or demolished buildings, earthquakes, aircraft and train crashes, locating survivors and injured persons. Rescue dogs will respond immediately to an emergency call and anyone may summon a life-saving team by contacting the local police.
