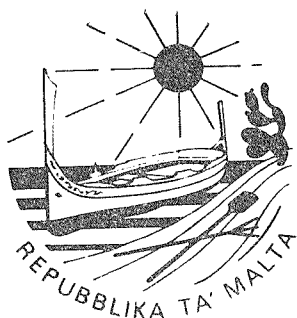

Citation and
commencement.

1. This order may be cited as the Judges and Magistrates (Revision of Salaries) Order, 1976, and shall be deemed to have come into force as shown on the 1st April, 1976.

**President of Malta and other Officers (Revision of Salaries)
Order, 1976**

IN exercise of the powers conferred by sections 2 and 3 of the President of Malta and other Officers (Salaries) Act, 1965, hereinafter referred to as "the Act", the Prime Minister has made the following order:

Citation and
commencement.

1. This order may be cited as the President of Malta and other Officers (Revision of Salaries) Order, 1976, and shall be deemed to have come into force on the 1st April, 1976.

Revision of
the President's
salary.

2. There shall be paid in any year to the President of Malta, instead of the salary prescribed by section 2 of the Act, a salary of five thousand six hundred and ninety-five pounds.

Revision of
other Officers'
salaries.

3. There shall be paid to the holders of the officers specified in the first column of the Schedule hereto, instead of the salaries prescribed by section 3 of the Act, the annual salaries respectively specified opposite to each such office in the second column of that Schedule.

**FINANCIAL ADMINISTRATION AND AUDIT ACT, 1962
(ACT NO. I OF 1962)**

Director of Audit (Revision of Salary) Order, 1976

IN exercise of the powers conferred by subsection (1) of section 6 of the Financial Administration and Audit Act, 1962, hereinafter referred to as "the Act", the Prime Minister has made the following order:

Citation and
commencement.

1. This order may be cited as the Director of Audit (Revision of Salary) Order, 1976, and shall be deemed to have come into force on the 1st April, 1976.

Revision of
Director of
Audit's salary.

2. Without prejudice to the proviso to subsection (1) of section 6 of the Act, there shall be paid to the Director of Audit, instead of the salary prescribed in that subsection, the salary of three thousand and sixty-seven pounds per annum.
