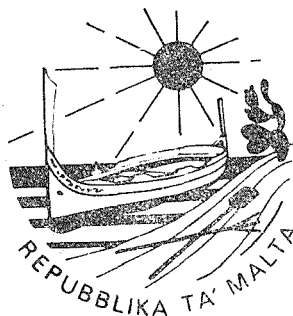

- (f) Telex Number

Each entry submitted must be signed by the manager of the agency concerned and must indicate clearly if the agency is only a travel agency providing furnished accommodation and/or an estate agency.

Those agents who in the past had submitted this information to the Tourist Board should do so again.
