ELIZABETH THE SECOND by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories **Queen, Head of the Commonwealth, Defender of the Faith, to Our Right Trusty and Right Entirely Beloved Cousin and Counsellor Bernard Marmaduke, Duke of Norfolk, Knight of Our Most Noble Order of the Garter, Knight Grand Cross of Our Royal Victorian Order, Earl Marshal and Our Hereditary Marshal of England.**

WHEREAS for the greater honour and distinction of MALTA We are desirous that Arms, Crest and Supporters be assigned for that Territory.

ELIZABETTA T-TIENI għall-Grazzja t'Alla tar-Renju Unit tal-Gran Britannja u ta' l-Irlanda ta' Fuq u tar-Renji u t-Territorji l-oħra Tagħna, **Regina, Kap tal-Commonwealth, Difenditriċi tal-Fidi, lill-Wisq Fdat u l-Wisq Maħbub Kugin u Kunsillier Tagħna Bernard Marmaduke, Duka ta' Norfolk, Kavalier tal-Wisq Nobbli Ordni Tagħna tat-Takkalja, Kavalier Gran Kruċ ta' l-Ordni Irjali Tagħna Vittorjan, Earl Marshal u Marixxal Tagħna Ereditarju ta' l-Ingilterra.**

Sliem!

BILLI għall-akbar gieh u distinzjoni ta' MALTA Ahna nixtiequ illi Armi, Cimjier u Sostenji jigu mogħtija lil dak it-Territorju.

KNOW YE THEREFORE that We of Our Princely Grace and Special Favour have granted and assigned and by these Presents do grant and assign the following Armorial Ensigns for MALTA that is to say: For Arms: **Per pale Argent and Gules in dexter chief a representation of the George Cross proper fimbriated Gules:** And for the Crest, **Upon a representation of Our Royal Helmet mantled Gules, doubled Argent;** On a Wreath of the Colours: **A Mural Crown with a Sally Port the embattlements turreted of eight octagonal Turrets Or;** And for Supporters: **On either side a Dolphin, the dexter supporting with the fins an Olive branch and the sinister likewise supporting a Palm branch all proper and upon a compartment of Water Barry wavy issuing therefrom a Rocky Mount proper charged with a Maltese Cross Argent,** together with the Motto VIRTUTE ET CONSTANTIA, as the same are in the painting hereunto annexed more plainly depicted, the whole to be borne and used for MALTA on Seals or otherwise according to the Laws of Arms.

Our Will and Pleasure therefore is that you the said Bernard Marmaduke, Duke of Norfolk to whom the cognizance of matters of this nature, doth properly belong do require and command that this Our Concession and Declaration be recorded in Our College of Arms to the end that Our Officers of Arms and all other Public Functionaries whom it may concern may take full notice and have knowledge thereof in their several and respective Departments.

And for so doing this shall be your Warrant.

GIVEN at Our Court at Buckingham Palace this Second day of September, 1964: In the Thirteenth year of Our Reign.

Għaldaqstant huwa r-Rieda u l-Pjaċir Tagħna illi inti l-imsemmi Bernard Marmaduke, Duka ta' Norfolk, li lilek kif jixraq, tappartjeni l-kompetenza f'materji ta' din in-natura, trid u tor-dna illi din il-Konċessjoni u d-Dikjarazzjoni Tagħna tiġi registrata fil-Kulleġġ Tagħna ta' l-Armi sabiex l-Uffiċjali Tagħna ta' l-Armi u l-Funzjonarji Pubbliċi l-oħra kollha li jistgħu jkunu konċernati jsiru mgħarrfin u jkunu jafu sewwa dwarha fid-Dipartimenti diversi u rispettivi tagħhom.
