The Public Service Commission invites applications for the post of *Lecturer in Commerce* in the above College of the Department of Education. Applications which must be accompanied by certificates of birth and of police conduct and testimonials relating to qualifications and experience, will be received in the first instance by the Director of Education, 141, St. Christopher's Street, Valletta, not later than noon of Tuesday, 10th November, 1964.

2. In addition to an application including a sample of the candidate's own handwriting, six copies of a summary of qualifications, experience and other information should be tabulated in a special form (M.C.A.S.T., 95) obtainable from the Education Office on request.

3. The post of *Lecturer* is on the Pensionable Establishment and carries a salary of £980 per annum rising by annual increments of £30 to £1010.
