The Public Service Commission invites applications for the post of Inspector of Wireless Telegraphy in the Wireless Telegraphy Branch of the Office of the Prime Minister.

2. The post is on the Pensionable Establishment and carries a salary of £M1,360 per annum (minimum linked with 4 years experience) rising by annual increments of £M45 to £M1,495 and thereafter by £M55 to £M1,810 per annum. This salary is subject to review on Reorganisation. In the case of an appointee who is a Member of the Institution of Electrical Engineers (with Radiocommunication as a special subject) or who has an equivalent professional qualification of a recognised Radio and/or Electronic Institution obtainable by examination, the scale will be £M2,036 per annum (minimum linked with 5 years experience) rising by annual increments of £M56 to £M2,316 per annum. This salary is subject to review on Reorganisation. The approved cost of living increase of £M1.50 per week will be paid, in addition to the above mentioned salary scales.
