COMMONWEALTH SCHOLARSHIPS AND FELLOWSHIP PLAN  
SCHOLARSHIPS TENABLE AT THE UNIVERSITY OF HONG KONG

The Hong Kong Government proposes to award two two-year scholarships each for post-graduate study or research. These scholarships will be tenable at the University of Hong Kong. Applications are now invited for two scholarships to be awarded for 1966-1968.

Single scholars will be accommodated in University Halls of Residence and will pay the usual charge, which the maintenance allowance will cover. An additional maintenance allowance of £80 per month will be paid to a married scholar (who will have to find his own accommodation) provided that he is married at the time of submitting his application. His wife's passage also will be paid for only on the same condition.

The University expects that, by early 1966, the Robert Black College (a new residential college for visiting scholars and research workers) will be in operation and that single Commonwealth Scholars will be offered accommodation there. There is also a limited number of small suites suitable for married couples without children.

*Eligibility*

Candidates must be Commonwealth citizens, and possess a University degree. They must be under 35 on 1st October 1966.

Candidates whose native language is not English will be required to produce satisfactory evidence that they have sufficient competence in English.

Scholars will be expected to reside in Hong Kong throughout the period of tenure of the scholarship, though they may leave for short periods with the permission of the University authorities. They may not undertake paid employment without the written consent of the Hong Kong Government.

A scholar is expected to undertake to pursue a course of study set by the Senate of the University after consultation with him and with the nominating country.

### *Immigration*

Scholars must comply with the normal requirements.

### *Further Information*

Further information about Hong Kong Universities and technical institutions and about courses of study available at them may be obtained from the Commonwealth Universities Yearbook which is available for perusal at the Education Office, 141, St Christopher Street, Valletta.

### *Nominations*

No nominations will normally be made in respect of candidates who have been on scholarship at any time during the three years previous to the commencement of this scholarship.

### *Method of application*

Preliminary applications by letter will be received by the Director of Education, 141, St Christopher Street, Valletta, by not later than noon of Friday, 26th November, 1965.

In addition to an application in the candidate's own handwriting a summary of qualifications, experience and other information should be tabulated in eight copies of a special form obtainable from the Education Office on request. Applications not fully completed may not be considered.

A short-list of applications will be prepared by the Local Commonwealth Committee and only candidates appearing on the short list will be requested to attend for interview.

The Public Service Commission invites applications for the post of Assistant Lecturer, Grade B, in Mathematics in the above College of the Department of Education.
