



SUPPLIES AND SERVICES ACT, 1947

(ACT NO. IV OF 1947)

Importation (Control) (Amendment) (No. 12) Regulations, 1978

IN exercise of the powers conferred by section 3 of the Supplies and Services Act, 1947, the Minister of Trade has made the following regulations:—

Citation and commencement.

L.N. 48 of 1969.

1. (1) These regulations may be cited as the Importation (Control) (Amendment) (No. 12) Regulations, 1978, and shall be read and construed as one with the Importation (Control) Regulations, 1969, hereinafter referred to as "the principal regulations".

(2) These regulations shall come into force on the day immediately following the date of their publication in the Gazette.

Amends Schedule to the principal regulations.

2. Immediately after the item "Savoury Snacks with a base of potatoes, maize or rice", in the Schedule to the principal regulations there shall be inserted the item "Seed of all species of Cannabis — unwashed".
