POLICE NOTICE

[No. 60]

Permission having been granted for the holding of races at Rabat, Malta, on the 29th June, 1975, the Commissioner of Police in virtue of Section 31 (1) (f) of the Code of Police Laws (Chapter 13) has issued the following orders:—

1. No animal shall take part in any race unless it has been registered by the owner. Registration shall be made in Malta at the Police Headquarters, Floriana, between the hours of 9 a.m. and 1 p.m. on the 14th, 16th or the 17th June, 1975.

2. No animal shall be allowed to take part in the races unless provided with a snaffle.

3. Every animal competing in the races shall have a number round the neck. Such number will be allotted to it by the Police when the animal is registered.

4. The use of goads or other pointed instruments is forbidden.

5. No person below the age of 18 years shall act as a jockey if objection is raised by either of his parents or by his guardian.

6. No one shall lead the animals to the starting point until the order to do so has been given by the Police Officer charged with that duty. No other person shall be near the starting post without the permission of the Police.

7. The starting signal shall be given by a Police Officer by the firing of a pistol.

8. Jockeys shall not use any unfair means to prevent other jockeys from overtaking them.

9. No one shall be allowed to stop at the winning post an animal competing in the races, unless he has been re-

10. The winning post shall be indicated by a red flag.

11. No prize shall be awarded to animals passing the winning post without a jockey or without a distinctive number.

12. The decisions of the Commissioner of Police, taken in his discretion after consultation with the starters, judges, and any course stewards appointed by him, shall be final, whether the races shall be ordinary or extra races.

13. Any jockey infringing these Regulations shall be disqualified and the owner of the animal shall forfeit any prize he may have won in the races. The Commissioner of Police shall have discretion to order that any disqualified jockey shall not ride in any later race or races on the same day.

14. Every jockey must be decently dressed to the satisfaction of the Commissioner of Police. Any jockey not so dressed shall not be allowed to ride in any race.

15. No one shall molest the jockeys or interfere in any way with the races.

16. The races shall be run on the usual course and shall commence at 6 p.m.

17. All vehicular traffic will be suspended on the racecourse on the day of the races from 5 p.m. until the termination of the races.

Examination for Temporary/Substitute Postmen

The Registrar, Board of Local Examinations, notifies that a competitive examination for employment of not more than 30 Temporary or Substitute Postmen will be held in July, 1975.

2. This post which confers eligibility for promotion to the pensionable establishment carries a salary scale of £612 rising by annual increments of £M36 to £M900 per annum plus a cost of living bonus of £M3.50 per week. Successful candidates will be engaged in accordance with the order of merit obtained in the examination. For the purpose of employment the result will hold good for a period of twelve months from the date of publication. Temporary/Substitute Postmen employed in virtue of this examination will be eligible to fill vacancies of Postmen in Malta, and may be transferred to Gozo according to the exigencies of the service. They would also be required to ride a bicycle and drive a motor cycle, a car or a van. Unless they already possess such abilities, the Department of Posts will provide the necessary instruction.

3. Candidates must:—

- (a) be citizens of Malta;
- (b) be of good moral character;
- (c) be free from any physical or mental defect or disease likely to interfere with the proper discharge of their duty;

(d) have attained their eighteenth but not their twenty seventh birthday on the first day of the month of the examination, provided that if the candidate is already in the Government Service the maximum age limit may be extended to 33 years by setting off his continuous service against any excess of age over 27;

(e) produce a police certificate of conduct, their birth certificate, together with certificates of parents and paternal grandfather showing the place of birth.

Composition (i.e. *essay*, letter writing, etc.), Translation from Maltese, Comprehension Tests.

(B) MALTESE — Max. 100 Min. 50
Grammar, Composition, Translation from English.

(C) ARITHMETIC Max. 100 Min. 50
The subject matter covered by the paper will be that taught in local secondary schools.

(D) GEOGRAPHY Max. 100 Min. 50
Questions on the principal sea and air routes of the world, the principal towns and commercial centres of the world, the Mediterranean littoral and Europe in particular, the British Commonwealth and the U.S.A.

(E) ITALIAN/FRENCH

Max. 100 Min. 50

(Candidates to choose one language).

Composition, Translation from English.

INTERVIEW — Max. 100 Min. 50

Designed to bring to the fore those personal qualities, such as personality, alertness, intelligence, etc., required of a postman and not necessarily showing up in the written test.

7. In order to qualify, candidates must obtain the minimum number of marks in each of the above written subjects and in Part II — Interview.

8. In the case of candidates who in the final results are awarded the same number of marks, previous service with Government and, if this will not form an establishing factor, age will then be taken into account in fixing priority for appointment and seniority.

9. The examination shall be conducted by a panel of examiners under the direction of the Board of Local Examinations.

10. The Board of Local Examinations shall have the power to deal summarily with any candidate who, while the examination is in progress, is found to be guilty of misconduct or of any candidate who, while the examination is in progress, is found to be guilty of misconduct or of any breach of the instructions issued for the guidance of candidates.

11. The Board of Local Examinations reserves the right to annul the examination if any irregularity is detected in connection therewith. Such annulment may be in respect of the whole examination even if the detected irregularity is in respect of only one subject or a particular stage of the examination.

12. Candidates who are bound by an agreement of apprenticeship may be precluded from appointment unless they produce the consent in writing of their employer and of the Director of Labour and Emigration.

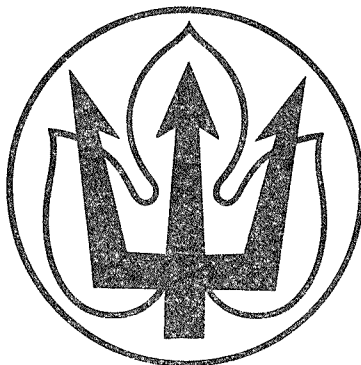
