ACQUISITION OF LAND

The following declaration made by His Excellency the Acting Governor General under section 3 of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) is published in terms and for the purposes of section 8 (1) thereof.

6th August, 1967.

DECLARATION BY THE ACTING GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land
