NOTICES**Order No. 1 of 1967 by the Director of Agriculture**

(Under Regulation 6 of the Tomato Paste and Sale of Tomatoes for Processing Purposes (Control) Regulations, 1957).

1. In this Order "manufacturer" "pitkal", "producer" "purchase" and "society" shall have the meaning assigned to those expressions in the Tomato Paste and Sale of Tomatoes for Processing Purposes (Control) Regulations 1957, published by Government Notice No. 424 of the 10th July, 1957.

2. When tomatoes are purchased by a manufacturer directly from a producer, the following prices and conditions shall apply:—

(a) the minimum price for the Ribbed and Round -/1ld, and for the oval 1s./ld. per wiżna.

(b) the producer shall deliver the tomatoes to the manufacturer free of transport charges.

(c) the manufacturer shall not make any charge for containers which may be provided by him, but he may exact from the producer a deposit of a fair amount representing the value of the container.

(d) every manufacturer shall return to the producer, immediately after the delivery of the tomatoes any container which may have been provided by the producer for such tomatoes.

3. When tomatoes are purchased by the manufacturers through a pitkal or society the minimum price shall be $\frac{1}{2}$ d. less per wiżna than that stated under 2(a) above and the following conditions shall apply:

(a) the producer shall bear transport expenses to the pitkal or society; the manufacturer shall bear transport expenses from the pitkal or society.
