#### CODE OF ORGANIZATION AND CIVIL PROCEDURE (CAP. 15) CRIMINAL CODE (CAP. 12)

#### Duties of Her Majesty's Judges

IN exercise of the powers conferred by section 11 of the Code of Organization and Civil Procedure (Chapter 15) and by sections 508A and 513 of the Criminal Code (Chapter 12), His Excellency the Governor-General has directed that the following arrangements be made regarding the duties of Her Majesty's Judges in the Courts hereunder mentioned with effect from the 1st October, 1967.

**HER MAJESTY'S COURT OF CRIMINAL APPEAL**

The Honourable Mr. Justice Professor J.H. Xuereb LL.D., will sit in Her Majesty's Court of Criminal Appeal with His Honour the Chief Justice and President of that Court, and with the Honourable Mr. Justice Professor J.J. Cremona B.A., LL.D., D.Litt. (Rome), B.A. (Hons.) (Lond.), Ph.D. (Lond.), F.R. Hist. S., Vice-President of Her Majesty's Constitutional Court.

Whenever any member of the said Court is precluded by law or is incapacitated from sitting by reason of illness or absence from these Islands, the Honourable Mr. Justice A. Gauci Maistre will sit instead.

His Honour Mr. Justice J. Flores B.L. Can., LL.D., will sit in Her Majesty's Court of Criminal Appeal for the hearing of appeals from decisions of the Courts of Magistrates of Judicial Police in their criminal jurisdiction and, whenever he is precluded by law or is incapacitated from sitting by reason of illness or absence from these Islands, the Honourable Mr Justice J.J. Cremona B.A., LL.D., D. Litt. (Rome), B.A. (Hons.) (Lond.), Ph. D. (Lond.), F.H. Hist. S., Vice-President of Her Majesty's Constitutional Court, will sit instead.
