3. The designated importers will proceed with importing commodities from China by signing contracts with the China National Import and Export Corporations (or their Branches).

4. The said contracts shall provide:

“The Maltese organizations shall establish with their respective banks in Malta confirmed, irrevocable letters of credit in favour of the China National Import and Export Corporations (or their Branches).”

5. All the said contracts and letters of credit shall stipulate: “Upon the receipt of the shipping documents sent by the Bank of China, the Issuing Bank shall immediately pay the value of the goods to the Central Bank of Malta to be credited to the 'Special Account of Local Expenses under Economic and Technical Cooperation between China and Malta' (hereinafter referred to as the 'Special Account of Local Expenses') and inform the Central Bank of

8. On the 27th December, 1972 the Importation (Control) Regulations, 1969, were amended so as to provide for an import licence to be required in respect of *all* imports from the People's Republic of China. In view of the new procedure outlined in paragraphs 2 to 6 above, the amendment is no longer considered necessary, and the Importation (Control) Regulations are accordingly being altered so as to revert to the position as it stood before the 27th December, 1972.
