In virtue of section 81 (1) of the Code of Police Laws (Chapter 13), the Commissioner of Police notifies that the following traffici arrangements will Wied Gerżuma, limits of Rabat from 1.00 p.m. onwards on Sundays, 14th and 21st December, 1975, respectively.

RABAT

All vehicles, except buses, proceeding to Wied Gerżuma (Il-Kuncizzjoni) from the direction of Rabat will approach from the direction of Saqqajja, Museum Road, Museum Esplanade, Għerixem/Mtarfa Road Junction or from Mtarfa to Għerixem/Mtarfa Road Junction, and thence, in both cases, through il-Biċċerija Road, Fiddien Bridge, Bieb ir-Rua Road, Baħrija Road and Il-Kuncizzjoni Road or through Fiddien Bridge, Mtaħleb Road, Wied Rini Road, to Baħrija Road and temporary car track through "Ta Borgu" Road to Kuncizzjoni Road or as directed by the Police.

Vehicles proceeding to Wied Gerżuma (Il-Kuncizzjoni) from the direction of Mġarr/Bingemma Road will proceed to Wied Gerżuma via Bingemma Road towards Il-Kuncizzjoni or as directed by the Police.

Buses will in all cases proceed to Wied Gerżuma via Museum Road, Museum Esplanade, Għerixem Road, Ta' Slampa Road, Biċċerija Road, Fiddien Bridge, Bieb ir-Rua Road, Baħrija Road and Il-Kuncizzjoni Road and vice versa.

All vehicles, except buses, travelling to Wied Gerżuma (Il-Kuncizzjoni) will proceed through Il-Kuncizzjoni Road and from thence either to Tas-Salib Road and Bingemma Road or through Bieb ir-Rua Road, Fiddien Bridge, Biċċerija Road, Ta' Slampa Road, Mtarfa Road towards Mosta or as directed by the Police.

The abovementioned routes will be one-way as specified above except where otherwise directed by the Police.
