**CLOSING TIME OF RESTAURANTS
AND WINES AND SPIRITS SHOPS
DURING CHRISTMAS EVE AND
NEW YEAR'S EVE**

IN exercise of the powers conferred by Section 170 of the Code of Police Laws, the Prime Minister has authorised that restaurants and shops licensed to sell wines, beer and spirituous liquors may remain open all night on the 24th/25th December, 1975, and on the night of the 31st December, 1975/1st January, 1976, provided that applications are made to the competent authorities and the prescribed fee is paid.

In virtue of Section 81 (1) of the Code of Police Laws (Chapter 13), the Commissioner of Police notifies that the transit of vehicles through the streets mentioned hereunder will be suspended on the date and hours indicated in connection with an International Football Match between Malta and Bulgaria at the Stadium, Gżira.

On Sunday, 21st December, 1975, from 12.30 p.m. onwards, vehicular traffic other than Sliema Route Buses will not be allowed to make use of the following streets:—

- (a) Rue D'Argens, between Bishop Caruana Street, Msida and Sliema Road, Gżira;
- (b) St George's Street, Gżira;
- (c) Msida Road, between Rue D'Argens and Testaferrata Street, Gżira.

During the hours when traffic restrictions are in force, no parking will be permitted in the following streets, except for cars with CD or MG number-plates, and vehicles bearing screen label "STADIUM" issued by the Management of the Gżira Stadium.

(d) Rue D'Argens, Msida, between Msida Roundabout and Bishop Caruana Street, towards Gżira, only;

(e) Testaferrata Street, Msida, in the direction of Sliema;

(f) Msida Road, Gżira, in the direction of Sliema;

(g) Ta' Xbiex Coast Road, Msida, in the direction of the Parish Church, Msida.

SUPPLIES AND SERVICES ACT, 1947
(ACT No. IV OF 1947)

Importation (Control) (Amendment) (No. 18) Regulations, 1975

IN exercise of the powers conferred by section 3 of the Supplies and Services Act, 1947, the Minister of Trade, Industry and Tourism has made the following regulations:—

Citation and commencement.

1. (1) These regulations may be cited as the Importation (Control) (Amendment) (No. 18) Regulations, 1975, and shall be read and construed as one with the Importation (Control) Regulations, 1969, hereinafter referred to as “the principal regulations”.

(2) These regulations shall come into force on the day immediately following the date of their publication in the Gazette.

Amends the Schedule to the principal regulations.

2. The Schedule to the principal regulations shall be amended:

(a) by the insertion of the item “Blinds of whatever material” immediately before the item “Brooms, floor”;

(b) by the deletion of the item “Candied peel” and by the substitution therefor of the item “Candied peel, candied fruit and/or candied vegetables”;

(c) by the insertion of the item “Toys and fancy articles containing any substance which represents a hazard to health, even if a caution is included on any label or wrapper or container” immediately after the item “Towels, sanitary”; and

(d) by the deletion of the item “Venetian blinds”.
