REDEMPTION OF STOCK: The stock shall be redeemed at par on such date between the 1st January, and the 31st December, 1974 (both dates inclusive), as shall be determined by the Accountant General and notified in the Government Gazette. Stock shall be redeemed only on the surrender of stock certificate issued.

5. PROVISION FOR REPAYMENT: The Government is required by the provisions of the Local Loans (Registered Stock and Securities) Ordinance, 1959 to provide for the formation of a sinking fund towards the redemption of the stock. The first half-yearly appropriation of not less than £2,500 out of the general revenue and assets of the Government of Malta will be made as a contribution to the sinking fund within three years from the 8th day of March, 1969, followed by further appropriations in each subsequent half year ending with the date specified for the payment of the half-yearly interest on the stock now being issued.

6. SECURITY: The stock and interest thereon will be a charge on the general revenue and assets of the Government of Malta.

7. RELEVANT LEGISLATION: The Development Local Loan Act, 1965, the Local Loans (Registered Stock and Securities) Ordinance, 1959 and directions by the Minister of Finance, Customs and Port under section 6 of this Ordinance and the Local Loans (Registered Stock) Regulations, 1959.
