IS-SEGRETARJU tad-Djar u *Chairman* ta' l-Awtorità tad-Djar javża li qiegħed jirċievi offeriti għax-xiri 'tale quale' tal-bċejjeċ ta' art żviluppata jew żviluppata in parti li huma elenkati fl-iskema li tidher fl-aħħar ta' dan l-avviż.

2. (a) L-offerti jintlaqgħu minn koppji miżżewġin jew gharajjes li:
- huma ċittadini Maltin;
 - ilhom iġixu hawn Malta għal mhux anqas minn 18-il xahar qabel id-data ta' l-egħluq ta' l-applikazzjonijiet;
 - m'għad lix bżonn l-approvazzjoni tal-Ministru tal-Finanzi biex jakkwistaw biċċa art taħt l-iskema tal-'Home Ownership';
 - m'humiex proprjetarji tar-residenza tagħhom jew m'għandhomx xi biċċa art li fuqha nħareġ permess tal-PAPB;
 - fl-ebda żmien ma jkunu bbenefikaw minn skemi tal-'Home Ownership' u ddisponew minn din l-istess proprjetà 'inter vivos'.

(b) Barra minn hekk, fil-każ ta' koppji gharajjes, iż-żewġ partijiet irid ikollhom 'il fuq minn 18-il sena fid-data ta' l-egħluq ta' l-applikazzjonijiet.

SALE OF PARTLY DEVELOPED AND DEVELOPED HOME OWNERSHIP SCHEME PLOTS SURRENDERED BY BENEFICIARIES FOR DISPOSAL BY THE HOUSING AUTHORITY

THE SECRETARY – Housing and Chairman of the Housing Authority notifies that offers will be received for the purchase 'tale quale' of the developed/ partly developed plots listed in the schedule appearing at the end of this notice.

2. (a) Offers will be received from married persons and engaged couples who:—
- are Maltese citizens;
 - have been living regularly in Malta for not less than eighteen (18) months prior to the closing date for applications;
 - do not require the approval of the Minister of Finance to acquire a plot of land under the Home Ownership Scheme;
 - do not own their own residence or are in possession of a plot of land on which a PAPB permit has been issued;
 - had at no time benefitted from the Home Ownership Schemes and disposed of this property 'inter vivos'.

(b) Furthermore, in the case of engaged couples, both parties are to be over 18 years of age on the closing date for applications.

3. Il-biċċa art tiġi allokata taħt il-kondizzjonijiet elenkati fil-paragrafi 20 sa 50 (iż-żewġ paragrafi inklużi) tan-Notifikazzjoni tal-Gvern Nru. 647 (Id-9 Harga), kif ippubblikati fil-Gazzetta tal-Gvern Nru. 14,692 datata 19 ta' Diċembru, 1986. Madankollu, irrispettivament minn dak kollu li hemm provdud fil-paragrafu 24 ta' l-imsemmija Notifikazzjoni Nru. 647, l-applikant li jingħażel ikun marbut li jlesti l-bini għall-abitazzjoni u jokkupah sad-data li tidher fl-iskeda fl-aħħar ta' dan l-avviż.

4. Min ikollu l-offerta tiegħu għall-art u l-benefikati ta' fuqha aċċettata mill-Awtorità tad-Djar ikun intitolat għal sussidju fuq iċ-ċens skond il-'Kondizzjonijiet taċ-Ċens' kif jidhru fil-paragrafi 9 sa 19 (iż-żewġ paragrafi inklużi) fin-Notifikazzjoni tal-Gvern Nru. 647 datata 19 ta' Diċembru, 1986.

5. Min ikollu l-offerta tiegħu għall-art u l-benefikati ta' fuqha milqugħa mill-Awtorità tad-Djar irid iħallas:

(a) lill-benefiċjarju preżenti somma li ma taqbiż l-ammont li jidher fl-iskeda fl-aħħar ta' din in-Notifikazzjoni (dan l-ammont jinkludi stima ta' l-ispejjeż li ntefqu fil-benefikati, iżda jeskludi l-ispejjeż għal xogħlijiet magħmula għal xogħol ta' appoġġi u għal drittijiet professjonali);

(b) lill-Awtorità tad-Djar;

(i) id-differenza li biha l-offerta tiegħu taqbez l-ammont indikat taħt klawso 5(a);

u (ii) lawdemju ekwivalenti għal sena ċens kif applikabbli għall-kategorija tiegħu skond il-paragrafu 10 ta' l-imsemmija Notifikazzjoni tal-Gvern Nru. 647.

6. B'danakollu, il-hlas ta' xi talbiet li jirriżultaw minn:

(a) il-konvenju/kuntratt bejn l-Awtorità tad-Djar u l-benefiċjarji preżenti;

(b) ftehim għal self magħmul bejn Lohombus Corporation Ltd. u l-benefiċjarji preżenti;

(ċ) xi djun jew kontijiet pendenti ma' kuntratturi u terzi persuni oħra;

u li jistgħu jinqatgħu mill-benefiċjarju preżenti fid-data tat-trasferiment jitnaqqsu mill-ammont indikat fl-iskeda fl-aħħar ta' din in-notifikazzjoni u jithallsu b'mod kif indikat mill-Awtorità tad-Djar.

7. Spejjeż għal xogħol ta' appoġġi u drittijiet professjonali jridu jithallsu bi ftehim dirett bejn min jiġi aċċettat li jieħu l-offerta tal-biċċa art/benefikati u l-benefiċjarju preżenti, indipendentement mill-Awtorità tad-Djar.

3. The plot will be allocated to the successful tenderer subject to the conditions under paragraphs 20 to 50 (both paragraphs inclusive) as appearing under Government Notice No. 647 (9th Issue) published in Government Gazette No. 14,692 dated 19th December 1986. However, irrespective of the provisions of paragraph 24 of the above-mentioned Government Notice No. 647, the successful applicant shall be bound to finish the building ready for habitation and occupied by him as stated in the schedule hereunder.

4. The successful tenderer shall be entitled to a subsidy on the ground rent according to the 'Conditions of Ground Rent' as listed under paragraphs 9 to 19 (both paragraphs inclusive) in the above-mentioned Government Notice No. 647 dated 19th December 1986.

5. The successful tenderer shall be bound to pay:

(a) to the present beneficiary of the plot a sum of not more than the amount stated in the schedule hereunder (being the sum indicated in the Schedule of Works for expenses incurred on the improvements and which amount excludes expenses made for party walls and for professional fees.)

(b) to the Housing Authority:

(i) any amount tendered above the sum indicated under Clause 5(a) of these conditions;

and (ii) a 'laudemium' equivalent to one year's ground rent as applicable to the category of the successful tenderer qualifying under paragraph 10 in the above-mentioned Government Notice No. 647.

6. However, payments for claims arising out of:

(a) the Convegno/Deed entered between the Housing Authority and present beneficiaries;

(b) loan agreements entered between Lohombus Corporation Ltd and beneficiaries;

(c) and outstanding debts/bills by contractors and other third parties

and which may be still outstanding by the present beneficiary of the plot on the date of transfer, shall be deducted from the above amount and paid in the manner and as indicated by the Housing Authority.

7. Expenses made for party walls and for professional fees shall be settled directly by the successful tenderer and the present beneficiary, independently of the Housing Authority.

8. L-offerti mitfugħa jeskludu dawk l-ispejjeż kif jidhru taħt klawsoli 5, 6 u 7.

9. Min ikollu l-offerta tiegħu milqugħa mill-Awtorità tad-Djar ikun responsabbli għal xi talbiet oħra registrati minn terzi persuni wara li t-trasferiment relattiv ikun sar.

10. Bħala garanzija tal-pagamenti/obligazzjonijiet riżultanti minn dawn il-kondizzjonijiet, min ikollu l-offerta tiegħu milqugħa mill-Awtorità tad-Djar irid jipoteca favur l-Awtorità tad-Djar il-gid tiegħu kollu, preżenti u futur, u dan barra l-privileġġ speċjali skond il-liġi, f'dak iż-żmien u b'dak il-mod li l-Awtorità tad-Djar jidhriha xieraq.

11. Min ikollu l-offerta tiegħu milqugħa mill-Awtorità tad-Djar irid iħallas l-ispejjeż kollha li għandhom x'jaqsmu mat-trasferiment f'ismu tal-biċċa art u l-benefikati ta' fuqha.

12. L-offerti mitfugħa jibqgħu validi sa, u ma jistgħux jiġu rtirati qabel, xahrejn mid-data li fiha jagħlqu l-applikazzjonijiet.

13. L-offerti għandhom isiru biss fuq il-formola preskritta. Fuq din il-formola:

- (a) għandu jiġi indikat b'mod ċar in-numru ta' riferenza ta' l-offerta magħmula (li jittiehed mill-iskeda fl-aħħar ta' dan l-avviż);
- (b) għandha titwaħħlilha l-bolla kif meħtieġ;
- (c) għandha timtela kollha kif mitlub.

Magħha għandha tiġi annessa garanzija bankarja irrevokabbli, pagabbli fuq talba sempliċi a favur tas-Segretarju tad-Djar u *Chairman* ta' l-Awtorità tad-Djar, għall-ammont ta' hamsa fil-mija (5%) ta' l-offerta u dan biex iservi bħala 'bid bond'. 16. Min ikollu l-offerta tiegħu milqugħa mill-Awtorità tad-Djar jitlef l-ammont tal-'bid bond' u jeħel il-penali skond il-liġi kemm-il darba jonqos li jikkonkludi t-trasferiment f'ismu tal-biċċa art/benefikati meta jkun mitlub jagħmel dan mill-Awtorità tad-Djar.

8. The offers tendered shall exclude those expenses as listed under Clauses 5, 6 and 7.

9. The successful tenderer shall be responsible for all other claims registered by third parties after the relative transfer has been concluded.

10. As a guarantee of the above payments/obligations which result from these conditions, the successful tenderer shall hypothecate in favour of the Housing Authority his whole wealth, present and future and this besides the special privilege according to law in such time and manner as the Housing Authority may deem fit.

11. The successful tenderer shall pay all expenses in connection with the relative transfer of the plot to his name.

12. All offers tendered shall be retained valid and cannot be withdrawn before the lapse of at least two (2) months from the closing date for applications.

13. Offers are to be made on the prescribed forms which are the only ones admissible. The application forms are

- (a) to show clearly the reference number of the offer tendered for as indicated in the Schedule hereunder;
- (b) to be duly stamped;
- (c) to be filled in all respects.

Offers are to be accompanied by an irrevocable bankers guarantee payable on first demand to the Secretary – Housing and Chairman – Housing Authority for an amount of five per cent (5%) of the offer tendered as bid-bond. The bid-bond shall be valid for up to three (3) months from the closing date for applications. Failure to comply with these conditions may invalidate the offer tendered.

14. Application forms may be obtained from the Office of the Housing Authority, Auberge de Baviere, Valletta or from the branch of the Housing Authority at the Gozo Secretariat, Republic Street, Victoria, Gozo, on any working day during office hours.

15. Applications are to be deposited in the applications box at the Office of the Housing Authority, Auberge de Baviere, Valletta, by not later than noon of 24th April, 1987.

16. The successful tenderer shall forfeit the bid-bond and shall be liable to pay damages at law if he fails to conclude the relative transfer of the plot in his name as and when asked to do so by the Housing Authority.

17. L-Awtorità tad-Djar iżżomm id-dritt li tinterpreta dawn il-kondizzjonijiet u li tirrifjuta xi, jew kull, offerta mitfugħa, anki jekk din tkun l-aktar waħda vantaġġjuża.
