2. L-iskala tar-razzjon tal-hobz kuljum kull persuna se tkun kif ġej:—

6 — 10 snin	Kwart u nofs
10 snin jew fuqhom	Nofs artal

3. Is-sistema prezenti ta' għazliet, li permezz tagħha familji jistgħu jagħzlu li jixtru zokkor jew dqiq *extra* minflok dak kollu li huma intitolati għal hobz jew għagin, qiegħda tiġi mibdula b'sistema ġdida ta' għazliet, li permezz tagħha familji jistgħu jagħzlu li jirċievu flus minflok dak li huma intitolati (jew parti minn dak li huma intitolati) għal hobz, zokkor u/jew għagin.

4. Il-familji li jagħmlu użu minn din l-għażla se jithallsu kif ġej:—

(a) 1c6 għal kull ratal hobz li jċedu kuljum;

(b) 20 ċenteżmu għal kull ratal zokkor li jċedu kull perijodu ta' razzjon;

(c) 5 ċenteżmi għal kull ratal għagin li jċedu kull perijodu ta' razzjon.

5. Il-hlas isir perjodikament permezz ta' *cheque*.

6. Il-kapijiet tal-familji li jixtiequ jagħmlu użu minn din l-għażla għandhom jiksbu l-formola adattata ta' applikazzjoni mill-Uffiċċju tar-Razzjon (29, Triq Nofs in-Nhar, Valletta, jew 28, Triq Sant'Ursola, ir-Rabat, Ghawdex) jew minn kull Għassa tal-Pulizija. Meta timtela l-formola ta' l-applikazzjoni għandha tintbagħat bil-posta lill-Uffiċċju tar-Razzjon, mhux aktar tard minn nhar it-Tlieta, it-8 ta' Ottubru, 1974. Din tista' tintbagħat mingħajr bolla bil-posta.

7. Kull min jeżerċita l-għażla msemmija hawn fuq ma jithalliex ibidilha qabel l-aħħar tas-sena 1975.

Changes in the Ration System

It has been decided to make some changes in the current Ration Scheme.

2. The scale of daily bread ration per person will be as follows:—

<i>Age</i>	<i>Entitlement</i>
Under 3 years	Nil
3 — 6 years	Quarter of a rotolo
6 — 10 years	Three-eighths of a rotolo
10 years or over	Half a rotolo

3. The present system of options, whereby families may elect to buy extra sugar or flour instead of their full entitlement of bread or paste, is being replaced by a new system of options, whereby families may elect to receive money in lieu of their entitlement (or part of their entitlement) of bread, sugar and/or paste.

4. Families who avail themselves of this option will be paid as follows:—

(a) 1c6 for every rotolo of bread given up daily;

(b) 20 cents for each rotolo of sugar given up every ration period;

(c) 5 cents for every rotolo of paste given up every ration period.

5. Payment will be made periodically by *cheque*.

6. Heads of families who wish to avail themselves of this option should obtain the appropriate application form from the Rationing Office (29, South Street, Valletta, or 28, St Ursola Street, Victoria, Gozo) or from any Police Station. When completed the application form should be posted to the Rationing Office not later than Tuesday, 8th October, 1974. It may be sent unstamped through the post.

7. Whoever exercises the above option will not be permitted to alter it before the end of 1975.
