Local Notice to Mariners No. 19 of 1981

The Osservatorio Geofisico Sperimentale of Trieste, Italy, will continue with its oceanographic survey in order to study the interaction between air and sea and to improve the knowledge of the currents in the Central Mediterranean area. The operations are controlled from the Danish Research Vessel 'DANA RESEARCHER'.

The buoys and stations mentioned in Notice to Mariners No. 8 of 1981 dated 8th July, 1981, have been repositioned as follows until further notice:—

They will therefore be a hazard to trawling. If they break loose the buoys will surface and will transmit a signal from a radio beacon on a frequency of 29 MHz.

All shipping and other craft are warned to give these buoys and current meter stations a wide berth and to report any loose buoy to the vessel 'DANA RESEARCHER'.
