



(b) of good moral character;

(c) free from any physical or mental defect likely to interfere with the proper performance of their duties;

(d) unless exempted from the written test of the entrance examination, in possession of a certificate, to be certified in each case by the Director of Education, showing that they have at least completed such studies as are equivalent to those of Form V of the Government Secondary School;

(e) citizens of Malta (besides their birth certificate, candidates are to produce certificates of birth of their parents and paternal grandfather, showing the place of birth).

(f) produce a police certificate of conduct (not older than six months).

4. Candidates will be required to pass a competitive entrance examination which will consist of a written test in English (two papers), Maltese and Mathematics, set on the syllabus of Form V of the Government Secondary School, and in General Knowledge; successful candidates will be submitted to a selective interview.

7. In the case of candidates obtaining an identical total number of marks, previous service with Government and, if this does not form an establishing factor, age will be taken into consideration in establishing the order of merit amongst them.

8. Successful candidates will have to follow the course of studies in accordance with the Training School for Registered (General) Nurses Regulations, 1971.

9. Candidates admitted to the training school shall be known as student nurses.

10. During the course of studies, student nurses will be provided with free meals, free issue of uniforms, as well as free medical attention and treatment in hospital during periods of sick leave.

11. Student nurses shall have to perform night duties at regular intervals.

(ACT NO. IV OF 1947)

Agricultural Produce (Marketing) (Amendment) Regulations, 1981

IN exercise of the powers conferred by section 3 of the Supplies and Services Act, 1947, the Minister of Trade, Industry and Parastatal and People's Industries has made the following regulations:—

Citation.

G.N. 360

1. These regulations may be cited as the Agricultural Produce (Marketing) (Amendment) Regulations, 1981, and shall be read and construed as one with the Agricultural Produce (Marketing) Regulations, 1952, hereinafter referred to as "the principal regulations".

2. For paragraphs (3), (4) and (5) of regulation 9 of the principal regulations there shall be substituted the following:

"(3) The Minister may by order in the Gazette specify —

(a) which standardised containers have been approved for use in marketing centres; and

(b) which agricultural produce entering or leaving marketing centres is to be carried only in the said standardised containers.

(4) It shall be an offence for any person wilfully to break, damage or destroy a standardised container specified in sub-paragraph (a) of the foregoing paragraph or to use any such container for any purpose other than that of containing agricultural produce."
