Post ta' Dietitian Mara

Il-Kummissjoni dwar is-Servizz Pubbliku tilqa' applikazzjonijiet għall-post ta' Dietitian Mara fid-Dipartiment Mediku u tas-Saħħa. L-applikazzjoni, li magħhom jintbagħtu ċertifikati tat-twelid u tal-kondotta mill-pulizija, kif ukoll dokumenti dwar il-kwalifiki u l-esperjenza, jiġu milqughin primarjament mit-Tabib Principali tal-Gvern, 15, Triq il-Merkanti, Il-Belt Valletta, mhux aktar tard minn nofs in-nhar ta' nhar is-Sibt, it-28 ta' Jannar, 1967.

2. Il-post huwa fuq l-Istabiliment Pensjonabbli u għandu salarju ta' £376 fis-sena li jitla' b'żidiet fis-sena ta' £12 sa £588 fis-sena bi grad ta' effiċjenza meta jintlaħaq is-salarju ta' £400. Is-salarju jiġi awmentat b'żieda ta' 8 fil-mija.

3. Din in-nomina hija soġġetta għar-regoli u r-regolamenti li jiggvernaw minn żmien għal żmien is-Servizz Ċivili ta' Malta b'mod ġenerali u d-Dipartimenti Mediku u tas-Saħħa b'mod partikolari u min jiġi nominat jista' jiġi trasferit skond l-esiġenzi tas-Servizz Pubbliku.

4. L-applikanti jrid:—

i) ikollhom id-Diploma in Dietetics (u catering);

ii) jkunu mhux anqas minn 18-il sena u mhux aktar minn 26 sena fl-aħħar gurnata iffissata li fiha jiġu milqughin l-applikazzjonijiet;

iii) jkunu ta' karattru morali tajjeb;

iv) jkunu mingħajr ebda difett fiziku jew mentali li jista' jfixkilhom fil-qadi sewwa tad-doveri tagħhom;

v) ikunu ċittadini ta' Malta.

5. Jekk ma jkollhiex diġà d-Diploma fid-Dietetics, il-kandidata magħżula tkun trid tmur barra minn Malta f'dak iż-żmien li jista' jiġi determinat mill-Gvern biex tagħmel kors approvat ta' studju li jwassal għad-Diploma fid-Dietetics.

Post of Female Dietitian

The Public Service Commission invites applications for the post of Female Dietitian in the Medical and Health Department. Applications, which must be accompanied by certificates of birth and of police conduct, as well as testimonials relating to qualifications and experience, will be received in the first instance by the Chief Government Medical Officer, 15, Merchants Street, Valletta, not later than noon of Saturday, 28th January, 1967.

2. The post is on the Pensionable Establishment and carries a salary of £376 per annum rising by annual increments of £12 to £588 per annum with an efficiency bar at £400. The salary will be augmented by the 8% increase.

3. This appointment is subject to the rules and regulations governing from time to time the Malta Civil Service in general and the Medical and Health Department in particular and involves liability to transfer according to the exigencies of the Public Service.

4. Applicants should:—

(i) be in possession of the Diploma in Dietetics (and catering);

(ii) be not less than 18 years of age nor over 26 years of age on the last day fixed for the receipt of applications;

(iii) be of good moral character;

(iv) be free from any physical or mental defect or disease likely to interfere with the proper discharge of their duties;

(v) be citizens of Malta.

5. Unless she is already in possession of the Diploma in Dietetics, the selected candidate will be required to proceed overseas at such time as may be determined by Government in order to undergo an approved course of study leading to the Diploma in Dietetics.

6. Għad-dhul f'kurs *full-time* li jiehu bejn it-tlieta u erba' snin, il-kandidati jkunu jridu jgħaddu minn Eżami tal-G.C.E. Ordinary Level fl-Ingliż, il-Matematika u l-Kimika u f'mill-anqas żewġ suġġetti oħra, jew passes f' 'A' level fil-Kimika u jew fil-Fizika, il-Bijoloġija jew Zooloġija u 'O' level fl-Ingliż u suġġett ieħor.

7. Il-kandidati li jkollhom il-livell minimu ta' l-edukazzjoni ġenerali fil-paragrafu 6 ta' hawn fuq u li għandhom wieheġ mill-kwalifiki preliminari li ġejjin:—

(a) Grad Universitarju fix-Xjenza Domestika, jew Household Science, jew Nutrition jew Xjenza Pura (inklużi l-Kimika u l-Fisjoloġija) u tliet xhur taħriġ fit-Tisjir; jew

(b) State Registration fin-Nursing u tliet xhur taħriġ approvat fit-tisjir; jew

(c) Diploma ta' Teacher fix-Xjenza Domestika; jew

(d) Institutional and Catering Management Certificates of the Institutional Management Association; jew

(e) Associate Members of the Hotel and Catering Institute fejn wieheġ ikun temm kors shih fil-catering u jkun ġie elett wara li jgħaddi mill-eżami professjonali ta' l-Institute jew eżami li jeżentah minn dak;

f) jista' jsegwi kors iqsar (sena jew tmintax-il xahar) għal Diploma in Dietetics.

3. Meta jispiċċa b'suċċess il-kors u meta terġa' lura Malta l-kandidata magħzula tkun Dietitian nominata.

9. Matul il-perijodu ta' studju barra minn Malta, il-kandidata magħzula tiffallas għall-ispejjeż bir-rati li jkunu qed isehhu f'dak iż-żmien. Informazzjoni fuq ir-rati kurrenti u informazzjoni aktar dwar is-sillabu ta' studju jistgħu jiġu akkwistati mid-Dipartiment Mediku u tas-Saħha.

6. For admission to a full-time course lasting between 3 and 4 years, candidates will be required to have passed an approved G.C.E. Examination at Ordinary Level in English, Mathematics and Chemistry and in at least two other subjects, or passes at 'A' Level in Chemistry and either Physics, Biology, or Zoology and at 'O' Level in English and one other subject.

7. Candidates possessing the minimum standard of general education in paragraph 6 above and who possess one of the following preliminary qualifications:—

(a) University Degree in Domestic Science, or Household Science or Nutrition or Pure Science (including Chemistry and Physiology) and three months training in cookery; or

(b) State Registration in Nursing and three months approved training in cookery; or

(c) Teacher's Diploma in Domestic Science; or

(d) Institutional and Catering Management Certificates of the Institutional Management Association; or

(e) Associate members of the Hotel and Catering Institute having completed a full-time course in catering and having been elected after passing the Institute's professional examination or examination exempting therefrom;

may follow a shorter (one year or eighteen months) course for a Diploma in Dietetics.

8. On the successful completion of either course and on return to Malta the selected candidate will be appointed Dietitian.

9. During the period of study abroad the selected candidate will be paid and reimbursed expenses at the rates in force at the time. Information on the current rates and further information regarding the syllabus of study may be obtained from the Medical and Health Department.

10. Il-kandidata magħżula tkun trid:—

a) tiddedika l-hin kollu tagħha biex issegwi l-kors ta' studju barra minn Malta, kemm-il darba ma tingħatax permess biex isir xogħol ieħor jew biex tbiddel il-kors tagħha ta' studju mill-Gvern;

b) tersaq għall-eżamijiet preskritti jew gruppi ta' eżamijiet;

c) tissodisfa lill-Gvern dwar dik li hija attendenza, kondotta u progress permezz ta' rapporti mill-kap ta' l-istituzzjoni jew awtorità oħra li taħtu jkun qiegħed isir il-kors.

Jekk il-kandidata magħżula, wara li takkwista l-approvazzjoni tal-Gvern taċċetta xi impieg bi flas waqt li tkun barra minn Malta, il-għotja totali li tiffal-las mill-Gvern tiġi ridotta b'ammont ekwivalenti għas-salarju ta' impieg bħal dan.

11. Il-kors ta' studju barra minn Malta jista' jiġi sospiz jew imwaqqaf skond kif jidhirlu l-Gvern jekk:—

(a) ir-rapporti fuq il-progress u l-imġieba tal-kandidata matul il-kors ma jkunux soddisfaċenti;

(b) il-kandidata mingħajr skuza raġonevoli, ma tghaddix mill-eżamijiet preskritti fiż-żmien iffissat mill-awtoritajiet ta' l-istituzzjoni illi tkun qiegħda tattendi jew mill-Gvern;

(c) il-kandidata tidhol għal xi attività li tkun ta' tfixkil għall-progress tagħha fil-kors ta' studju barra minn Malta preskritti għaliha jew taċċetta xi impieg bil-flas mingħajr il-permess tal-Gvern;

(d) il-kandidata ssir mhux f'kundizzjoni tajba li ttejjem l-istudji tagħha minhabba mard jew tkun assenti mill-istudji tagħha għal aktar minn sitt xhur minhabba mard;

(e) il-kandidata ma tiġix lura Malta jekk u meta tkun meħtieġa mill-Gvern,

10. The selected candidate will be required to:—

(a) devote her whole time to following the course of study abroad, unless permission to undertake other work or to change her course of studies is granted by the Government;

(b) sit for the prescribed examinations or groups of examinations;

(c) satisfy the Government as to attendance, conduct and progress by reports from the head of institution or other authority under whom the course is being undertaken.

Should the selected candidate, after obtaining Government approval, accept any paid employment while abroad, the total grant payable by Government will be reduced by an amount equivalent to the salary of such employment.

11. The course of study abroad may be suspended or terminated at the option of the Government if:—

(a) reports on the candidate's progress or conduct during the course are unsatisfactory;

CARNIVAL DANCES (SPECIAL TAX) ACT, 1952
(ACT NO. VII OF 1952)

Carnival Dances (Special Tax) (Amendment) Regulations, 1966

Date of commencement: 27th December, 1966.

IN exercise of the powers conferred by section 5 of the Carnival Dances (Special Tax) Act, 1952, the Honourable Minister of Finance, Customs and Port has made the following regulations:—

Citation

1. These regulations may be cited as the Carnival Dances (Special Tax) (Amendment) Regulations, 1966, and shall be read and construed as one with the Carnival Dances (Special Tax) Regulations, 1952, hereinafter referred to as “the principal regulations”.

ELECTRICITY ACT, 1963
(ACT NO. XXIV OF 1963)

Electricity Supply (Amendment) Regulations, 1966

Date of commencement: 27th December, 1966.

IN exercise of the powers conferred by section 40 of the Electricity Act, 1963, the Malta Electricity Board, with the approval of the Honourable Minister of Trade, Industry and Agriculture, has made the following regulations:—

Citation.

1. These regulations may be cited as the Electricity Supply (Amendment) Regulations, 1966, and shall be read and construed as one with the Electricity Supply Regulations, 1939.

2. For regulation 63 of the Electricity Supply Regulations, 1939, there shall be substituted the following new regulation:

“63. If a meter, on being tested, is found to be registering correctly, within a limit of $2\frac{1}{2}\%$, plus or minus, a fee of ten shillings shall be charged to the consumer.”
