I have to submit the Annual Report in accordance with the provision of Section 14 (1) of the Industrial Relations Act, 1976, for the period 1st July 1986 to 30th June 1987.

2. At the beginning of the period under review there were 42 organisations on the register, made up of 21 Trade Unions and 21 Employers' Associations.

3. The Union Haddiema Coca Cola, Union Haddiema tal-Hwienet, Medelec Switchgear Union, Għaqda Haddiema Tessuti Ghawdxin, House Union Maldiam and Union of Government Medical Doctors were registered during this period.

4. The membership strength of Trade Unions and Employers' Associations as compared with those of my previous report are as follows:—

5. No routine inspections were carried out during the period under review. which will take effect in two months' time if there is still no compliance by then.
6. The Għaqda Haddiema Bluebell (No. 199) failed to submit the required returns as required by law and was therefore cancelled.
7. The returns show an overall increase of 5,694 in membership from last year.
8. The organisations which failed to render complete returns as required by law are The Lotto Receivers' Union, the Association of Self-Employed and Employers, Coaches Transport Service Association, Għaqda tad-Dulciera, Association of Self-Catering Accommodation and Medelec Switchgear Union. Three organisations were issued with a Notice of Cancellation


