## AVVIŻ TAL-QORTI — COURT NOTICE

BY MINUTE filed this day in Her Majesty's Commercial Court, Dr Mario Felice produced the following document for publication in accordance with and for the purposes of the Commercial Code:

This 12th day of April, 1965.

In virtue of this agreement entered into today between Mr John Bartolo of 82, Rudolph Street, Sliema, and Mario Pullicino of 8, St Nicholas Street, Sliema, do form and constitute between them a Limited Liability Company for the purposes, object and under the name and conditions herein undermentioned:

1. The name of the Company shall be "C. Testa & Co. Ltd."

2. The Company shall be a Private Company and accordingly all the conditions, restrictions, limitations and prohibitions contained in article 146 of the Commercial Partnerships Ordinance, 1962, are binding on it.

3. The Registered Office of the Company shall be at 203, Merchants Street, Valletta.

4. The Objects of the Company as established are the following:

(a) To import, sell and export gold bullion, jewels and all precious stones and articles, gold and silver ware, filigree, ceramics, and all household appliances and decorative articles;

(b) To carry on trade in chandeliers, carpets, furniture, clocks, watches, cookers, refrigerators, washing machines, Television and wireless sets, heating appliances and all office equipment;

(c) To borrow or raise in any way money for the purpose of carrying on the business of the company, as well as to do all such acts and to conduct all such activities as are essentially incidental or conducive to the attainment of all or any of the above-mentioned objects.

5. The share capital of the Company shall be ten thousand pounds (£10,000) divided into one hundred shares of one hundred pounds (£100) each share. All the shares are fully paid up by the shareholders as follows:

John Bartolo — 94 shares,

Mario Pullicino — 6 shares.

Share holders shall have a right of first refusal on any newly issued shares if and when they will be so issued by the Company in proportion (pro rata) to the number of shares already held by each of them from time to time.

6. The whole business of the Company shall be managed by one Director only, who shall represent the Company at all times and on all acts and deeds.

Bis-saħħa ta' dan il-ftehim li sar il-lum bejniethom is-Sur John Bartolo ta' 82, Triq Ridolfu, tas-Sliema, u Mario Pullicino ta' 8, Triq San Nikola, tas-Sliema, iwaqqfu u jikkostitwixxu bejniethom Soċjetà Anonima għall-finijiet, skopijiet u bl-isem u l-kondizzjonijiet hawn taht imsemmija:

1. L-isem tas-Soċjetà ikun "C. Testa & Co. Ltd."

2. Is-Soċjetà tkun Soċjetà Privata u allura l-kondizzjonijiet, restrizzjonijiet, limitazzjonijiet u probizzjonijiet kontenuti fl-artikolu 146 ta' l-Ordinanza ta' l-1962 dwar is-Soċjetajiet Kummerċjali għandhom japplikaw għaliha.

3. L-uffiċċju registrat tas-Soċjetà ikun f'203, Triq il-Merkanti, il-Belt Valletta.

4. L-iskopijiet tas-Soċjetà kif imwaqqfa huma dawn li ġejjin:

(a) Li timpорта, tbiegħ u tesporta ingotti tad-deheb, gojjelli u haġar u oġġetti prezzjużi, oġġetti tad-deheb u tal-fidda, filigranu, ċeramika u apparati tad-dar u oġġetti ta' tizjin;

(c) Li tissellef jew tipprokura flus b'kull mod biex jiġi mmexxi n-negozju tas-soċjetà, kif ukoll li tagħmel dawk l-atti kollha u tmexxi dawk l-attivitàjiet kollha li jkunu essenzjalment inċidentalijiet jew li jwasslu biex jintlaħqu l-iskopijiet fuq imsemmija jew uħud minnhom.

5. Il-kapital f'azzjonijiet tas-Soċjetà jkun ta' għaxart elef lira (£10,000) maqsum f'mitt azzjoni ta' mitt lira (£100) il-waħda. L-azzjonijiet kollha huma mħallsa għal kollox mill-azzjonisti kif ġej:

John Bartolo — 94 azzjoni,

Mario Pullicino — 6 azzjonijiet.

L-azzjonisti jkollhom dritt ta' preferenza fuq kull azzjonijiet maħruġa godda jekk u meta jinħarġu mis-Soċjetà fil-proporzjon (pro rata) tan-numru ta' azzjonijiet ġa posseduti minn kull wieħed minnhom minn żmien għal żmien.

6. In-negozju kollu tas-Soċjetà għandu jiġi mmexxi minn Direttur wieħed biss, li għandu jirrapprezenta lis-Soċjetà f'kull żmien u fuq kull att u kuntratt.

7. The first Director of the Company shall be John Bartolo.

8. The Director shall hold office for five years and is eligible for re-appointment.

9. Except by the death of a shareholder, no shareholder may in any way dispose of his shares to third parties unless he first offers them for sale at their nominal value to the other shareholders who shall be entitled to purchase them in proportion (pro rata) to the number of shares then held by each shareholder willing to avail himself of such offer.

10. Each share in the Company shall give the right at General Meetings to one vote, and any resolution at General Meetings, even if purporting to alter, revoke, or add any thing to the present articles shall be validly carried if approved by at least a vote representing seventy-five (75%) per centum of the paid up value of the issued share capital of the company.
