WHEREAS section 78 of the Constitution of Malta provides that there shall be a general election of members of the House of Representatives at such time within three months after every dissolution of Parliament as the Governor-General, acting in accordance with the advice of the Prime Minister, shall by proclamation appoint;

AND WHEREAS Parliament was dissolved on the 15th day of February, 1966;
