### BILLS TAT-TEŻOR TAL-GVERN TA' MALTA

L-*Accountant General* jirċievi offerti sa Lm27,500,000 għal *Bills* tat-Teżor ta' wieħed u disghin gurnata li jkunu mahruġin skond l-Att Nru. II ta' l-1952 dwar il-*Bills* tat-Teżor ta' Malta. L-offerti għandhom jaslu fl-Uffiċċju tat-Teżor, il-Furjana, sa l-10 ta' fil-għodu tal-ĦAMIS, l-10 ta' Diċembru, 1987.

The Accountant General invites tenders for up to Lm27,500,000 ninety-one days Treasury Bills, to be issued under the Malta Treasury Bills Act II of 1952. The tenders will be received at the Treasury, Floriana, up to 10 a.m. on THURSDAY, 10th December, 1987.

2. The Bills will be for Lm1,000 or multiples of Lm1,000, will be dated Friday, 18th December, 1987, and be due for repayment at the Treasury on Friday, 18th March, 1988.

3. The tenderer shall accept any portion of the sum for which he has tendered at the same price per Lm100 as that for which he has tendered for the whole amount.

4. No tender will be considered unless it is made on a form obtainable from the Treasury.

Eżami kompetitiv għandu jsir ma jdmx għar-reklutaġġ ta' Pulizija Nisa bi Prova biex jimtlew għadd limitat ta' vakanzi fil-Korp tal-Pulizija ta' Malta.

Il-post ta' Kuntistabbli tal-Pulizija għandu sallarju ta' Lm1,997 fis-sena li jitla' b'żidiet fis-sena ta' Lm40 sa Lm2,117 u b'żidiet oħra ta' Lm54 sa Lm2,420 bi grad ta' effiċjenza meta jintlaħaq Lm2,117.

### **Examination for Recruitment of Women Police Constables**

A competitive examination for the recruitment of Probationary Women Police Constables will be held shortly to fill a limited number of vacancies in the Malta Police Force.

The Post of Police Constable carries a salary of Lm1,997 per annum rising by annual increments of Lm40 to Lm2,117 and by further increments of Lm54 to Lm2,420 with an efficiency bar at Lm2,117.

Candidates must:—

- (a) be citizens of Malta;
- (b) be of minimum height of 1.60m standing in their bare feet;
- (c) be of good moral character;
- (d) have attained their eighteenth (18) birthday but not their thirtieth (30) birthday on the 12th December, 1987;
- (e) be free from physical or mental defect or disease likely to interfere with the proper discharge of their duties; they must have normal vision of both eyes without spectacles and/or contact lenses and no imperfection of the colour sense. The rules for determining visual competency of candidates for the Malta Police Force are in Legal Notice No. 14 of 1960 as amended by Legal Notice No. 89 of 1978.

The examination will consist of:—

PART I — Interview and Aptitude Test  
PART II — Medical Test  
PART III — Written Test  
PART I — Interview and Aptitude Test  
(Maximum 100, Minimum 50)

Designed to bring to the fore those personal qualities in a candidate such as personality, alertness, intelligence, etc., which do not necessarily show up in a written test.

PART II — Medical Test

Only candidates who pass the Medical Test will be allowed to sit for the written examination.

(d) *Typewriting* — Speed Test (at least 45 words per minute) copying of manuscripts and drawing up of tabular statements. Candidates are to provide their own machines.

Conditions:—

(a) shall be required to produce the necessary certificates prior to engagement;

(b) shall be eligible for appointment to fill vacancies occurring within a period of twelve months from the date of the publication of the final result of the examination;

(c) Candidates who are bound by an agreement of apprenticeship shall be precluded from appointment unless they obtain from the Director of Labour a certificate of their release from the agreement;

(d) This examination is open to female candidates and application forms, the only ones admissible, may be obtained from the Personnel Section, Police General Headquarters, Floriana, by not later than Saturday, 12th December, 1987, during normal office hours, including Saturdays between 8.00 a.m. and 12.30 p.m. Two recent passport size photographs are to be presented with the application. Those who have already applied are to re-apply.
