POSTAGE SET COMMEMORATING THE 20th ANNIVERSARY OF THE UNITED NATIONS RESOLUTION ON THE SEABED

THE Postmaster General notifies that the Minister for Development of Infrastructure has authorised the issue on Friday, 18th December, 1987, of a set, consisting of two stamps and one souvenir sheet, to commemorate the 20th anniversary of the United Nations resolution on the reservation exclusively for peaceful purposes of the seabed. The set will remain on sale up to Wednesday, 18th May, 1988, unless stocks are previously exhausted.

The value and subject of each stamp will be the following:—

Value	Subject
8c	A portrait of Dr Arvid Pardo
12c	The Emblem of the United Nations

The souvenir sheet will incorporate the two stamps and will be available for sale at 20c.

The stamps, designed by Salvu Mallia, will be printed by Printex Limited in multi-coloured lithography on Maltese Cross watermarked sheets of forty stamps each. The size of each stamp will be 39.5 mm×48 mm, in a vertical format, with a perforation gauge of 14×14. The size of the souvenir sheet will be 125 mm×90 mm in a horizontal format.
