THE AUTHORS

MANU BHASKARAN is Partner and Member of the Board, Centennial Group Inc, a strategic advisory group based in Washington DC. He heads the Group's economic research practice in Singapore. He is also an Adjunct Senior Fellow at the Institute of Policy Studies, focusing on economic policy issues confronting Singapore. Mr Bhaskaran graduated in Economics from Cambridge University and also has a Masters degree in Public Administration from Harvard University. He is a Chartered Financial Analyst. Prior to his current positions, Mr Bhaskaran worked for 13 years at the investment banking arm of Société Générale as its Chief Economist for Asia. Before that he worked in Singapore's Ministry of Defence, focusing on regional security and strategic issues.

ASSAD BHUGLAH is the Director of Trade Policy at the Ministry of Foreign Affairs, International Trade and Regional Cooperation of the Government of Mauritius. He has participated extensively in trade negotiations at regional and multilateral levels over the last 15 years. He has been closely associated with the work of Commonwealth Trade Expert Group on Small Economies. Since January 2002 he has formed part of UNDP's Experts Team on SIDS. He has also acted as external lecturer on Trade Diplomacy at the University of Mauritius.

LINO BRIGUGLIO is Professor and Head of the Economics Department at the University of Malta, Director of the Islands and Small States Institute at the Foundation for International Studies and Director of the Malta University Centre on the Island of Gozo. He was awarded a PhD in Economics from the University of Exeter (UK) in 1982. His main area of interest is islands and small states studies. He was originator of the concept of the economic vulnerability index and was instrumental in its construction. Professor Briguglio has represented the Maltese government in United Nations meetings dealing with islands and small states' affairs, including the 1994 UN Global Conference on the Sustainable Development of Small Island States and at the 2002 AOSIS meeting during the World Summit on Sustainable Development. He also sits on many Government committees, including the Fair Trading Commission and the Commission for Sustainable Development.

GORDON CORDINA is a graduate of the University of Malta and of the University of Cambridge, UK. He currently lectures at the Economics Department of the University of Malta. He had previously worked in the Economics Department of the Central Bank of Malta for nine years up to October 2001, where he headed the Department's Research Office. He is the author or co-author of a number of journal articles on public finance, macroeconomic models and welfare reform. In 1997, Mr Cordina published the study "A Structural Econometric Model of the Maltese Economy" in the

Journal of Economic and Financial Modelling – a model which remains in use at the Central Bank of Malta. Mr Cordina is currently a board member of the Malta Council for Science and Technology and advisor to the Malta Council for Economic and Social Development. In recent years, he has served on a number of economic policy committees in Malta including the Commission for Welfare Reform and the Malta Council for Economic Development.

ANDREW S. DOWNES is Professor of Economics and University Director of the Sir Arthur Lewis Institute of Social and Economic Studies of the University of the West Indies. He is based at the Cave Hill Campus in Barbados. He was educated at the University of the West Indies, University of Toronto and University of Manchester. He obtained his PhD in Economics from the University of Manchester in 1985. He specialises in Applied Econometrics, Labour Economics and Development Economics and has published several articles in regional and international journals. He has been a consultant to several national, regional and international organisations. He has received several academic awards and has been a member of several public bodies including the National Productivity Council in Barbados.

ROSEMARIE-RITA ENDELEY studied at Universities in West Africa, USA and the United Kingdom and has been involved in development work for the past 25 years in the Commonwealth. His recent publications include Monetary Issues in the South Pacific Island Countries, USP Book Centre, Suva, 2003 and Financial Sector Development and Private Investment in Vanuatu, Macmillan Brown Centre for Pacific Studies, Christchurch, New Zealand, 2003. Dr Jayaraman was a Senior Economist with the Manila-based Asian Development Bank for more than 15 years and in that capacity, he processed many development loans and technical assistance projects in the SPICs and in Southeast Asia. HIROSHI KAKAZU was awarded a PhD in Economics from the University of Nebraska in 1971. Since then he has held posts at the London School of Economics, the East-West Centre (Fulbrighter), the University of Hawaii, the University of the Ryukyus and the Asian Development Bank. Recent positions include that of Professor and Dean of the International University of Japan, and Professor of the Graduate School of International Development at Nagoya University. He also served as Vice-President of the Okinawa Development Finance Corporation. ART KOVACIC is a research assistant in the Institute for Economic Research in Ljubljana. His research work is mainly oriented on competitiveness issues in international network co-operating in the preparation of two competitiveness reports (IMD and WEF). Both provide a multidimensional approach to benchmarking a country's performance against economies-world wide by highlighting their comparative strengths and weaknesses. LUCA MONGE ROFFARELLO is an Economics Affairs Officer within the Trade Negotiations and Commercial Diplomacy Branch at UNCTAD in Geneva. He is a graduate of the University of the West Indies and the Institute of Development Studies (IDS), University of Sussex, UK. He is the author of the book *The Economics of Sustainable Development in Small Caribbean Islands*, published by the Centre of Environment and Development of University of the West Indies (UWICED). He has been the Principal Investigator on several recent SEDU studies on environmental management and sustainable livelihoods in the land water interface in the Caribbean region.

MAHENDRA REDDY is a Development Economist based at the Development Studies Programme at the Pacific Institute of Advanced Studies in Development Governance of the University of the South Pacific. He teaches in the Postgraduate Programme of Development Studies. He has taught courses on "Trade and Development", "Development Economics", "Agricultural Economics", "Research Methodology", "Microeconomics", "Macroeconomics" and "Economic Statistics". He has researched on a wide range of topics related to economic development and has published extensively in this area, in local, regional and international journals. He obtained his PhD from the University of Hawaii in 1998, majoring in Agricultural and Resource Economics.

PETER STANOVNIK is Professor at the University of Ljubljana. He possesses an MA from University of Ljubljana and PhD in Economics from the University of Zagreb. In 1978 he joined the Institute for Economic Research, the leading economic research institution in Slovenia. In the period 1991-2003 he was director of this institute. He conducted numerous studies in the field of science and technology and innovation policy. MICHAEL SWIDINSKY is an Agricultural Economist with special interest on international aspects. His specific expertise is agricultural trade policy, particularly relating to WTO issues. At the time of writing he was on leave with the Division on International Trade in Goods and Services, and Commodities at the UNCTAD in Geneva. He holds a PhD in Agricultural Economics from the University of Guelph, Canada. NIKHIL TREEBHOOHUN was appointed as the first Executive Director of the National Productivity and Competitiveness Council (NPCC) of

He launched a Clothing Technology Centre, and an Information Resource Centre in 1998. Mr Treebhoo hun pioneered Internet access in Mauritius. He is a Fellow of the World Academy of Productivity Science and was a Fulbright scholar at Georgetown University, Washington D.C. He possesses a BSc (Hons) Economics, specialising in Industry and Trade from the London School of Economics and has carried out post-graduate studies in financial management at the University of New England (Australia) and in developing studies at the Institute of Social Studies (The Hague).

PITOU VAN DIJCK is Associate Professor of Economics at the Centre for Latin American Research and Documentation (CEDLA) at the University of Amsterdam. Since 1997 he has been giving courses on international trade and integration at the Anton de Kom University in Paramaribo, Suriname. He has published widely on structural reform programmes in Latin America, and more specifically on reform of trade regimes at the national, regional and multilateral levels. Among his most recent books are *Ten Years of Mercosur* (2002), *Suriname – The Economy* (2001) and *The External Economic Dimension of the European Union* (2000, co-edited with Gerrit Faber).

DAVID VANZETTI is an Agricultural Economist within the Trade Analysis Branch at UNCTAD in Geneva. He holds a PhD in Economics from the La Trobe University in Australia.
