THE AUTHORS

HARVEY ARMSTRONG is Professor of Economic Geography and Head of Department at the University of Sheffield, UK. He has previously worked in economics departments at the University of Loughborough and Lancaster University in the UK, and has been a visiting academic at the University of British Columbia and the University of West Virginia. His principal research interests are in the fields of regional economic growth, regional and local economic regeneration policies, the evaluation of government policies and the economic performance of small states and island economies. His books include *Regional Economics and Policy*, *The Economics of Regional Policy and Regional Economics* (all with Jim Taylor) and *Regional Convergence and Divergence* (with Roger Vickerman). His work with Robert Read has led to a wide range of publications in the academic journals on the determinants of growth and on economic policy-making in small states and island economies.

GODFREY BALDACCHINO holds a Ph.D. from the University of Warwick and is currently Canada Research Chair in Island Studies at the University of Prince Edward Island, Canada and Visiting Professor of Sociology at the University of Malta. His areas of research interest include: brain rotation, immigration, labour relations, governance, social capital and sub-national island jurisdictions. He is a Director of Global Islands Network (GIN), editor-in-chief of *Island Studies Journal* and moderator of an island studies website at <http://www.islandstudies.ca>. His is author of many books and peer reviewed articles. His forthcoming books include *Extreme Tourism: Lessons from the World's Cold Water Islands* (Elsevier, 2006); *Islands and the Bridge Effect* (Acorn Press, 2006) and *A World of Islands: An Island Studies Reader* (Agenda Academic and Institute of Island Studies, 2007).

LINO BRIGUGLIO is Professor and Head of the Economics Department at the University of Malta, Director of the Islands and Small States Institute at the Foundation for International Studies and Director of the Malta University Centre on the Island of Gozo. He was awarded a Ph.D. in Economics from the University of Exeter (UK) in 1982. His main area of interest is islands and small states studies. He was originator of the concept of the economic vulnerability index and was instrumental in its construction. Professor Briguglio has represented the Maltese government in United Nations meetings dealing with islands' and small states' affairs, including the 1994 UN Global Conference on the Sustainable Development of Small Island States and at the 2002 AOSIS meeting during the World Summit on Sustainable Development. He also sits on many Government committees, including the Fair Trading Commission and the Commission for Sustainable Development.

DAVID CARMENT is a full Professor of International Affairs at the Norman Paterson School of International Affairs, Carleton University and Fellow of the Canadian Defence and Foreign Affairs Institute (CDFAI). He is listed in the Who's

Who in International Affairs. In addition Carment is the principal investigator for the Country Indicators for Foreign Policy project (see <http://www.carleton.ca/cifp>). He has served as Director of the Centre for Security and Defence Studies at Carleton University. Carment held a Fellowship at Harvard University's Belfer Center, where he contributed to the Harvard International Review. He is the recipient of a Cadieux Fellowship from the Department of Foreign Affairs and held a post-doctoral fellowship at Stanford University's Hoover Institution.

SATISH CHAND is an Associate Professor in the International and Development Economics Programme at the Australian National University (ANU). He is also the Director of the Pacific Policy Project, located within the Asia Pacific School of Economics and Government at the ANU. Professor Chand has a Ph.D. in Economics from the ANU and has published extensively on trade, economic growth, labour markets, and development. His research interests include the role of international trade in economic growth and the role of aid in development.

HAROLD CODRINGTON possesses degrees in Economics from the University of the West Indies and York University, Toronto, Canada. He is currently adviser to the Governor of the Central Bank of Barbados. His publications include papers on currency issues, exchange rates, monetary union, the balance of payments, taxation and social partnerships. He is joint editor of several books on the Barbadian economy, as well as editor of the Barbados Economics Society's Newsletter. He is at present preparing a paper on transportation policy in Barbados.

GORDON CORDINA is a graduate of the University of Malta and of the University of Cambridge, UK. He currently lectures at the Economics Department of the University of Malta. He had previously worked in the Economics Department of the Central Bank of Malta for nine years up to October 2001, where he headed the Department's Research Office. He is the author or co-author of a number of journal articles on public finance, macro-econometric models and welfare reform. In 1997, Mr Cordina published the study "A Structural Econometric Model of the Maltese Economy" in the *Journal of Economic and Financial Modelling*, which model remains in use at the Central Bank of Malta. Mr Cordina is currently board member of the Malta Council for Science and Technology and adviser to the Malta Council for Economic and Social Development. In recent years, he has served on a number of economic policy committees in Malta including the Commission for Welfare Reform and the Malta Council for Economic and Social Development.

ROLAND CRAIGWELL is Deputy Director (Economic Modelling) at the Central Bank of Barbados. A graduate of the University of the West Indies, the University of Warwick and the University of Southampton, he specialises in applied econometrics and his publications have appeared in Caribbean and international journals. Dr Craigwell is currently working on panel data applications to financial institutions, tourism modelling and business cycle analysis.

ANDREW DOWNES is Professor of Economics and University Director of the Sir Arthur Lewis Institute of Social and Economic Studies of the University of

the West Indies. He is based at the Cave Hill Campus in Barbados. He was educated at the University of the West Indies, University of Toronto and University of Manchester. He obtained his Ph.D. in Economics from the University of Manchester in 1985. He specialises in Applied Econometrics, Labour Economics and Development Economics and has published several articles in regional and international journals. He has been a consultant to several national, regional and international organisations. He has received several academic awards and has been a member of several public bodies including the National Productivity Council in Barbados.

NADIA FARRUGIA is an economist and a part-time tutor in intermediate macroeconomics and advanced microeconomics. Her main research interests are competitiveness, economic growth and small states studies. She possesses a first class honours Bachelor's degree and a Master's degree (with distinction) both in Economics and from the University of Malta. Her Master's dissertation was entitled "Economic Vulnerability: Developing a New Conceptual Framework and Empirically Assessing its Relationship with Economic Growth". Her published peer reviewed articles focus on economic vulnerability, competitiveness and institutional building. KEVIN GREENIDGE is a macroeconometrician and a Senior Economist in the Research Department of the Central Bank of Barbados. His is currently following a Ph.D. programme at Nottingham University. His publications topics include the measurement of financial liberalisation, liberalisation and the challenges for policy-makers in small developing economies, issues of exchange rate misalignment in the Caribbean, cross country monetary effects, growth and convergence in the Caribbean. CHANDAN KHESWAR JANKEE has earned his M.A. degree from the Delhi School of Economics and subsequently, his Ph.D. in monetary economics from the University of Mauritius.
