

DIPLOMA COURSE IN APPLIED SOCIAL STUDIES/LABOUR STUDIES

The University is at present running an Evening Diploma Course in Applied Social Studies/Labour Studies. Thirty students have registered for the Course which commenced on Tuesday, 10th March, 1987 and which will end in January, 1989.

The Course Co-ordinator is Dr. Edward Zammit, Senior Lecturer in the Department of Management Studies.

A SPECIAL COURSE ON THE HISTORY OF WESTERN TECHNOLOGY

The University of Malta recently organised a special course on 'The History of Western Technology' to student-workers pursuing studies leading to degrees in Education, Pharmaceutical Technology, Mechanical Engineering and Electrical Engineering.

The purpose of the course was to inspire in students an appreciation for the sociological, historical and humanistic aspects of science and technology. This approach helped to widen their perspectives on the subjects normally taught in the curricula of the respective courses.

The course was given by Professor R.F. Cane who has had a distinguished career both in industry and in academia and has held various university appointments in the United States of America, Australia and the United Kingdom. For the past five years, he has given similar courses in the University of Utah (U.S.A.) as part of a Liberal Education Programme.

This interdisciplinary course was attended by more than 100 students. The course, which was coordinated by Professor V. Axiak, traced the evolution of man's use and development of technology from early times; considered the cyclic nature of man's endeavours, the rates of change in the adoption of technology and its effects on society.
