MOS notes with satisfaction that, all the political parties appreciate the need to safeguard our fauna and flora and to create the necessary legislation in that regard.

LPO Project in French Guiana

French Guiana is the smallest South American country with an area of 90,000 km². It is almost entirely covered by tropical rain forest. The population is only 120,000 but growing rapidly. The majority of people are concentrated in the narrow coastal band.

As in most tropical rain forests, hunting played an important part in traditional societies. Today the hunting pressure has greatly increased due to a relatively rich, urbanised population using sophisticated equipment such as high performance guns, 4x4 vehicles and spotlights. Penetration into the forest has been made easier by the creation of forestry tracks. As a result the animal populations have declined despite there are protected species. For example the Scarlet ibis and Toco toucan are massacred to a point that these species will not survive long.

The French society for the protection of birds LPO is co-operating with the local administration in a project to develop the environmental awareness among the population.

MOS gives its moral support to the LPO in this project.



MOS felt slandered by this press release and after taking legal advice, it decided to take court action. Dr Toni Abela LL.D. is representing MOS.





Bird-watch

The most frequently spotted birds are sparrows, robins, starlings or perhaps swifts. However, if you go to the right places there are many many other birds to watch. These places were mentioned in last month's newsletter.

April brought in an interesting variety of birds. In the first two days of April about 675 Garganeys, a type of duck, and 75 Curlews were spotted off Il-Oammieh, I/o Mellieha.

The Ghadira Nature Reserve was host to, among others, sandpipers, kingfishers, black-winged Stilts(drawing below), and the now quite rare Glossy Ibis. Another rare visitor was the Squacco Heron.

Although Is-Simar Nature Reserve at Xemxija is not complete, birds are already using this resting place on their migration path. The visitors included the Grey and Purple Heron and the Ferruginous Duck.


Due to its protected status the island of Comino enjoys many bird sightings. There, a large number of Subalpine Warblers were observed as well as the Little Bittern, the Cuckoo, the Hobby, the Hoopoe, and the former breeder in our islands, the Peregrine Falcon.


In Ramla Bay, Gozo, one of the

smallest but most beautiful of the falcon species was observed. This was the Red-Footed Falcon, with its bright coloured feet and beak. Its feathers are of a velvet powdery blue colour.

Next month, we shall talk about the sort of equipment you can use to enjoy this relaxing past-time. If you have seen an unusual bird, please write and tell us about it and where you have seen it. We would like to know.
