# White Elephant in Gozo

The Annual General Meeting passed a resolution regarding the proposed development of an airstrip in Gozo. The resolution states that BirdLife Malta is totally against such a development and demands that the authorities withdraw the project completely. This issue was again brought up in a press conference held late last March in which Birdlife Malta together with five other environmental organisations (NGOs) expressed their objections on the development of an airstrip in Gozo. During the press conference it was emphasised

that the word 'development' is not anathema to environmental organisations. The concern rather lies in the lack of foresight and holistic planning. Social and environmental parameters that characterize certain projects are considered by developers as trivial compared to the economic benefits. The Gozo airstrip is a typical case.

The NGOs concluded that greater social benefits may be derived from improving existing sea/land transport services as opposed to air-links. It was also stated that the proposed development should not even reach the stage of an Environment Impact Assessment since its effects on the environment would be too obviously extensive to remedy.

A position paper has been prepared on the impact of such a project on the environment. The six NGOs expect to meet both local and foreign authorities to discuss this issue during the weeks following the press conference. its aesthetic and ecological value.

The need for a healthy environment should not be underestimated. The countryside provides us with our air, food and water on which we depend. The countryside is necessary for recreation and is also essential for providing habitats for other living things including birds.


Along with **Dinja Waħda**, a campaign which encourages environmental action among primary schoolchildren, Kampanja għall-Kampanja is a contribution by BirdLife Malta to the European Nature Conservation Year. Several other activities are being held on a national and local level including a photographic competition and a seminar.

### **Road Verges**

We frequently see government employees working along country roads and lanes removing wild plants from under rubble walls. Unfortunately this practice is destroying an interesting ecosystem that supports several species of flora and fauna.

Authorities in several European countries consider road verges an important habitat worthy of study and maintenance. Such is the case in the Netherlands, where nowadays road verges contain up to 50% of all Dutch plant species.

Birdlife Malta is insisting with government authorities that roadside vegetation in the countryside should be managed properly so that this ecological system is not damaged. The vegetation should be removed only if really necessary and under no circumstances should herbicides be used.

#### **MLP Policy Paper**

Political parties have a significant say in the protection of the environment. For some years political parties have introduced the concept of environment protection in their overall political strategy.

BirdLife Malta was asked to review the Labour policy paper on the environment and has, following this, prepared a dossier on the subject. Several aspects have been touched on in the policy paper including building development, traffic, air and water quality, the natural environment and hunting and trapping among others.

Whereas some aspects of the policy paper were highly commendable, it was disappointing to note the low priority given to bird protection, an issue that BirdLife Malta will surely bring out in its discussions with officials of the Labour party.



# Caught red-handed

Mr David Briffa, public relations officer of the Hunters and Trappers' Association was caught red-handed trapping finches during the close season! The trapping devices were confiscated and the hunters' official will be taken to court.

It is interesting to note that in a recent television debate, Mr Briffa proclaimed that the new laws were so banal as to be impossible not to break!

Several other hunters and trappers had their equipment confiscated over the past months following swift action by the police force and the environment inspectorate. Nonetheless BirdLife Malta receives phone calls daily reporting hunting infringements. This useful information will allow BirdLife Malta to monitor hot spots for illegal hunting and ensure efficient and effective action to be taken at the appropriate time.

#### **Outing to Is-Simar**

This is your opportunity to be one of the first members to visit Is-Simar Nature Reserve. The work at the reserve is progressing well, with the three birdwatching hides nearing completion and the several hundred tree saplings becoming established. This has only been possible through the financial support of BirdLife members and the dedicated work of several volunteers.

A team of birdwatchers will show the visitors around the reserve for a spot of nature observation. We may be lucky to see a number of interesting migratory birds which may have delayed their northward journey.

The activity is scheduled for Wednesday 7 June at 7.00pm. The group will meet at the

# Long-awaited Book

Flora u Fawna ta' Malta is the title of a new popular publication by the Environment Protection Department.

The book, published this year to coincide with the European Nature Conservation Year, describes almost 1000 local species of plants and animals in 434 pages. Each species mentioned is also depicted in colour. Written by 9 experts in different fields of



biology, this publication will fill a large gap in the information available about Maltese wildlife.

#### Trade in WildLife

Authorities recently enacted a new regulation that will restrict the importation of various species of fauna and flora. Most of these species are CITES listed. CITES is the United Nations' Convention on International Trade in Endangered Species. It is the convention having the most signatory parties (128 countries so far), including Malta.

An incredible 50 species of animals and plants are lost *every day* due to the destructive activity of man. Along with habitat destruction and direct persecution, the illegal trade in wildlife is also taking its toll.

The implementation of CITES is essential for combating this illegal trade.



#### Bird of the Year

The Kingfisher (Maltese: Ghasfurta' San Martin) has been chosen Bird of the Year 1995.

A large head, a long bill, a short tail and even shorter legs; an almost excessively colourful plumage: brilliant blue head, iridiscent blue-green back, orange underparts - the bird is unmistakable. Despite its extrovert colours, however, it is a rather shy bird, normally resting and feeding away from people. Its flight is swift and direct and close over the water surface. Even then it would be difficult to spot, were it not for the high pitched whistles which it usually



utters in flight. However hard to locate, a sighting of this gem of a bird makes the search worthwhile.

In Malta the Kingfisher is a fairly common autumn migrant from mid-July to mid-November, although a few occur irregularly up till March. It is seen mostly around the coast. It is also seen inland in valleys where fresh water pools are present, and keeps a low profile among the reeds. The kingfisher often graces the reedbeds at Għadira and Is-Simar.

Although a protected species, the kingfisher unfortunately shares the fate of other brightly coloured birds and has always suffered the worst of the showcase mentality.
