THE AUTHORS

AMJAD ABDULLA has been working in the Environment Ministry of the Maldives since 1990. His major fields of expertise are environmental planning, environmental impact assessment and cost benefit analysis for development projects, especially in small islands. He is also experienced in planning for tourist resort development and coastal construction. Mr Abdulla has carried out several coastal erosion studies and surveys and was involved in several projects relating to environmental awareness. He possesses an honours degree in Civil Engineering from the University of Brighton, UK and an MSc in Environmental Science Policy and Planning from the University of Bath, UK.

AL BINGER is Director of the Centre for Environment and Development at the University of the West Indies and member of the Committee for Development Policy of the United Nations Economic and Social Council (ECOSOC) and is visiting Professor, Saga University Institute of Ocean Energy, Japan. He leads the UNDP team of experts on vulnerability and resilience of small island developing states (SIDS), and in this capacity was instrumental in convening a number of expert meetings, mainly on issues relating to SIDS' capacity building and vulnerability, in preparation for World Summit on Sustainable Development and for the Mauritius International Meeting on the 10-year Review of the Barbados Programme of Action for the Sustainable Development of SIDS. He authored several publications of direct relevance to SIDS, including Potential and Future Prospects for Ocean Thermal Energy Conversion in Small Islands Developing States and Vulnerability and Small Island States.

LINO BRIGUGLIO is Professor and Head of the Economics Department at the University of Malta, Director of the Islands and Small States Institute at the Foundation for International Studies and Director of the Malta University Centre on the Island of Gozo. He possesses a PhD in Economics from the University of Exeter, UK (1982). His main area of interest is islands and small states studies. He was originator of the economic vulnerability index and was instrumental in its construction. Professor Briguglio has represented the Maltese government in United Nations meetings dealing with islands' and small states' affairs, including the 1994 UN Global Conference on the Sustainable Development of Small Island Developing States. He is one of the Lead Authors for the IPCC Fourth Assessment Report. He sits on a number of Malta Government committees, including the Fair Trading Commission and the Commission for Sustainable Development.

SATISH CHAND was educated up to the first degree, and worked for several years, in Fiji. He is currently the Director of the Pacific Policy Project within the Asia Pacific School of Economics and Government and a Senior Lecturer in Economics at the Australian National University (ANU). Dr Chand holds a PhD in Economics from the ANU and has published extensively on trade, economic growth, labour markets, and development. Dr Chand has worked

as a consultant for the Asian Development Bank, the World Bank, and the Governments of Australia, Fiji, Papua New Guinea, and Vanuatu.

GORDON CORDINA is a graduate of the University of Malta and of the University of Cambridge, UK. He currently lectures at the Economics Department of the University of Malta. He had previously worked in the Economics Department of the Central Bank of Malta for nine years up to October 2001, where he headed the Department's Research Office. He is the author of a number of journal articles on public finance, macro-econometric models and welfare reform. In 1997, Mr Cordina published the study "A Structural Econometric Model of the Maltese Economy" in the *Journal of Economic and Financial Modelling*, which model remains in use at the Central Bank of Malta. Mr Cordina is currently board member of the Malta Council for Science and Technology and advisor to the Malta Council for Economic and Social Development. In recent years, he has served on a number of economic policy committees in Malta including the Commission for Welfare Reform and the Malta Council for Economic Development.

TOM CROWARDS currently works for the UK's Department for International Development as an Economic Adviser on macroeconomics. He was earlier the Government Economist for the South Atlantic island of St Helena, for two years and a Research Economist for the Caribbean Development Bank. Mr Crowards has a Masters degree in Environmental Economics from University College London. He has published papers on a range of issues including 'green' national accounts, discount rates and sustainable development, economic valuation of the environment, economic vulnerability, and the definition of 'small' states.

PIERRE ENCONTRE is an economist in the Special Programme on the Least Developed Countries, and Land-locked and Island Developing Countries in the secretariat of the United Nations Conference on Trade and Development (UNCTAD) in Geneva. He is a graduate of the Institute of Political Studies of Paris, and holds a Doctorate in Economics from the University of Clermont 1 (France). Prior to joining UNCTAD in 1991, he was a UN economic adviser to the governments of various SIDS in the Caribbean and Pacific regions. Most of his work in the UN has been relevant to the special treatment of vulnerable countries, with particular reference to the least developed countries (LDCs) and SIDS. In recent years, his activities have concentrated on supporting the periodic review of the list of LDCs, analysing the effective benefits derived from LDC status, and raising the international community's awareness of the economic vulnerability of SIDS.

PATRICK GUILLAUMONT is Professor at the Université d'Auvergne, Centre d'Etudes et de Recherches sur le Développement International and President of the Fondation pour les Etudes et Recherches sur le Développement International. He has been director of the *Revue d'Economie du Développement* since its creation and was co-ordinator of the AUF (Agence Universitaire Francophone) network on "Analyse économique et développement" from 1992 to 2002. He has been member, since 1987, of the Committee for Development Policy of the United Nations, in which capacity he has chaired several expert groups on the identification criteria of LDCs and economic vulnerability. He is also member of the Programme Committee of the African Economic Research Consortium and member of the Expert Group on Development Issues, Swedish Ministry of Foreign Affairs. Patrick Guillaumont has published twenty books and about 200 articles in books or journals on development issues. He is currently preparing a book on the least developed countries.

MALCOLM HADLEY is a biologist by training. Between 1967-1972 he was scientific coordinator of the Terrestrial Productivity Section of the International Biological Programme. He then spent most of his professional career with the Natural Sciences Sector of UNESCO, as part of the secretariat for the Man and the Biosphere Programme. His primary concerns have included natural resource issues and human-environment interactions in tropical regions, and collaborative research in a number of fields including tropical soil biology and fertility. He has been involved in diverse initiatives for communicating scientific information for different audiences, including the twenty-eight volume *Man and the Biosphere* Series. From 1995-1999, he was editor of the quarterly magazine *Nature and Resources*. He has been involved in developing many island-related materials, including several overviews of UNESCO's work on island environments, territories and societies.

T. K. JAYARAMAN, is Associate Professor at the Economics Department of the University of the South Pacific, Fiji. Before joining the University of the South Pacific, he was a postdoctoral research fellow at the Macmillan Brown Centre for Pacific Studies, University of Canterbury, New Zealand. Earlier, as an East West Center Grantee he followed a course leading to a Masters degree at the University of Hawaii. He followed his PhD programme as a Fulbright Scholar, also at the University of Hawaii. His academic/research interests are in the area of Monetary Economics and Comparative Economic Development in the South Pacific Island Countries and has several publications to his credit. Dr Jayaraman was a Senior Economist with the Manila-based Asian Development Bank for more than 15 years and in that capacity, he processed many development loans and technical assistance projects in the SPICs and in Southeast Asia.

RACINE KANE currently works as a Programme Specialist in the UNDP Capacity 2015 Regional Coordination Mechanism for Africa, based in Dakar (Senegal). His remit includes providing support to national programmes funded by Capacity 2015, monitoring and evaluating ongoing and completed projects, learning from various sustainable development experiences and developing sustainable development networks in sub-Saharan Africa. He contributes directly to the advocacy and mainstreaming of the new Capacity 2015 initiative at national and regional levels through participation in Sub-Regional Environmental Clusters. As the focal point for the SIDS in the Capacity Development Group, he is also currently working on an initiative relating to the International Meeting on the Ten-Year Review of the Barbados Programme of Action, scheduled to be held in Mauritius in January 2005. Before joining UNDP Capacity 21, Mr Kane worked with the Centre de Suivi Ecologique, in Senegal.

ELIZABETH KHAKA, a Zimbabwan, has, since 1993, been Programme Officer at the United Nations Environment Programme, and is responsible for projects in water, wastes and gender. Her remit includes planning, developing and implementing projects relating to the UNEP's Water Policy and Strategy and reviewing and providing the inputs on water related issues. She also helps countries to prepare projects for leveraging funds for integrated water resources management. As SIDS' focal point for UNEP, she was responsible for the preparation of a report on UNEP's activities in SIDS and on progress made in implementing the Barbados Programme of Action for the Sustainable Development of Small Island Developing States (BPoA). She also supported regions to prepare their input to the 1999 UN General Assembly Special Session, which reviewed the 5-year review of the BPoA. Ms Khaka possess a BSc in Biology and Chemistry from the University of Zambia and an MSc in Public Health Engineering from Imperial College of Science and Technology, London

ELIAWONY J. KISANGA is a Deputy Director in the Economic Affairs Division of the Commonwealth Secretariat. He holds a PhD in Regional Economic Integration from the London School of Economics. He is the author of *Industrial and Trade Cooperation in Eastern and Southern Africa* and coeditor with David Peretz and Rumman Faruqi of *Small States in the Global Economy*, published by the Commonwealth Secretariat and the World Bank.

JAGDISH KOONJUL is Ambassador Extraordinary and Plenipotentiary and Permanent Representative of the Republic of Mauritius. He represented Mauritius in the Security Council and presided over the Council in January 2002. He is currently the Vice President of the Economic and Social Council and Chairman of the Alliance of Small Island States (AOSIS). Between 1980 and 1994, Mr Koonjul served with his country's embassies in Brussels, Paris and Washington DC. In October 1994, he was appointed Deputy High Commissioner of Mauritius in New Delhi, and in January 1997, Head of the Multilateral Political Directorate at the Ministry of Foreign Affairs and International Trade. He is a graduate of the University of Bombay. His publications include *Mauritius and the Lomé Convention* and *Ethnic Conflict in Sri Lanka*.

PETER LAROSE is General Manager of the Central Bank of Seychelles. He was previously an Advisor at the Ministry of Finance of Seychelles. He possess a PhD from the University of Birmingham (UK). His research topic was "Modelling of Corporate Credit Risk, Banks Stocks Returns, and the Effect of Risk-Based Capital Standards on the UK Commercial Banks". He also holds an MBA in International Banking and Finance. For a time he conducted lectures for MBA and MSc students on International Business Finance subjects at the University of Birmingham. In January 2003, he chaired the small states session at the 4th Annual Global Development Conference, which took place in Cairo, Egypt, with the theme "Globalisation and Equity". He is member or associate member of many international associations, including the Chartered Institute of Bankers, the British Institute of Management and of the Institute of Company Accountants.

HANNEKE VAN LAVIEREN has for the past three years acted as Programme Officer at the UNEP's Division of Environmental Conventions, Regional Seas Coordinating Office Nairobi, Kenya. She is responsible for the formulation and supervision of the implementation of projects and activities in the framework of the Regional Seas Conventions and Action Plans. She also assists in maintaining communication with relevant Convention Secretariats. Between 1999 and 2001 she was technical advisor/marine specialist in the coastal zone management component of the Northern Sierra Madre Natural Park Conservation Project working for the Netherlands Development Agency and PLAN International, Philippines. Earlier, she acted as fisheries biologist, with the Netherlands Institute for Fisheries Research. Ms van Lavieren possesses an MSc in Marine Biology and Ecology from the University of Groningen.

ABDULLAHI MAJEED is Deputy Minister of Environment and Construction of the Government of the Maldives. He has been serving as Deputy Minister with an environmental remit since 1996. Mr Majeed possesses an MSc in Meteorology form the University of Somerset (UK), and for a time was Executive Director of the Department of Meteorology, Maldives. He held various high ranking advisory roles within the World Meteorological Organisation (WMO). He represented his government in various meetings on the environment and sustainable development and on meteorological issues. He is national co-ordinator and co-scientist for Kaashidhoo Climate Observatory (KCO) and participates in other activities conducted under the Indian Ocean Experiment (INDOEX) by the Centre for Clouds, Chemistry and Climate at the University of California. He also acts as vice-chairman of the Working Group II, WMO/UNEP Intergovernmental Panel on Climate Change (IPCC).

MICHAEL MANNING is the Director of the Papua New Guinea Institute of National Affairs, a privately funded research institute based in Port Moresby. He is also chairman or a director of a number of Non-Government Organisations, including Transparency International. He has a Bachelor's degree in Economics from the Australian National University. He was a senior public servant in the PNG government, and has acted as director of a number of private and government boards in PNG. He has written extensively on the economy and development issues in PNG and organises studies and seminars on the subject. He recently co-authored the article "Papua New Guinea on the Brink" for the Centre for Independent Studies which caused a degree of controversy in both Australia and PNG. He has represented PNG at international conferences organised by the World Bank, the Asian Development Bank, the United Nations, the European Union, the Australian Government, the Australian National University and Transparency International.

PHILIP DUKU OSEI is a Fellow of the Sir Arthur Lewis Institute of Social and Economic Studies at the University of the West Indies, Mona Campus, Jamaica. He possess a PhD in Politics from the University of Strathclyde, Scotland, an MA from the University of Manchester and an Honours Degree in Political Science from the University of Ghana. His main research interests are public-private partnerships and public sector reform including administrative restructuring, local government reorganisation, policy reform and management, poverty policy, social protection and public debt. He has published many studies on these areas. He has taught both graduate and undergraduate students at the University of the West Indies, the University of Manchester and the University of Ghana. He has offered advisory services to the Government of Jamaica on poverty eradication and local government reform, the Government of St Lucia on social protection and the European Union on poverty reduction policy in Jamaica.

CLAUDIUS PREVILLE joined the Caribbean Regional Negotiating Machinery (RNM) on January 1, 2004, as Trade Policy Adviser to the Organisation of Eastern Caribbean States (OECS) and its member states. In this capacity, he is responsible for advising the OECS countries in developing their trade policy positions for the various negotiating theatres, and serves as the RNM's representative. Since commencing this assignment Dr Preville has worked extensively in the area of market access. After completing his PhD with a published thesis entitled *Trade Liberalization under Imperfect Competition* from the Institute of Social Studies, The Hague, in January 2003, Dr Preville worked as a consultant to the Commonwealth Secretariat (London), the Institute of Social Studies (The Hague) and the University of the West Indies (St Augustine). He has also taught and provided advice to students at masters and doctoral levels within the field of Economics, and serves as a referee and book reviewer for a peer-reviewed journal.

SIVARAMEN PALAYATHAN is Trade Adviser at the Permanent Mission of Mauritius in Geneva. He has served as Coordinator of the WTO African Group in 1999-2000 and 2003-2004, and as Coordinator of the African Group in UNCTAD in 2001. He held two consecutive mandates as Chairman of the WTO TRIMS Committee in 2003-2004 and 2004-2005. He has been defending the cause of the small economies and SIDS since 1997 within the WTO and other fora, and has provided expert assistance to the Group of Small Economies in Geneva for whom he has been acting as Coordinator since 1998. He has served on and chaired various working groups and committees on trade-related matters and has written several discussion papers and proposals for WTO negotiations. Prior to his posting in Geneva, he worked at very senior levels in industry, trade, finance and banking in Mauritius for Government and for the private sector.

GAVIN PEEBLES is a former Associate Professor in the Department of Economics at the National University of Singapore and, before that, Senior Research Fellow in the Institute of Advanced Studies at the Australian National University and a Lecturer at the University of Hong Kong and various British Universities. His interests are the history of economic thought, comparative economic studies, and the modern history of Singapore and Hong Kong. He is the author of many books, including *Hong Kong's Economy: An Introductory Macroeconomic Analysis* and, with Peter Wilson, *The Singapore Economy* and *Economic Growth and Development in Singapore: Past and Present.*

MAHENDRA REDDY is a Development Economist at the University of the South Pacific. He teaches in the postgraduate programme of Development Studies. He has taught courses in the area of "Trade and Development", "Development Economics", "Agricultural Economics", "Research Methodology", "Microeconomics", "Macroeconomics" and "Economic Statistics". He has researched on a wide range of topics including public finance, farm efficiency and productivity, energy economics, urban informal sector, financial sector governance and devaluation. He has a wide range of publications in local, regional and international journals in the area development mostly focused on the Pacific. He obtained his PhD from the University of Hawaii in 1998, majoring in Agricultural and Resource Economics. He is currently the Chair of the Oceania Development Network, an arm of World Bank's Global Development Network.

ESPEN RONNEBERG is currently Interregional Advisor for SIDS, within the SIDS Unit of the UN Department of Economic and Social Affairs. From 1992 to 1999 he worked for the Government of the Republic of the Marshall Islands, specialising in sustainable development negotiations. In 2003 and 2004 he assisted in the preparations and organisation of the Regional and Interregional Preparatory Meetings for the Review of the Barbados Programme of Action for the Sustainable Development of SIDS, and organised several meetings for AOSIS. He possesses a Masters degree in Political Science from the University of Rhode Island, USA. He published several works on small island states with a focus on climate change.

NADIA EL-HAGE SCIALABBA is a Senior Officer in Environment and Sustainable Development at the Food and Agriculture Organisation (FAO). Since 1991, she has been the FAO Focal Point for SIDS. She holds a Master Degree in Environmental Sciences. Her 20-year career in the FAO has evolved around developing integrated approaches to development, with a particular focus on environmental externalities of agriculture, forestry and fisheries. Ms Scialabba authored catalogues and field guides on the identification of marine species. She also published work on marine pollution and fisheries, integrated costal area management, sustainable agriculture and rural development, livestock waste and the environment, sustainability analysis in agricultural development, biodiversity and the ecosystem approach in agriculture, agroecology and organic agriculture, and agriculture and the environment in small island developing states.

CLETUS SPRINGER is a graduate of the University of the West Indies (Public Administration and Mass Communications respectively); Oxford Brooks University (Urban Planning Studies) and Aberdeen University's Centre for Environment and Planning (Environmental Impact Assessment). Mr Springer served as Permanent Secretary in the Ministry of Tourism (1992-94); Permanent Secretary in the Ministry of Planning, Development and Environment (1994-97) in the Government of St Lucia; and as Adviser in Policy and Strategy Development with the OECS Secretariat based in St Lucia (998-2001). He has represented St Lucia on several regional and international bodies, including the World Bank, the OAS, the CARICOM Task Forces on Environment and Development and Insurance and Reinsurance respectively. DIRK TROOST is Chief of UNESCO's Coastal Regions and Small Islands (CSI) Platform, set up in 1995 with a principal aim of catalysing joint action among the Organisation's five programme sectors in headquarters and field offices in the various regions of the world. His technical background is in coastal biology, with doctoral work on coastal marine productivity in the Caribbean. He joined UNESCO as marine sciences adviser in the regional office in Jakarta (Indonesia) and subsequently served as regional secretary of IOCARIBE in Port-of-Spain (Trinidad and Tobago), before being posted in 1980 to the Natural Sciences Sector at UNESCO Headquarters in Paris. His interests include ways and means of facilitating cross-sectoral interdisciplinary cooperation in addressing complementary facets of shared problems, recording and valorisation of local and indigenous knowledge, applying remote sensing to coastal area research and management, and the use of modern information and communications technologies for promoting dialogue and concerted action among different stakeholder groups.

JOHN M. UNDERWOOD, a US National, joined the World Bank in 1984, initially serving as Senior Economist, and later as Principal Economist, and Acting Lead Economist for the Debt and International Finance Division. In 1998, he became the Programme Manager for the Poverty Reduction and Economic Management Department of the Latin America and Caribbean Region. In May 2000 he became Director of the Operations Policy and Country Services of the World Bank. Prior to joining the World Bank, Mr Underwood was the Chief of the International Development Section, in the International Finance Division of the US Federal Reserve Board. Beckford; *Pathways to Progress*, with G. Beckford, N. Girvan, L.
