LINO BRIGUGLIO is Professor and Head of the Economics Department, Director of the Islands and Small States Institute and Director of the Gozo Centre, all at the University of Malta. He was awarded a PhD in Economics from the University of Exeter (UK) in 1982. Professor Briguglio has published a large number of papers on islands and small states, one of which is a seminal article on the economic vulnerabilities of small island states in *World Development* (September 1995). He has also edited a series of three books on vulnerability, resilience and competitiveness of Small States, published by the University of Malta in collaboration with the Commonwealth Secretariat. Professor Briguglio has acted as consultant to several international organisations on matters related to the economies of small states. He has represented the Maltese government in many international conferences dealing with islands and small states. He is a member of the Malta Fair Trading Commission (a judiciary tribunal) and the Malta Commission for Sustainable Development, and serves on a number of Government Committees and University of Malta Boards.

DAVID CARMENT is a full Professor of International Affairs at the Norman Paterson School of International Affairs, Carleton University and Fellow of the Canadian Defence and Foreign Affairs Institute (CDFAI). He is also a NATO Fellow and listed in Who's Who in International Affairs. In addition Professor Carment serves as the principal investigator for the Country Indicators for Foreign Policy project (CIFP). Professor Carment has served as Director of the Centre for Security and Defence Studies at Carleton University and is the recipient of a Carleton Graduate Student's teaching excellence award, SSHRC fellowships and research awards, Carleton University's research achievement award, and a Petro-Canada Young Innovator Award. Professor Carment has held fellowships at the Kennedy School, Harvard and the Hoover Institution, Stanford and currently heads a team of researchers that evaluates policy effectiveness in failed and fragile states. Recent publications on these topics appear in the *Harvard International Review* and the *Journal of Conflict Management and Peace Science*.

SATISH CHAND is an Associate Professor in the International and Development Economics Programme at the Australian National University (ANU). He is also the Director of the Pacific Policy Project, located within the Crawford School of Economics and Government that undertakes policy-relevant research on Papua New Guinea and the Pacific Islands. Professor Chand possesses a PhD in Economics from the ANU and has published work on international trade, economic growth, labour markets, and development. He has also worked as a consultant for the Asian Development Bank, the International Monetary Fund, The World Bank, and the Governments of Australia, Fiji, Papua New Guinea, the Republic of Marshall Islands, and Vanuatu.

JOHN CONNELL is Professor of Human Geography at the University of Sydney. He gained his two degrees at the University College London. His principal research interests centre on various facets of migration and small island states, but currently also include tourism (notably medical tourism) and festivals. His most recent publications are *The International Migration of Health Workers* (Routledge, New York, 2008) and *Tourism at the Grass Roots: Villagers and Visitors in the Asia-Pacific Region* (Routledge, London 2008).

GORDON CORDINA is a lecturer at the University of Malta. His main areas of research interest relate to sustainable growth and macroeconomic dynamics, on which he published several works. Dr Cordina's PhD thesis focused on the relationship between economic vulnerability and growth. Dr Cordina has served as Director General of the National Statistics Office of Malta, as Economic Advisor to the Malta Council for Economic and Social Development and as Head of the Research Department of the Central Bank of Malta. He has been involved in a number of research projects with institutions including the EU Commission, Government Ministries and private sector institutions.

JEAN PAUL FABRI is an economist specialising in Public Finance in the Economic Analysis Office at the Central Bank of Malta. He obtained his B.Com (first class Hons) in Economics from the University of Malta in 2005 and Masters in Economics from the same University in 2007. His main research interests are political economy, small island states and economic growth. The dissertation he submitted in completion of the B.Com (Hons) Economics degree examined the existence of a political business cycle in Malta on which he based the article entitled "The Electoral Business Cycle in Malta" published in *Bank of Valletta Autumn Review*, No. 32 (2005). His dissertation submitted for his Master of Arts in Economics degree assessed the link between governance and economic development with a particular focus on small island states.

NADIA FARRUGIA lectures Microeconomics at introductory, intermediate and advanced levels, at the University of Malta. Her main research areas are small states studies, in particular economic vulnerability and resilience, economic growth and competitiveness. She was previously employed as an Economics Officer at the Central Bank of Malta, within the Economic Analysis Office. She graduated B.Com (first class Honours) in Economics from the University of Malta in 2002 and obtained a Master of Arts in Economics (with Distinction) from the same University in 2004. She is currently a PhD candidate at the University of Malta and is researching the relationship between economic resilience and economic performance. Her most recent publications focus on composite index construction and on small states.

JEAN-FRANÇOIS GAGNÉ is a PhD candidate at the University of Montreal and a recipient of a doctoral scholarship by the Social Sciences and Humanities Research Council of Canada (SSHRC). His research interests are related to political transformation and hybrid political regimes.

Dr McGillivray's main research interests are the allocation and effectiveness of foreign aid, measuring achieved human well-being and international inequality in well-being.

STEPHANIE MEDINA CAS is a senior economist in the Africa Department at the International Monetary Fund (IMF). Her research interest in the area of macro economic policy in small states has been prompted by her responsibilities as economist for Lesotho, Papua New Guinea, and Seychelles.
